Naming of New Facilities

The Board shall be responsible for naming any building, site or other facility which is the property of the district.

In considering names for facilities, the board will use an equity framework and give preference ~~will be given~~ to names associated with the community. Names of historical persons, places and events may be considered. Names of living persons will not be considered.

Pursuant to OAR 581.021.0047, facilities will not use names associated with or significant to a Native American Tribe unless the school district enters into an approved written agreements with that federally recognized Native American Tribe in Oregon.

Recommendations from parent groups, students and residents of the district will be considered.

The superintendent will, upon request of the Board, prepare a list of possible names for new facilities.

The Board may establish a committee for screening, reviewing and suggesting names.

Memorials

The Board will use an equity framework when considering the acceptance of memorial scholarships in honor of persons who have special significance to the students, the district or the community. A room or item may be named for the person in whose honor the scholarship fund is created. A memorial plaque may be appropriately dedicated whenever a room or items is designated as a memorial in conjunction with a scholarship fund.

Offers of memorial scholarships will be submitted to the superintendent together with information concerning the purpose of the memorial and administration of the scholarship fund.

A principal may receive items for the his/her school as a memorial to a student or person having a special significance to the students of that school. Items received as memorials become property of the district. Principals must have the superintendent's approval to accept any item that may require additional maintenance cost to the district. The superintendent will establish guidelines for the acceptance of such memorials.

Flag Displays and Salutes

A United States flag, ~~and~~ an Oregon flag, a National League of Families' POW/MIA flag, a progressive pride flag, and a Black Lives Matter flag shall be displayed on or near each school building under the control of the Board or used by the district, during school hours, except in unsuitable weather and at other times the Board deems proper.

The district shall obtain and display a United States flag, an Oregon flag, a National League of Families' POW/MIA flag, a progressive pride flag, and a Black Lives Matter flag of an appropriate size for each classroom.

Students shall receive instruction in respect for the national flag, and be provided an opportunity to salute the United States flag at least once each week by reciting *The Pledge of Allegiance*. They will also receive instruction on native land acknowledgements and have the opportunity to recite it at least once each week. Students shall learn the United States national anthem and the Black national anthem *Lift Every Voice and Sing*.

A flag salute may be implemented at assemblies, before or after school, at lunch, special events, home room class, athletic contests or at other times deemed appropriate by the principal. Individual staff members and students who do not participate in the salute must maintain a respectful silence during the salute.
