During the interview, I discovered there is a documented inistory of violence between the victim and Colon Colon battered. In this incident, the victim alleged that Colon Colon battered are. As a result, officers determined probable cause was established to charge Colon Colon with battery. She informed me of other undocumented incidents of violence. The victim stated approximately two weeks prior to the attack in the garage, she discovered a tracking device on her vehicle. She explained she confronted Colon Colon about the device, and obtained a partial admission from him. She stated she originally suspected that he placed the device on her vehicle because of jealousy issues. The victim stated she did confront Colon Colon about this incident, but believes his denials. I collected the tracking device from the victim for forensic processing.											
After questioning the victim regarding the Toyota Prius, she indicated she remembers Colon Colon being associated at one point with a tow yard on Ferguson Drive. The victim was not specific about the vehicle and tow yard, but believed she observed a light colored Prius at this tow yard in the past. On 5/4/21, I traveled to 605 Ferguson Drive (TRL Towing). Upon my arrival, I observed a gold Toyota Prius with a Florida temporary tag (CXW3017) parked in the lot. I obtained pictures of the vehicle before it left the scene. I later obtained surveillance video from the tow yard showing the occupants as they entered and left the scene. The vehicle is identified as a gold 2011 Toyota Prius, registered to UP RENTAL CAR FORT LAUDERDALE LLC. A public records search from Sunbiz.org reveals the company owner is Witness 2 (NOI) with an address in Windermere, Florida.

I also observed a tow hitch on the rear the vehicle. In the surveillance video from the garage, I can clearly observe a logo or emblem in the same area. I can also observe the trailer hitch in the garage video and street camera from S Orange Blossom Trail and W Washington Street. Based upon this information, I had probable cause to believe this was the suspect vehicle. Street cameras from the area captured the vehicle on 4/27/21 at 1937 hours, in the area of Capri Place, Orlando, Florida. Detectives Maldanado (31299) and Hammond (19645) performed a traffic stop on the vehicle at 3575 Vineland Road. The driver and passenger were identified as Witness 1 and Witness 2, who were both fully identified. During a road side interview, I learned two vehicles were rented during the timeframe of the attempted murder. The vehicles were identified as a silver Jeep Cherokee-NOI and this Toyota Prius. Witness 2 stated that two subjects were present during the rent transaction, however the transaction was cash and there was no receipt. Witness 2 informed me that one of these subjects, identified as Witness 3 (who I have fully identified), was arrested. Witness 2 stated he was eating dinner with his wife-NOI, on 4/21/21, when he received a call from 407-413-0153. The caller informed him of the arrest of Witness 3 and the tow of the silver Jeep, and requested to return the Toyota Prius. Witness 2 stated that two men arrived and returned the vehicle to him. Witness 2 stated he recognized one of the men who returned the Toyota Prius, as being present with Witness 3 during the initial rent transaction, however did not recognize the other. Witness 2 stated he does not personally know this subject, but would be able to recognize him. He described this familiar subject as a Hispanic male with a beard.
