AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statements:
I have good reason to believe and do believe that ARMSTRONG, KAITLIN MARIE W/F DOB 11/21/1987 on or
about the 6th day of March, 2018 did commit the offense of:

THEFT OF SERVICE (CLASS B MISDEMEANOR)

My belief of the foregoing statements is based upon personal knowledge and information contained in Travis County
Sheriff's Office report #18-6647:

On 03/06/2018, Armstrong intentionally secured the performance of a Botox treatment valued at
\$653.00 at Aesthetica Med Spa at 500 N Capital of Texas Hwy, Westlake, Travis County, TX. As part
of the process to secure the service, Armstrong provided her personal information, such as her name and
date of birth, on a Patient Information Sheet provided by Aesthetica. The Patient Information Sheet,
which Armstrong signed, included the following statement: "I understand that I am financially
responsible for any balance incurred at the time of this service." As part of the administrative process
for the procedure, Aesthetica took four close-up photos of Armstrong's face, which clearly match
Armstrong's California Drivers License photo.

After the procedure was completed, Armstrong presented a Mastercard with her name on it at the point
of sale. Before the card could be run for payment, Armstrong stated she did not want to use the card, but
had another card in her vehicle she preferred to use. Armstrong left the card on the counter, walked out
of Aesthetica, and did not return to pay.

Thus, Armstrong intentionally secured the performance of a service by agreeing to provide
compensation and, after the service was rendered, failed to make payment after receiving notice
demanding payment.
