FELONY COMPLAINT

The undersigned is informed and believes that:

COUNT 1

On or about August 11, 2020, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by AKIRA KEYSHELL SMITH, who did unlawfully, and with malice aforethought murder ETERNITY S., a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

COUNT 2

On or about August 11, 2020, in the County of Los Angeles, the crime of ASSAULT ON A CHILD CAUSING DEATH, in violation of PENAL CODE SECTION 273ab(a), a Felony, was committed by AKIRA KEYSHELL SMITH, who did unlawfully, having care and custody of ETERNITY S., a child under the age of 8 years, assault that child by means of force that to a reasonable person would be likely to produce bodily injury, resulting in the child's death.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Sections 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 3

On or between August 10, 2020 and August 11, 2020, in the County of Los Angeles, the crime of TORTURE, in violation of PENAL CODE SECTION 206, a Felony, was committed by AKIRA KEYSHELL SMITH, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon ETERNITY S..

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

It is further alleged as to count(s) 1 and 3 that the above offense is a serious felony pursuant to Penal Code section 1192.7(c).

Pursuant to Penal Code section 1170(h), it is further alleged that an executed sentence as to count(s) 1, 2 and 3 shall be served in state prison pursuant to Penal Code section 1170(h)(3) in that the defendant(s), AKIRA KEYSHELL SMITH, has suffered the following prior conviction(s) of a serious felony described in Penal Code section 1192.7 or a violent felony described in Penal Code section 667.5(c) or is required to register as a sex offender pursuant to Chapter 5.5 (commencing with Penal Code section 290) of Title 9 of Part 1:
