**COUNT 1:** SECOND DEGREE MURDER, A  
CLASS 1 FELONY Dangerous, Domestic  
Violence (Christopher R Hoopes)

**COUNT 2:** UNLAWFUL DISCHARGE OF

The Grand Jurors of Maricopa County, Arizona, accuse CHRISTOPHER R HOOPES,  
on May 27, 2022, charging that in Maricopa County, Arizona

## **COUNT 1**

CHRISTOPHER R HOOPES, on or about May 20, 2022, without premeditation, intentionally did cause the death of Colleen Elizabeth Hoopes, and/or knowing that his conduct could cause death or serious physical injury, caused the death of Colleen Elizabeth Hoopes, and/or under circumstances manifesting extreme indifference to human life, recklessly engaged in conduct which created a grave risk of death and thereby caused the death of Colleen Elizabeth Hoopes, in violation of A R S §§ 13-1101, 13-1104, 13-710, 13-701, 13-702, 13-3601, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a firearm, a deadly weapon or dangerous instrument and/or the intentional or knowing infliction of serious physical injury upon Colleen Elizabeth Hoopes, in violation of A R S §§ 13-105 and 13-704

## **COUNT 2**


