

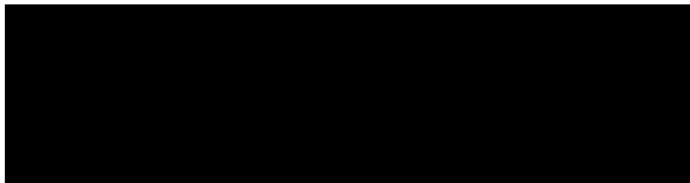

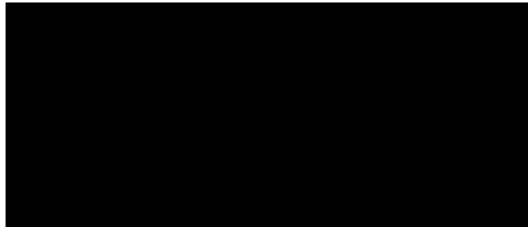

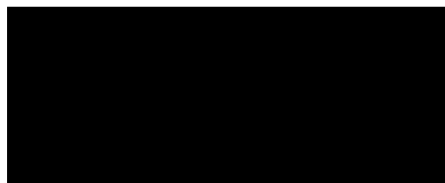

**RE: ANNA SOROKIN**

Dear Sirs/Madams:

I am writing with reference to your lengthy emails, telephone calls and recent Lozado notice that was sent to my office.

First and foremost, your demand that immediately turn over the files for Anna Sorokin will not be entertained as that is not how reality works.

Second, if you proceed with your baseless Lozado claim against me, I remind you that there is no attorney client privilege when an attorney is forced to defend themselves against allegations by their clients.

Third, Anna's claims that are outlined in the Lozado complaint are without merit and are a true testament to her habits.

Fourth, I am not going to sit by and let you disparage my name. I will respond in kind because I am not one who will ever be the bigger person.

Fifth, the proper procedure when trying to substitute an attorney is to show the same professional courtesies that you would want shown to you.

Sixth, you do not have the files on this matter and therefore, I suppose you are completely unaware that Anna Sorokin signed sworn affidavits that were notarized at the jail where she is housed and the claims she has raised in your baseless Lozado notice are in direct contrast to her sworn affidavit.

Seventh, I do not work the month of April for it is my birth month and therefore, I am out of the country until April 30, 2022. Anna is fully aware of this.

Eight, I strongly advise you to reconsider attacking me. Anna did the same thing to Todd Spodek when she fired him and hired me. I was respectful and kind and courteous and when I needed him, I was able to return to him and he helped fill in many of my blanks because as the trial attorney, his input was valuable and insurmountable.

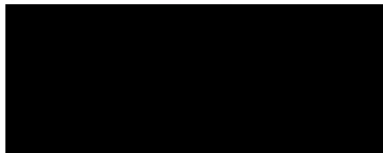

Dear Anna:

Enclosed please find a money order for \$200.

Pursuant to your request, we have debited your IOLA funds \$400. This represents, \$150 payable to Kai by Cashapp and \$200 money order for you and overnight and money order purchase, and travel fees.

The funds were wired to Javien Forres via Zelle. Javien cashapped the \$150 to Kai and then sent you a money order via overnight mail.

As discussed, I went to do the interview with ABC 20/20 yesterday. I was seriously ill and thus had to cancel the last appearance. But they were very accommodating.

They are asking to re-interview you upon your release.

Lastly, I am enclosing copies of the documents you requested for your review and acceptance. Those documents are:

1. The Record and Briefing Schedule from the BIA
2. DHS Brief in Opposition to Respondent's Appeal
3. The denial notice from the ESTA application

We will perfect the brief and serve you with the same accordingly.

I pray you are managing to maintain your strength and positive attitude.

I am also asking that you refrain from bad mouthing me and from encouraging your friends to send me ridiculous messages that will justify my decision to drop you as a client.

I have 175 open files. If I was required to speak to every client on a daily basis I would go mad and I would never get any work done.

You literally call me everyday to ask me the same questions. I understand that you are in jail and that you do not have anyone in this country really. But you have a lot of friends.

Please stop dumping all of the unnecessary emotional stress you are under on me. You will break me and render me ineffective. I told you I do not do well with emotions. I remind you that when my then 17 year old son was shot in the back of his head at point blank range, I chose to go to court and continue my trial for I could not cope with the emotional crisis of being at the hospital and dealing with my relatives' angst.

I am a great attorney because I am detached from emotions and I use logic and reason to solve the heinous and outrageous issues other people would fall apart if faced with.

You are someone I care deeply about because I believe your intentions are honorable. However, I am warning you that if anyone connected to you, Rachel, Kai, Doug or anyone else ever contacts me again in aggression, I will dump your files and leave you to figure your plight out without me.

Anna I am as resolved to help you as I am resolved to avoid having you pull me into a storm of emotions that will compromise my ability to serve you zealously and effectively. If it comes down to choosing between serving your interest and maintaining my peace of mind, you will come in second and I will take the first place prize to losing you and that unnecessary stress.

I am sorry you have had so much disappointment. But I remind you that disappointment is not hurt. You must distinguish between being disappointment by not speaking to me and being hurt by not speaking to me.

Kai is a good friend but she is an idiot for thinking it wise to send me paragraphs of disrespect on your behalf.

We are a team so do not come at me (team scrambled).

I continue to serve at your pleasure and I am committed to being she who stands confidently between you and your would be oppressors.

Lastly, the balance in your escrow account is now \$3,483.96.
