In the Common Pleas Court of Summit County, Ohio, of the term of JUNE in the year of our Lord, Two Thousand Twenty Two.

The Jurors of the Grand Jury of the State of Ohio, within and for the body of the County aforesaid, being duly impaneled and sworn and charged to inquire of and present all offenses whatever committed within the limits of said County, on their oaths, IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OHIO,

COUNT ONE

DO FIND AND PRESENT, that A) **DESHAWN ANTIONE STAFFORD** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **INVOLUNTARY MANSLAUGHTER** in that he did cause the death of [REDACTED] and such death was the proximate result of Deshawn Antione Stafford committing or attempting to commit the felony offense of Aggravated Assault, R.C. 2903.12(A)(1), a felony of the fourth degree, in violation of Section 2903.04(A), 2903.04(C) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT TWO

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **A) DESHAWN ANTIONE STAFFORD** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **AGGRAVATED ASSAULT** in that he while under the influence of sudden passion or in a sudden fit of rage, either of which is brought on by serious provocation occasioned by [REDACTED] that is reasonably sufficient to incite the person into using deadly force did knowingly cause serious physical harm to [REDACTED] in violation of Section 2903.12(A)(1), 2903.12(B) of the Ohio Revised Code, a **FELONY OF THE FOURTH DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT THREE

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **A) DESHAWN ANTIONE STAFFORD AND B) TYLER CHARLES ANTIWANE STAFFORD** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **INVOLUNTARY MANSLAUGHTER** in that they did cause the death of [REDACTED] and such death was the proximate result of Deshawn Antione Stafford and Tyler Charles Antiwane Stafford committing or attempting to commit the misdemeanor and/or regulatory offense and/or minor misdemeanor of Assault, 2903.13(A), a misdemeanor of the first degree, in violation of Section 2903.04(B), 2903.04(C) of the Ohio Revised Code, a **FELONY OF THE THIRD DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT FOUR

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **A) DESHAWN ANTIONE STAFFORD AND B) TYLER CHARLES ANTIWANE STAFFORD** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **ASSAULT** in that they did knowingly cause or attempt to cause physical harm to [REDACTED] in violation of Section 2903.13(A), 2903.13(C) of the Ohio Revised Code, a **MISDEMEANOR OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT FIVE

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **C) DONOVON ANDRE JIMMY JONES** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **ASSAULT** in that he did knowingly cause or attempt to cause physical harm to [REDACTED] in violation of Section 2903.13 (A), 2903.13(C) of the Ohio Revised Code, a **MISDEMEANOR OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT SIX

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **C) DONOVON ANDRE JIMMY JONES** on or about the 2nd day of June, 2022, in the County of Summit and State of Ohio aforesaid, did commit the crime of **ASSAULT** in that he did knowingly cause or attempt to cause physical harm to [REDACTED] in violation of Section 2903.13 (A), 2903.13(C) of the Ohio Revised Code, a **MISDEMEANOR OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.
