Sgt. E. Freeman #1890 makes oath that on or about the 07<sup>th</sup> day of, September 2022, in said County, and within the jurisdiction of the Criminal Court of Shelby County, Tennessee, one Ezekiel Kelly age 24, sex Male, whose last known address is 4026 Hitchcock. (last known), did unlawfully commit the offense (s) 1<sup>st</sup> Degree Murder T.C.A. 39-13-202 and the essential facts constituting said offense (s) and the source of the affiant's information are as follows:

On Wednesday September 07, 2022. Officers arrived on the scene of a Shooting Call at 3176 Lyndale Ave where victim Dewayne Tunstall was suffering from a gunshot wound. MFD Engine #23 made the scene to administer aid. The Victim, Dewayne Tunstall was pronounced deceased at 01:04pm by Paramedic. The death was determined to be a homicide from the result of a gunshot wound.

Dewayne Tunstall was visiting Marcus Cash at the at 3176 Lyndale with four friends when Ezekiel Kelly pulled Tunstall to the side. During the conversation Kelly drew his black handgun and discharge several shots in the direction of Dewayne Tunstall and Kelly shot Tunstall in the head with a black colored handgun. Three of the witnesses on the scene at the time Kelly shot Tunstall positively identified Kelly from a six-person photographic lineup as the person who fired the fatal shots at the victim. The witnesses are friends of both Kelly and Tunstall. Witnesses true identity is being withheld due to safety reason and is available to magistrate upon request.
