On 9/10/22 around 6:08 PM, I was dispatched to [REDACTED] n reference to a missing person.

Upon arrival, I spoke with the caller, Steven Collier. He informed that he had last seen his wife, Deborrah Collier, the night before just before going to bed around 9pm. He stated when he left for work this morning, the vehicle Deborrah drives was still in the driveway, so she should have been home. He clarified that he and Deborrah sleep in separate bedrooms due to his snoring.

I also spoke with Deborrah's daughter, Amanda Bearden, who was also on scene. She informed that around 3:17 PM, Deborrah sent her \$2,385 through Venmo. There was a message on Venmo with the money sent that said "they are not going to let me go love you there is a key to the house in the blue flower pot by the door." Amanda said the message scared her and got her worried for her mom, so she tried calling her but she did not pick up. Amanda also informed that her mother did not take anything with her but her drivers license and debit card. She also informed that her mother left in a black Chrysler Pacifica that she had rented due to her vehicle being in a wreck. They informed that they did not no the year nor the tag number for the vehicle which is rented through enterprise.

Both Amanda and Steven stated this is unusual for Deborrah to do this. She has not done anything like this before. The family informed Deborrah doesn't have any family in the area besides them.

Dispatch, myself, and Deborah's family attempted calling her several times but it would go straight to voicemail.

Deborrah will be listed on GCIC as missing.

The family was informed to call 911 if Deborrah returns or calls them back.
