NARRATIVE

On 09/4/2021 I responded to a domestic disturbance at [REDACTED]. The caller Amanda Bearden told dispatch that Andrew Giegerich had come to her residence and trying to kick the front door down and trying to get in the residence through the back window. Officers arrived on scene and contacted Mr. Giegerich in the front yard. Mr. Giegerich said he was there to get things and that Miss. Bearden had stolen money from him in the past.

I went inside and talked to Miss. Bearden and she told me that he had been beating on the door and yelling. She also said her bedroom window was broken but that incident happened months ago. She told me there may have been a protective order against Mr. Giegerich. Dispatch informed me there was a protective order stating that Mr. Giegerich could not come to [REDACTED] unless for a one time pick up of items with police present. Mr. Giegerich violated multiple parts of the protective order by being on the property and having harassing communications with Miss. Bearden. Mr. Giegerich was arrested for violating warrant MC-01CR-CR-20 issued from the magistrate court. Mr. Giegerich was transported to the county jail and was disorderly.
