- 13) Plaintiff, please verify the constitutional violations committed by the alleged defendant.

- 15) Plaintiff, the plaintiff's attorney has filed and submitted to this Court negotiable instruments on record, please provide the 1099OID so that the taxes can be assessed otherwise a fraud upon the alleged defendant has occurred or in the alternative, close this account.
- 16) Plaintiff, please verify that the plaintiff STATE OF WISCONSIN will be able to testify at trial and if the STATE OF WISCONSIN will be available at trial for cross examination pursuant to the fact that the alleged defendant asserted his right to face his accuser.




