On 08/28/2021 at approximately 0234 hours, I was dispatched to a suspicious circumstances located near [REDACTED]. Call notes indicated that there was a female on the line saying "please help me" and disconnecting. The address was retrieved as an approximate location of the cell phone ping. At approximately 0237 hours, the female was back on the line whispering very faintly.

I arrived in the area at approximately 0239 hours and heard a female scream in front of [REDACTED]. The female was identified as Young An. I watched Young scream and run away from the house down the sidewalk. I identified myself as a Police Officer and asked Young to stop and talk with me. Young was extremely hysterical and crying and said that her husband hit her and that he hid her cellphone. I tried to get more initial information from Young but she was distraught and wasn't communicating effectively. Young complained of pain to her left bicep and right lower leg. Lacey Fire Department evaluated Young and gave her an ice pack. I did not observe any redness, scratches, or marks on Young.

Young confirmed that she lived at [REDACTED] with her husband, Chae, and two children. I knocked on the front door of the residence and Chae answered. I asked Chae to step out of the residence and speak with me. Chae complied and was calm and cooperative. I asked Chae to sit on the front steps and I detained him in handcuffs without incident. I read Chae the Miranda warning directly from my department issued card. Chae stated that he understood and agreed to speak with me.

Chae informed me that he had learned that his wife cheated on him with a younger man. Chae stated he learned this information over a month ago. Chae stated that he continued to attempt to salvage their relationship as Young had apologized for her actions. Chae stated he had given her \$550 dollars for golf lessons and found out that she had gone on a nice date with another man. Chae confronted her again and continued to try to keep their marriage, asking her to write a letter of apology, which she did. Chae stated that some time last week Young had stolen the letter back from him. Chae stated that Young has also taken debit cards and hidden the keys to the car.

Chae reported that Young returned home well after midnight tonight. Chae and Young often sleep in different rooms upstairs. Young sleeps in the Master bedroom and Chae sleeps in the smaller bedroom. Chae stated that he had not been asleep at any point tonight. Chae stated that he went into the Master bedroom where Young was in bed and confronted her about taking the letter back from him. Chae stated that it is not hers to take. Chae stated that Young's phone was on the small table next to the bed and he grabbed it. Chae stated that he took her phone and said he would give it back to her when he gets the letter back. Chae took Young's phone to the smaller bedroom and hid it in the trash can. Chae stated that Young came in his room, screaming and yelling at him about her phone. Chae stated that Young said she was going to call the police and he stated "go ahead". Chae stated he believes Young used their daughter's cellphone to locate hers. Chae stated that Young grabbed the trash can to retrieve her phone. Chae stated that he grabbed the trash can with the cellphone in it to keep it from her. Chae stated that Young fell to the ground on her own and started pulling trash out of the trash can. Chae stated that she got her phone and left the room. Chae stated that he did not touch her at all.

I spoke with their 18 year old daughter, [REDACTED]. [REDACTED] stated that she was asleep and heard loud arguing between her mother and father in the small bedroom. [REDACTED] stated that her mother came in her room and asked her to borrow her cell phone. [REDACTED] stated that she did not know why her mother wanted her cell phone. [REDACTED] did not see anything and could not say if anyone was in distress.

I recontacted Young after she had been seen by the medics. Young admitted that she had cheated on Chae. Young stated that she was in her bedroom when Chae came in asking about his documents. Young stated that she did not know what documents he was talking about. Young stated that Chae grabbed her cellphone and took it to his bedroom. Young stated that she told Chae she was going to call the police if he didn't give her phone back. Young

stated that Chae said "if you call the police, its over". Young stated that she found the cellphone by using her apple watch to ping the phone. Young stated that when she went to get her cellphone out of the trashcan, Chae grabbed her by the arm and threw her to the ground. Young stated that she was clutching her cell phone and laying on the ground. Young stated that Chae was standing over her and grabbed her by the right ankle and pulled her back into the room. Young stated that she ran outside and called 911.

Young was provided with a DV victim pamphlet and filled out a supplemental report.

I arrested Chae for LMC Simple Assault DV and Interfering with Reporting of DV for trying to keep her phone from her.

I transported Chae to Nisqually Jail for booking.

Recently, my husband wants to divorce me and he has been hiding my military ID card, credit cards and changed the access to our joint bank account. So I changed my personally bank account access.

And I told him to change back my bank account access how it was so he can have an access to my bank account. even I told him I would do as he said, he cannot calm down and keep yelling at me.

He took my phone and went to the garage. he grabbed an ax and tried to destroy my phone but I opened my garage door. I told him give my phone back but he refused to return it to me.
