Narrative:

Kaylee Goncalves called to report she believed she saw a an older female who had been reported as missing out of Coeur d' Alene in the Walmart in Moscow. Kaylee told me the females name is possibly Sharon Archer (62). Kaylee told me the female was starring at her and her boyfriend when they were in the store and as they checked out. Kaylee told me she didn't see the missing person flyer until several hours later.

Kaylee forwarded me the flyer and I have electronically attached it to this report. Ofc's responded to Walmart to see if we could find the Toyota Highlander Archer was reported to be in. We did not find the vehicle. I had my officers check all of the hotels in town to see if if she was staying at one of them. We did not find anything.

I went to contact one of the managers for Walmart. I asked the manager if I could review the video surveillance camera to see if the person Kaylee reported was in fact Archer. The manager told me there was currently no one in the store who had access to the video surveillance camera's.

I was given and email to send a request to someone who could access it on 10-06-21. I will review the video if and when we are able to get it.
