Before Me, the undersigned authority personally appeared K.KERN who being duly sworn, alleges, on information and belief, that on the 14 day of JAN, 2023, in Marion County, Florida, the defendant did:

Did knowingly and unlawfully commit the offense of sexual battery to wit:

On 1/15/2023, the Ocala Police Department was notified of a sexual battery that occurred at Hollywood 16 movie theatre located at 2801 SW 27th Avenue. informed Officers that her daughter was sexually battered after a movie on 1/14/2023 by an armed security officer working at the movie theatre.

Contact was made with who stated she went to the movies with her friends. The movie that and her friends watched was shown in theatre #11. stated after the movie her friend's grandfather came to the theatre to pick up her friends however refused to take home. attempted to make phone contact with her mother several times which was met with negative results. The secuirty officer, later identified as Augusta Williams, informed the grandfather that he would watch over until she was able to stated Williams, who was described as having long dreads and gold teeth, told her to go to theatre # 12 where get a ride home. the movie "Whale" was playing which was an empty movie theatre. stated this incident occurred at approximately 22:00. continued to make contact with her mother which was still met with negative results. followed Williams to the front of the movie theatre near the movie screen, behind the curtains, because she thought there was a backdoor exit. assumed that Williams would drive her home but instead they stayed behind the curtain. While behind the curtain, Williams asked to "give him head" which she denied doing. Williams then turned around, bent her over, pulled down her pants and had vaginal sex with her. she did not want to have sex with Williams however she was fearful that she would hurt him due to him being an armed security officer. told Williams to stop and put her hand behind her back to push him at which time Williams grabbed her hand and continued to have sex with her.

stated Williams eventually stopped but told her not to tell anyone of this because he needed his job. Williams told her that if she said anything her would punch her in the face and tapped on his gun as he told her again not to say anything, asking if she understood. stated she understood, clothed herself and went to the lobby with Williams. was ultimately picked up by her mother who was then told of this incident on 1/15/2023. Contact was made with Hollywood 16 management who had video surveillance footage of and Williams walking together through the movie theatre hallways. The two are observed on video surveillance walking towards theater # 12 at 22:07 and come out of the theater area at 22:26. This was believed to be the time frame of the described and reported by Evidence Officer Patterson responded to the movie theatre and utilized UV lighting behind the curtain described by Evidence Officer Patterson located 2 areas which exhibited a glow indicated a possible positive response.

I responded to Hollywood 16 and made contact with who participated in a Kimberlys interview and SANE examination. During her interview at Kimberly's described Williams as a "police officer" and stated that he wore a tactical vest and was armed with a firearm. stated while she was walking with Williams, she was looking at her phone but was following him into the movie theatre. relayed the same information that was reported to Officer Rossi during their initial contact with one another. Phone contact was made with the Chief of Knights Armed Security, Antwuan Hamm, who stated Knights subcontracts to Hollywood 16. Hamm was made aware of this incident and stated that Williams would be writing a statement regarding this incident which was sent to me.

In the report written by Williams he stated that he assisted in looking for her lost cell phone in theatre # 12. After not locating the
phone, Williams escorted to the front lobby of the movie theatre where he disconnected contact with her. On 1/17/2023, I made
phone contact with Williams who agreed to come to the Ocala Police Department for interview purposes. Williams was read his
Miranda Rights and agreed to speak with me. Williams stated he helped look for her lost cell phone in theatre #11 for 12-13
minutes, and after not locating the phone he escorted to the front lobby of the movie theatre where he disconnected contact with
her. Williams stated used his cell phone to call family members for a ride which was corroborated by during her
interviews. Williams confirmed he wrote the written statement that was forwarded to me by Chief Hamm. I confronted Williams and
asked him why he was in theatre #12 when the movie saw was in theatre #11. Williams stated told him she was in
theatre #12. I also confronted Williams about the possible positive responses located with UV lighting by Evidence Officer Patterson.
After confronting Williams with this information, he stated he "did not have sex" with

When I inquired as to what exactly happened, Williams continued saying he "fucked up" and that he did not want to go to jail. Williams eventually stated that asked him to go behind the curtain which he did but did not expand further about what happened behind the curtain. Based on the account given by the evidence located by Officer Rossi and Evidence Officer Patterson, Williams written statement which contradicts what stated and the evidence collected, I believe there is probable cause for his arrest.

Williams was ultimately placed under arrest and transported to the Marion County Jail without incident.
