COMPLAINT

17 I, the undersigned, say, on information and belief, that in the County of SAN JOAQUIN, State  
18 of California:

19 **COUNT 1: Code Section PC 187(A) WILLFUL, DELIBERATE, PREMEDITATED**  
20 **MURDER**

21 On or about May 8, 2023 in the County of San Joaquin, California, SATNAM SUMAL did  
22 commit the crime of WILLFUL, DELIBERATE, PREMEDITATED MURDER, in violation of  
23 Section 187(a) of the Penal Code, a FELONY, who at the time and place last aforesaid did  
24 willfully, unlawfully, and with malice aforethought murder SATBINDAR KUAR SINGH a  
25 human being. It is further alleged that the aforesaid murder was committed willfully,  
26 deliberately and with premeditation within the meaning of Penal Code Section 189 and is a  
27 serious felony pursuant to Penal Code Section 1192.7(c).

**INTENTIONAL DISCHARGE OF A FIREARM GBI/DEATH PC12022.53(D)**

It is further alleged that SATNAM SUMAL personally and intentionally discharged a firearm, to-wit: .40 CALIBER HANDGUN which proximately caused great bodily injury and death to SATBINDAR KUAR SINGH within the meaning of Penal Code Section 12022.53(D).

**SPECIAL CIRCUMSTANCE: CONVICTED OF MULTIPLE MURDERS  
PC.190.2(A)(3)**

It is further alleged that defendant, SATNAM SUMAL, in this proceeding, has been convicted of more than one offense of murder in the first or second degree.

For a further and separate cause of complaint, being a different offense from but connected in its commission with the charge(s) above, complainant further complains and says:

**COUNT 2: Code Section PC 187(A) WILLFUL, DELIBERATE, PREMEDITATED  
MURDER**

On or about May 8, 2023 in the County of San Joaquin, California, SATNAM SUMAL did commit the crime of WILLFUL, DELIBERATE, PREMEDITATED MURDER, in violation of Section 187(a) of the Penal Code, a FELONY, who at the time and place last aforesaid did willfully, unlawfully, and with malice aforethought murder NADJIBA BELAIDI a human being. It is further alleged that the aforesaid murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code Section 189 and is a serious felony pursuant to Penal Code Section 1192.7(c).

**INTENTIONAL DISCHARGE OF A FIREARM GBI/DEATH PC12022.53(D)**

1 It is further alleged that SATNAM SUMAL personally and intentionally discharged a firearm,  
2 to-wit: .40 CALIBER HANDGUN which proximately caused great bodily injury and death to

5 **SPECIAL CIRCUMSTANCE: CONVICTED OF MULTIPLE MURDERS**

6 **PC.190.2(A)(3)**

7 It is further alleged that defendant, SATNAM SUMAL, in this proceeding, has been convicted  
8 of more than one offense of murder in the first or second degree.

9  
10 If the above-named defendant(s) is/are presently on probation in San Joaquin County, any  
11 evidence presented at a preliminary hearing in the instant case will be used not only as a basis  
12 for a holding order in this case but also as evidence of a violation of probation and, at any  
13 formal hearing on that violation of probation, the People will move the transcript of the  
14 preliminary hearing into evidence as a basis for the violation.

15  
16 Pursuant to Penal Code Section 1054.5(b), the People hereby informally request that the  
17 defendant and their attorney disclose to the People all information and materials described in  
18 Penal Code Section 1054.3.

19  
20 I declare under penalty of perjury that the foregoing is true and correct except for those things  
21 stated on information and belief and those I believe to be true.
