

that on 04/07/2023, her daughter, [REDACTED], was on speakerphone with Gared Canales, [REDACTED] father, in her bedroom. [REDACTED] advised that she was told Gared was insulting her over the phone. [REDACTED] advised [REDACTED] told her that Gared said over the speakerphone, "You kill yourself, just don't say." [REDACTED] was further informed that Gared told [REDACTED] she was pregnant and worthless. [REDACTED] stated that [REDACTED] is constantly verbally abused by her father. [REDACTED] stated on Sunday, while cleaning after Easter fun, [REDACTED] grabbed her brother's baseball bat and broke a portrait of her and Gared. [REDACTED] advised that [REDACTED] has text messages on her personal phone with her grandmother (Gared's mother) talking about her father. [REDACTED] advised that in those text messages, [REDACTED] stated she was going to cut herself and go deeper to get her father's attention. [REDACTED] advised that [REDACTED] also has text messages with Gared expressing her feelings.

I made contact with [REDACTED], and she advised that on 04/07/2023, she contacted Gared at approximately 3:00 pm. [REDACTED] advised that her friends [REDACTED] and [REDACTED] were in the room at the time. [REDACTED] advised [REDACTED] walked in halfway through the conversation. [REDACTED] advised that Gared insulted her, saying, "Bitch, slut, whore, go fuck yourself." [REDACTED] advised she was telling him how she felt about him, and Gared said, "You're not worth it. I choose my girlfriend over you anyway, and go kill yourself." [REDACTED] advised on 04/08/2023, at night time, she gave herself a minor cut on the wrist upward with a knife causing minor bleeding. [REDACTED] advised that on 04/09/2023, at nighttime, she gave herself a minor cut in the same spot upward with a piece of glass, causing minor bleeding. [REDACTED] advised that on 04/10/2023, at approximately 9:00 am, in the kitchen, she took 7 pills of Benadryl. [REDACTED] stated she took another 7 pills of Benadryl in the vehicle with [REDACTED] in route to pick up her stepdad at work. [REDACTED] advised that she informed [REDACTED] of her taking the Benadryl pills. [REDACTED] advised that [REDACTED] turned the vehicle around and went straight to Halifax Hospital in Daytona Beach. [REDACTED] stated that she attempted suicide due to her father stating to go kill herself.

I made contact with [REDACTED], who was in the residence at the time. [REDACTED] advised that she heard Gared on the speaker from the other room on 04/07/2023. [REDACTED] said that Gared insulted [REDACTED] over the speakerphone, saying, "pregnant and worthless." In addition, [REDACTED] advised that she heard Gared yell, "You kill yourself, just don't say it," and was insulting her. [REDACTED] advised that Gared is verbally abusive.

Due to [REDACTED] being a juvenile, [REDACTED] completed all appropriate victim forms on [REDACTED] behalf. [REDACTED] was provided with a Victims Rights Brochure and a Domestic Violence pamphlet. [REDACTED] completed a Willingness to Prosecute form stating she did wish to prosecute. Additionally, [REDACTED] completed a


