The undersigned makes the following declarations subject to the penalty of perjury and says: That I am a peace officer with the Las Vegas Metropolitan Police Department, Clark County, Nevada, being so employed for a period of approximately 6 year(s).

That I learned the following facts and circumstances which lead me to believe that the above named subject committed or was committing the offenses above at the location of 3555 LAS VEGAS BLVD S LAS VEGAS NEVADA 89109 and that the offense(s) occurred at approximately 23:22 hours on the 9th day of July, 2023.

Details for Probable Cause:

On July 9th, 2023 at approximately 2322 hours I, Officer A. Montalbano P# 16301, and Officer T. Foth P# 19017 operated as a marked patrol unit 7M80B in the area of Cromwell, 3495 S Las Vegas Blvd. We were alerted of a fight occurring at the Flamingo next door near the Bird Bar. Upon arrival the fight had subsided and only one party remained. Individual witnesses stood by and described the male present (Citizen A) was attacked by another male, later identified as Brian Danilczyk (DOB: [REDACTED] PII 1988) via NY DL (OLN [REDACTED] PII). Citizens furth displayed a brief video to me showing other citizens, who were no longer present, attempting to remove Danilczyk from on top of Citizen A whom had one leg. Danilczyk was placed into a head lock and pulled away from Citizen A. Danilczyk is a white male wearing grey pants (similar to Slacks), no shirt, brown hear and a beard in the video. Danilczyk then ran off northbound to the Linq. Citizen A stated he did not want to press charges. While speaking to Citizen A on BWC, he stated the Danilczyk was not known to him and the encounter was unprovoked. Citizen A was seated on the curb as Danilczyk demanded Citizen A to stand up. Danilczyk then attempted to force Citizen A up and the encounter caused other citizens to assist Citizen A. Due to the numerous citizens involved and the breach in peace the incident causing persons to notify police it was believed Danilczyk committed the crime Disorderly Conduct.

While investigating this Danilczyk was believed to be involved under LLV230700040970 and security was attempting to locate him and the adverse party. Danilczyk was later detained at the Harrahs 3475 S Las Vegas Blvd forcefully by security. Due to the disorderly conduct we went to Harrahs to verify Danilczyk was the same subject due to security reporting Danilczyk was completely in the nude. Upon arrival Danilczyk was in the holding room with only a blanket and clothing on the desk. Danilczyk was identified by myself as the male in the video. Harrahs Security Officer Andrew Hicks informed us the additional offenses leading up to the detention security affected. We were told Danilczyk was seen by Security and CCTV footage removing his clothing at the Linq. Danilczyk ran completely naked through the Linq to Harrahs. Danilczyk had climbed atop a poker table game and flaunted his genitals to all who past exposing his penis and testicles while "gyrating." Danilczyk transitioned to a position where he exposed his anus to all who passed on the main floor. Danilczyk stood back up and removed a poker card distributor scattering cards about and displaced chips on the

inactive table. Security then took action and Danilczyk jumped from the table encircling his arm around Security Officer Hicks' neck without choking him. Danilczyk wrestled with security until they placed him into custody and escorted Danilczyk to the holding area. Security Officer Hicks was assisted by the following security officers who witnessed Danilczyk's indecent exposure to the public and all patrons of the Casino: Juan Flores and Alexis Berrios.

All security Officers provided voluntary statements, CCTV footage was present but not recovered at this time, images of the footage was captured. Security informed footage at the Flamingo showed Danilczyk was in fact the same male from the initial incident with him being placed in a headlock by a citizen in front of the Bird bar.

Linq Security Officers Jesus Esparza-Vega and Jeremy Bozant located at 3535 S Las Vegas Blvd next door had initial contact with Danilczyk. The two witnessed Danilczyk remove his clothing and alerted their dispatch. Security at Linq attempted to detain Danilczyk as he ran away through the casino floor yelling fully unclothed. Danilczyk exited to the north to Harrahs.

Voluntary statements were acquired by these Security Officers as well. Speaking to Danilczyk he appeared to be in an altered mental state but was cooperative. The longer the investigation proceeded Danilczyk still did not recall the encounter but was more lucid. Danilczyk was seen by medical where his vitals were stable.

Based on the facts and circumstances above with 5 corroborating witnesses/ victims, Danilczyk was arrested and charges for indecent exposure per NRS 201.220 for willfully and unlawfully making himself any open and indecent or obscene exposure of his or her person, being his genitals (penis and testicles) and anus, for an extended period of time within multiple casinos where the public was present.

Danilczyk was transported to CCDC where he was booked accordingly for the two charges and Hicks requested Danilczyk be charged for the battery when taken into custody. Danilczyk was charged with a citizens arrest as well.
