On June 17, 2023 at approximately 2200 hours, I was dispatched to 820 South Federal Highway, apartment #2, located in the City of Lake Worth Beach, Palm Beach County, Florida in reference to an armed domestic dispute where one party got hit with a bat.

Upon arrival, I observed the living room of the apartment with covered in blood, with streaks leading into the bedroom located at the north part of the apartment. In the bedroom, I observed a white male, later identified via his Arizona Driver's License as [REDACTED] laying on his back holding a towel on the top of his head, which was bleeding heavily. Photographs were taken of the scene and of [REDACTED] and were uploaded to Evidence.com via the Axon Capture application. Palm Beach County Fire Rescue arrived and began treating [REDACTED], who was transported to St. Mary's Hospital as a Trauma Alert. Due to the nature of [REDACTED] injuries, a crime scene was set up at the front door of the apartment.

I spoke with the complainant, who was identified via her Florida Driver's License as Christie Barbato, who advised she witnessed the incident. Barbato was placed under oath, at which time she advised that she had been laying down in bed in the bedroom of the apartment with her coworker, whom she had known since January of 2023 and identified as [REDACTED], at approximately 2200 hours. Barbato stated that she heard the front door open, at which time she observed her husband, whom she identified as John Dimmig, enter the front door of the apartment with an aluminum bat. Barbato stated that upon entering the apartment, Dimmig started swinging the bat at [REDACTED] whom she saw fall to the floor with blood coming from his head. Barbato stated that Dimmig did not say anything to either party before swinging the bat, but that afterwards he said something to the effect of "Don't come near my fucking wife again!" before leaving the apartment through the front door. Barbato was again placed under oath and attested that the above information was true and accurate.

I relocated to St. Mary's Hospital, at which time I was advised [REDACTED] was having a CT Scan done in order to assess his injuries. Once the CT Scan was completed, I made contact with [REDACTED] in Trauma Room #2.



_____ was placed under oath, at which time he stated that he was in town from Arizona working as a travel CT Technician. _____ advised that he had gone out for drinks with a coworker, whom he identified as Christie Barbato. _____ stated that afterwards, he and Barbato went back to his Air BnB rental located at 820 South Federal Highway #2 in Lake Worth Beach. _____ stated that while he was in the bed with Barbato, he heard the front door of the residence open. _____ stated that he then got up to see who it was. _____ stated that when he got to the living room, he saw a male running at him with a bat. _____ further advised that the male charged at him and pinned him to the ground and hit him three times with an aluminum bat. _____ stated that that time, Barbato pulled the male off of him. _____ stated that once Barbato pulled the male off of him, the male told him something to the effect of "Don't ever go near my wife again!" before leaving the apartment out the front door.


I asked _____ what he thought would have happened if Barbato had not intervened and pulled the male off of him, at which time he stated that he thought the male would have beaten him to death, stating "I felt like he was out to kill me." _____ was again sworn to his statement.

I then relocated to Barbato and Dimmig's residence located at 423 Park Avenue, located in the Town of Lake Park, Palm Beach County, Florida, after being advised that Dimmig had been located there and taken into custody after loading the trunk of his Hyundai Accent with two garbage bags full of clothes. I was further advised that Barbato was at the residence with deputies and was willing to consent to a search of the vehicle and home for the clothes and bat used by Dimmig during this incident. Upon arrival at the residence, I was advised by Deputy Hyde that video of the incident had been recovered from the property owner of the Air BNB.

I reviewed the video, which showed a male walk into the residence while holding a bat at 2157 hours as timestamped on the video before closing the door behind him. Moments later, screaming could be heard coming from inside the residence, with a female voice screaming "John! Stop! He's bleeding!" In a separate video timestamped 2158, the male can be heard screaming "Piece of shit! Fuck you!" seen leaving the residence and walking towards the road. I was further advised by Deputy Hyde that he had shown the video from the Air BNB to Barbato, who positively identified the male pictured as Dimmig.

Art. 1 § 16(b)</p> <p>While I was at 423 Park Avenue, Barbato signed a Consent to Search Form, for the black Hyundai Accent bearing Florida tag AR97KL, which is registered to both Barbato and Dimmig. A search of the vehicle was conducted for the bat used and the clothing worn by Dimmig, which I was advised was a black, ripped t-shirt, and a white tanktop undershirt, however the items sought were not in the vehicle.</p> <p>Barbato also signed a Consent to Search Form for the residence, which both she and Dimmig resided in as a family. A black "Rawlings" aluminum bat was found in the outside laundry room by the carport, and a black ripped t-shirt and a white tanktop undershirt which appeared to have blood on it, were found in a garbage bin at the rear of the residence. I observed the bat, and found that there were small hairs embedded in the larger portion of the bat, which is usually used to hit with.</p> <p>I relocated to District 14, where Dimmig had been transported to. After reading Dimmig his Miranda Warnings, I asked him about the incident. Dimmig stated that he was home all day, other than briefly going to the Publix located at the intersection of Northlake Boulevard and U.S. Highway 1, located in the Town of Lake Park. Dimmig stated that he knew that Barbato was at a beach party in the City of Lake Worth Beach, but stated that he never left the Town of Lake Park and was never in the City of Lake Worth Beach. When asked about the bat, Dimmig stated that he had a bat, which he kept in his closet for self-defense or hitting baseballs and soccer balls, but that he had never struck anyone with the bat and that there would be no reason for there to be hair on the larger portion of the bat. Dimmig was also provided the opportunity to consent to a search of his phone records and his location history from his phone carrier, which he refused.</p> <p>Using investigative means, it was found that a dark colored sedan with a yellow emblem to the left of the license plate and a blue/white emblem to right of the license plate, was found on camera at the intersection of 8th Avenue South and South Federal Highway at 21:59:21 hours. It should be noted that Dimmigs vehicle has a yellow placard reading "DRIVER" to the left of the license plate and a blue and white colored Keiser University parking pass to the right of the license plate.</p> <p>Based on my investigation, I find probable cause to charge John Dimmig with Attempted Murder in violation of Florida Statute 782.051(1), Burglary with Battery in violation of Florida Statute 810.02(2)(a), and Aggravated Battery with a Deadly Weapon in violation of Florida Statute 784.05(1)(a)(2).</p>



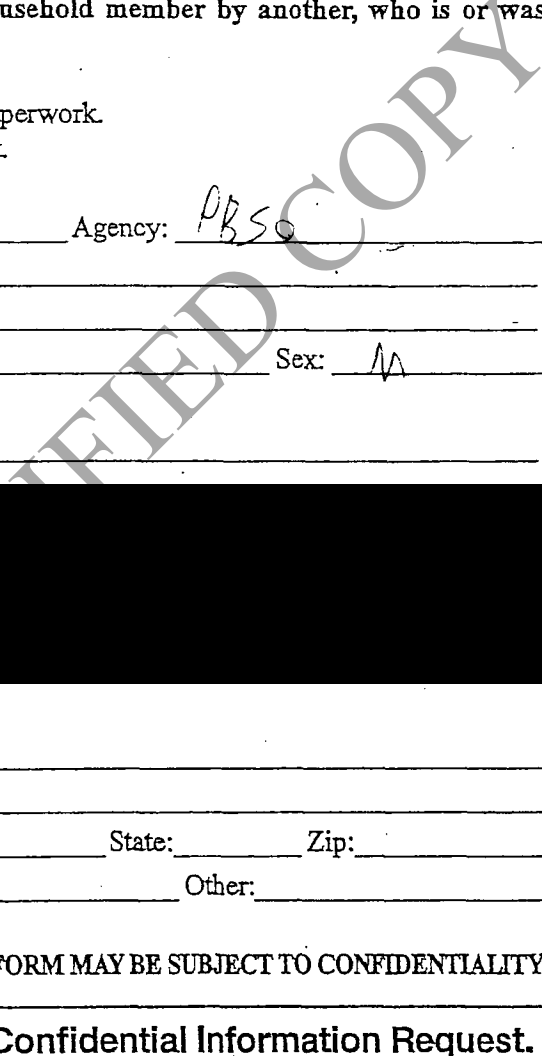
