Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
 Defendant called 911 on 8/12/2023 at approximately 1701hrs stating that his wife Judith Manis was deceased and that she was possibly beaten. Defendant also stated that there may have been a robbery at the residence. Defendant voluntarily provided a post-Miranda statement to law enforcement where he subsequently admitted to using a pillow to suffocate his wife Judith Manis. Thereafter she became limp and unresponsive. Following the incident the defendant plotted several scenarios in an attempt to cover up the crime, ultimately deciding to stage a home invasion during which he ransacked the room, including hiding the victim's jewelry in the basement ceiling. Defendant also removed items from the home belonging to the victim and discarded them in a dumpster at a nearby apartment complex located in Wood-Ridge NJ.
