NARRATIVE FOR SERGEANT KALEB M HAWKINS

On August 7, 2023, at approximately 0054 hours, officers were dispatched to 8000 Riverpointe Dr. #3A11 for reports of an altercation. While enroute, dispatch advised they were unsure if the altercation was physical or not. Ofc. Roussie, Lt. Garber, Ofc. Oliver, and I all arrived on scene. Ofc. Roussie and Lt. Garber made contact at the front door with Omar Pena-Romero and had him step outside while Ofc. Oliver and I made contact with the victim, inside the apartment. very emotional and was crying on the couch when we entered. She was also not wearing any clothing and was covering herself with her pants.

She advised Ofc. Oliver and myself that an argument had started again about her calling the police a few hours earlier concerning some suicidal ideations he was having (see 23-1348-OF). She stated during the argument he made a comment stating he needed to do one thing before he left, and stated Omar just raped her. At that time, I advised Ofc. Roussie to detain Omar in handcuffs. Lt. Garber stepped inside and I advised him what told me. They detained Omar before Lt. Garber stepped back inside to interview stated Omar began to take her clothes off and she stated she tried to get away but he picked her up and threw her on the couch. stated when he got all her clothes off, Omar forced her into performing and then began penetrating her. He then forced her to go the bathroom in the hall to grab lubricant and continued to penetrate her in the bathroom. They returned to the living room where he pushed her against the pillar next to the kitchen half-wall and penetrated her again before returning to the couch. According to , a few minutes later is when Ofc. Roussie knocked on the door and he finally stopped penetrating her.

Ofc. Roussie transported Omar to MPD for further investigation and on-call CID Det. Jackson was notified. Det. Jackson arrived on scene and interviewed (see supplement). After the interview, Det. Jackson advised to formally charge Omar with Rape, Aggravated assault on a Family/Household Member, and Interference with Emergency Communication. Omar was processed and transported to PCRJ with no bond to be held until court on August 8, 2023, at 1300 hours. He was also issued a No Contact Order.

On 08/07/2023 I met Nurse Ashely at Baptist Hospital Emergency Room at approximately 1000 hours to retrieve the forensic rape kit and two vials of drawn blood. I retrieved these items and they were labeled and placed into evidence to be sent to the Arkansas State Crime Lab.

I then went to residence to give her a copy of the property receipt for evidence that was taken from the home as well as a copy of the No Contact Order. I informed that if she needed any assistance or had any questions to call us. ZS1467

On 08/07/23, I responded to 8000 Riverpoint Dr Apt 3A11 in reference to a disturbance. I read Omar his Miranda Warning after he was detained and he verbally stated he understood his rights. I made contact with Lt. Det. Jackson who responded to the scene. Capt. Ivey was also notified and made aware of the incident. I made phone contact with the always acknowledges and/or responds to text messages from complainant, Alan . Alan advised him. Alan advised after approximately 1 hour of not responding to him he advised "I knew something was wrong". I was present for a portion of Lt. Det. Jackson's interview with and she stated that Omar choked her for a short amount of time and it made it difficult for her to breathe. After the interview Lt. Det. Jackson advised me Omar would be charged with rape, aggravated assault, and interfering with a communication device. After confirming with Lt. Det. Jackson that he did not need anything further from me I left the scene. I made contact with City Attorney Thornton and advised him of the incident and confirmed Omar would be transported to PCRJ and held without bond until court on 08/08/23. I made contact with Omar again and informed him he was no longer detained and he was under arrest and I advised him of his charges. Omar was advised Lt. Det. On 8/7/2023 at approximately 0100 hours, I received a call from Lt. Garber of the Maumelle Police Department regarding a suspected rape at 8000 River Point Drive, apartment #3A11. Lt. Garber informed me that he had already arrived at the scene and requested my assistance. Upon my arrival, Lt. Garber handed over the investigation to me.

I immediately interviewed the victim, , who confirmed that she had been raped by her husband, Omar Peña-Romero. She provided a detailed account of the events leading up to the assault.

stated that on 08/06/2023 at around 1200 hours, Omar came home from the hospital after being committed for a week and began expressing thoughts of suicide due to their relationship issues. admitted to having an affair with a co-worker, who she identified as Alan Yeargan. The conversation continued until approximately 1500 hours, when Omar took a shower with a sex toy known as a Fleshlight. The shower ended at approximately 1530 hours.

Later, at approximately 1855 hours, Omar initiated a discussion about mending their relationship, expressing that he did not wish to live if they couldn't be together. At approximately 2100 hours, he once again brought up the topic of ending his life and discussed various methods to do so. mentioned that she contemplated calling for help at approximately 2110 hours but decided against it, fearing that Omar, who is an EMT with MEMS, would know how to manipulate the situation.

Omar then left the apartment complex at 2130 hours to go for a walk and later returned at 2145 hours, expressing suicidal thoughts once again and displaying possessiveness towards . At 2315 hours, Omar attempted to take phone but failed, leading her to call the police at approximately 2328 hours. MEMS, Maumelle Police, and Maumelle Fire Department responded, but Omar was not transported by MEMS as he was deemed to be in his right state of mind after given a mental evaluation.

mentioned that Omar became enraged after the first responders left, realizing that his colleagues and supervisor now knew about the incidents since she made the 911 call. He accused her of ruining everything in his life including his career at MEMS.

At midnight, Omar forcefully took phone while she was standing near the balcony door. He then became physically abusive, grabbing her left arm and undressing her against her will. He coerced her into performing oral sex and proceeded to pin her down on the living room couch, forcibly penetrating her against her repeated protests of "no."

During the sexual intercourse, recalled Omar stating that he needed to do one more thing before leaving for good. He forced her into the bathroom, where he retrieved personal lubricant and continued engaging in sexual acts against her will. He then compelled her to return to the living area, where he once again forced her to perform oral sex and engaged in further intercourse.

Omar then moved to the dining area, where he pinned her against the wall and began choking her, depriving her of breath. Despite her objections, he insisted on continuing sexual activity. At this point, the police arrived, interrupting the assault as Omar attempted to initiate anal sex with

Based on account and the evidence at the scene, it is clear that a violent and non-consensual sexual

assault occurred.

I proceeded to process the apartment and took photographs of the relevant areas. The areas include the living room area, dining area, and the bathroom.

I advised that I needed to collect the physical evidence, I instructed to go to Baptist Hospital immediately for the collection of a rape kit. She agreed with my recommendation, understanding the significance of this procedure for the investigation.

I called and followed-up with and she informed that she had arrived at the hospital and was awaiting a nurse for the completion of the rape kit.

At approximately 0345 hours, I conducted an interview with Omar Peña-Romero at the Maumelle Police Department. Prior to the interview, I read Omar his Miranda rights, and he waived his right to an attorney, agreeing to speak with me.

During the interview, Omar revealed that his wife, had been communicating with a co-worker named Alen. He expressed concern that Alen was negatively impacting their marriage and believed that Alen was responsible for the deteriorating the state of their relationship. Omar disclosed that he had been struggling with depression due to connection with Alen.

Additionally, Omar admitted that he had lied to medical staff about his suicidal thoughts in hopes of being released from the hospital. He acknowledged having sexual intercourse with earlier in the day. While acknowledging that had said "stop" at one point during the encounter, Omar downplayed it, stating that rough sex was common between them.

Furthermore, Omar admitted to placing his hands around neck during the sexual encounter but claimed that he never intended to harm her, it was how they have sex. Despite his admission, he expressed remorse for his actions, stating that hurting was never his intention. He Stated that he asked her for sex and she agreed by nodding her head.

This new information provided further insight into the dynamics of their relationship and Omar's mental state leading up to the incident. It corroborated some aspects of account while also highlighting potential contributing factors to the assault.

After concluding the interview, I document the statements made by Omar, cross-reference them with the statements made by
in which their statements are similar, except Omar stated he never took
phone and he didn't prevent her from calling the police.

Based on the investigation and the information obtained from both and Omar during the interview, the following charges would be applicable:

1. Rape: Omar's admission to engaging in sexual intercourse with against her will, despite her saying "no" multiple times, establishes the basis for the charge of rape.

2. Aggravated Assault: Omar's admission to physically assaulting her neck, indicates the commission of an aggravated assault.

3. Interfering with an Emergency Communications Device: reported that Omar attempted to take her phone when she called 911, preventing her from seeking immediate help. This behavior constitutes interference with an emergency communication, which is a criminal offense.

Therefore, Omar Peña-Romero would be charged with rape, aggravated assault, and interfering with an emergency communications device based on the information gathered during the investigation, the victim's statement, and Omar's own admission to certain actions.

Case Notes:

- Regarding the rape investigation involving
 an important detail has been revealed upon interviewing both parties involved.
 stated that Omar did not ejaculate during the sexual assault, and Omar confirmed this in his own statement, aligning with account.
- clothing has been collected as evidence and stored at the Maumelle Police Department as evidence. Once the rap kit is received it will be sent to the Arkansas State Crime Lab as evidence.
- Photos of the scene has been uploaded to this report.
- I spoke with Detective Sanders about collecting the rape kit, due to receiving a call from Baptist Hospital stating the kit is ready. Detective Sanders agreed to follow up with Nurse Ashley from Baptist Health Little Rock to arrange for the pickup of the kit. Once the rape kit is collected it will be forwarded to the Aransas State Crime Lab for testing.

The following items have been listed as evidence:

- E1 Astroglide gel: This item is significant as it indicates the use of lubrication during the sexual intercourse, supporting the victim's account of the events.
- E2 Couch cushion cover: This item potentially contains forensic evidence such as DNA or bodily fluids that can link it to the sexual assault.
- E7 Black shirt: The black shirt found on the couch, where the sexual act took place, may have evidentiary value, potentially containing DNA or other trace evidence.
- E6 Blue shirt: The blue shirt found on the floor, where the sexual act occurred, may also have evidentiary value, and its location adds context to the sequence of events.
- E13 Socks: The victim's socks could potentially contain trace evidence or DNA that may corroborate her

E11 - Pink bra: The pink bra worn by the victim at the time of the assault is an important item for potential DNA analysis or other forensic examination.

- E12 Blue strip panties: The blue strip panties worn by the victim hold evidentiary value and might contain relevant forensic evidence.
- E9 Black shirt: The black shirt worn by the victim during the assault could potentially hold trace evidence.
- E10 Pajama pants: The victim's pajama pants could potentially yield important evidence such as fibers or DNA.

On 8-7-23 0054hrs. officers were dispatched to 8000 River Pointe Drive apt. 3A11 concerning an altercation.

Upon arrival I made contact with Omar Pena-Romero and asked him to step outside of the apartment. He explained that he and his wife have been having marital problems. Then after the incident earlier in the evening when he was threatening suicide he explained that they made up and had make-up sex. While speaking with him and asking him to take his hands out of his pockets I noticed that he was erect. He continued to explain what had happened after which Lt. Garber exited the apt. and asked Mr. Romero to place his hands behind his back. It was at this point that he was placed in handcuffs by this officer and was verbally informed of his Miranda Rights by Lt. Garber and stated that he understood. He was informed that he was being detained at this point. He was then transported to the PD while the investigation was underway. At the PD he was placed in an interview room.
