I responded in normal mode to 417 W 3rd Ave (Phoebe Main Hospital) in reference to an escaped prisoner. Upon arrival, I began searching the area for black male Carlton Bradford Gills, who escaped the custody of a Dougherty County Sheriff's Office detention officer. The information provided by Phoebe Security was that Gills was last seen jumping the fence by the construction site. While searching the area, I made contact with a black male standing in a yard in the 200-Blk of 6th Ave. The black male asked me if we were looking for somebody, and I said yes. The black male then advised a black male subject jumped in the rear of a green in color vehicle, and they went north on N. Jackson St. I drove north on Jackson St, then west on 7th Ave. As I traveled north on N. Jefferson St, I observed a green in color, Pontiac GATag#SDA6736, traveling north and turning right onto the Liberty Expressway onramp. I got behind the vehicle and noticed the driver alternated his right and left turn signals. As we merged onto Liberty Expressway, the driver drove slowly and alternated the turn signals again. The driver then started to pull off to the road's right shoulder. I then gave dispatch my location, vehicle description, and GATag#SDA6736. I activated my blue lights and siren, and the driver stopped the vehicle. I made contact at the driver's side door with a black male who was later identified as Randy Williams. I asked Williams if he was okay and looked in the vehicle's rear seat. Williams advised he was okay, and I asked Williams who was the male in the rear seat. Williams advised his stepson, Brad Gillis. I then told Williams to unlock the rear door, and when I looked inside, I noticed the black male matched the picture of the escapee, Carlton Gillis. I gave Gillis verbal commands to give me his hands, and he refused. Gillis then moved from the rear of the vehicle to the front, putting his left foot on the gas pedal and putting the vehicle's gear in drive. I gave Williams verbal commands to turn the vehicle off, and he attempted, but Gillis moved his hand and turned the vehicle on. Gillis forcefully took over the vehicle from Williams using his hands, legs, and body. Gillis continued to disregard commands and pulled off with Williams still in the driver's seat. The vehicle stopped again, and Williams was able to get out, and Gillis drove off east on Liberty Expressway.

A vehicle pursuit was initiated on Liberty Expressway going eastbound. Cpl. D. Bonner and Cpl. M. Hunt pursued the vehicle on Liberty Expressway and got off on exit 4 (Blaylock St) with the vehicle. Gillis traveled south on Blaylock St driving into oncoming traffic on the opposite side of the road at speeds up to 80mph. When the vehicle chase crossed over Clark Ave I called for it to be terminated. Cpl. Bonner terminated the pursue at N Central St/Mulberry Ave due to Gillis's recklessness and because his mother, who was later identified as Trudy Sellars, was inside the vehicle. The vehicle was later located at Nona Dr/E Campbell St with Sellars still inside.

Sellars advised Gillis took flight on foot eastbound through the woods. Sellars stated she tried to get out, but Gillis drove with her inside. Sellars advised she told Gillis to stop, but he would not. Sellars stated she told Gillis she was going to jump out while he was driving, and he stopped at Nona Dr/Campbell St. Sellars stated Gillis drove off with her inside the vehicle against her will. Sellars advised the reason they picked Gillis up was that he called them and stated he had been released from the hospital. Sellars stated she had no clue Gillis had escaped from custody.

I made contact with Randy Williams in the rear of a patrol car. I read Williams his Miranda Warning, and he agreed to speak with me. Williams advised he and his wife Sellars got a phone call from Gillis asking for a ride. Williams advised they had not seen Williams in about six months. Williams stated when Gillis got inside the vehicle, he laid down in the back seat. Williams advised he did not know Gillis had escaped from custody. Williams stated he was alternating the turn signals because he did not know what I wanted. Williams stated when he was trying to turn the vehicle off, Gillis would not let him. Williams advised Gillis was holding him, preventing him from doing so.

After speaking with Williams and Sellars warrants for Kidnapping, Robbery by Force, Fleeing and attempting to elude, and Reckless Driving were taken for Gillis.
