Additional Information

On 10/07/2023, at 0024hrs, I was dispatched to 1201 Riverplace Blvd. (Double Tree) in reference to a battery with injuries.

Upon arrival, I made contact with [REDACTED] JFRD arrived on scene to assess the victim's injuries. While talking to the victim, Corey Johnson (witness) advised us that Kyle Rogemoser (suspect/boyfriend) was walking in the lobby of the hotel. I made contact with the suspect, I observed blood spot on his neck. I detained the suspect and placed him in the back seat of my patrol car. I read the suspect his Miranda Rights via card. The suspect stated that he did not understand his rights. I attempted multiple times to ask the suspect which part of the Miranda Rights did he not understand with negative results. It should be noted that the suspect was extremely intoxicated.

Ofc. M. Cardwell #73735 provided the following statement when she spoke with the victim and witness.

" The victim stated they arrived at the hotel around 1700 hours and shared an alcoholic beverage. There was a celebratory dinner at the hotel for the suspect's promotion to Chief in the Navy and staying the evening. They got into a verbal argument and the victim stated the suspect punched her in the mouth three times. She started to call for help and she heard a knock on the hotel door, and she opened. The witness came in, picked her up and took her downstairs to management until police were called.



She completed all necessary paperwork including a threat assessment, a signature form and was given a case card. She also stated she wanted to have her injuries photographed. I observed red marks on her chin and on her neck as well as what appeared to be fresh blood on her bottom lip.

The witness stated that he was walking down the hall when he heard someone screaming for help. He knocked on the door and the victim answered. He observed her on the floor crying with red marks on her face. He picked her up and brought her down to management. "

Ofc. Cardwell completed all necessary paper work with the victim. A Crime Scene Detective was notified to photograph the victim's injuries. The victim was notified of a "safe place".

The suspect was transported to the PTFD without incident.

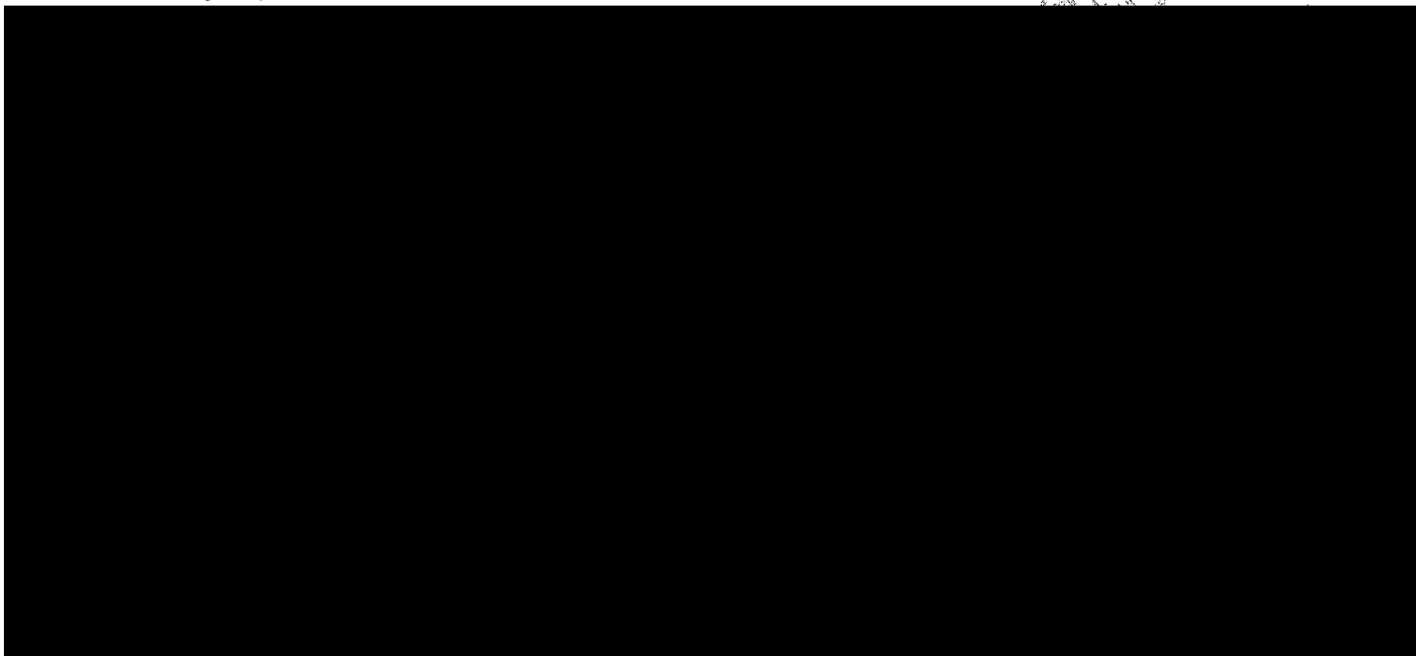

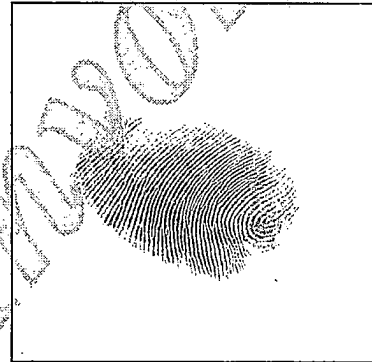
