Probable Cause

Before Me, the undersigned authority personally appeared DEPUTY N. HIMMEL #6793 who being duly sworn, alleges, on information and belief, that on the 5TH day of NOVEMBER 2023 in Marion County, Florida the defendant did:

Commit the offense of MAKE WRITTEN ELECTRONIC THREAT TO COMMIT MASS SHOOTING to wit:

ON 11-5-2023, I WAS DISPATCHED TO A CALL FOR SERVICE IN REFERENCE TO AN ASSISTANCE CALL FOR SERVICE FROM LAKE COUNTY SHERIFF'S OFFICE UNDER THEIR CASE NUMBER "230133184".

IN SPEAKING WITH DEPUTY COLEMAN OF LAKE COUNTY BY TELEPHONE, HE INFORMED ME THAT HE HAD RECEIVED A CALL FOR SERVICE IN WHICH THE REPORTEE, [REDACTED], ADVISED OF CONCERNING SNAPCHAT TEXT MESSAGES THAT WERE BEING SENT TO HIS DAUGHTER, [REDACTED], FROM THE DEFENDANT, MATTHEW WISE.

FURTHER INVESTIGATION REVEALED THAT THE DEFENDANT LIVES AT 6 SPRING LOOP CIRCLE, LOCATED IN MARION COUNTY, AND WAS SENDING THESE MESSAGES FROM MARION COUNTY. DEPUTY COLEMAN ADVISED THAT THESE TEXT MESSAGES CONTAINED THREATS TO COMMIT DRIVE BY SHOOTINGS, COMMIT A MASS SHOOTING IN LAKE COUNTY AND SUICIDE THREATS BY THE DEFENDANT.

IN SPEAKING WITH [REDACTED] BY TELEPHONE, SHE ADVISED THAT THE DEFENDANT HAS BEEN SENDING MESSAGES OF THIS NATURE FOR AS SHE DESCRIBED "SOME TIME" IN WHICH THE DEFENDANT THREATENS TO SHOOT HER FAMILY AND KILL HIMSELF. WHEN I ASKED HER TO SEND ME SCREEN SHOTS OF THESE MESSAGES FROM TODAY, SHE WAS ABLE TO SEND ME SEVERAL SCREEN SHOTS OF A SNAPCHAT MESSENGER CONVERSATION BETWEEN HER AND THE DEFENDANT.

IN VIEWING THESE MESSAGES, I OBSERVED ONE SUCH MESSAGE FROM THE DEFENDANT THAT ADVISED "I'LL START MASS MURDERING PEOPLE UNTIL I FIND AND START IN LAKE COUNTY". ANOTHER MESSAGE STATES "YOU'LL SEE ME ON FACEBOOK LIVE" AFTER THREATS ARE MADE BY THE DEFENDANT TO "BLOW HIS BRAINS OUT ON THE FLOOR".

RESPONDING TO THE ADDRESS OF 6 SPRING LOOP CIRCLE, I MADE CONTACT WITH THE DEFENDANT. IN A POST MIRANDA INTERVIEW, HE INFORMED ME THAT THE SNAPCHAT ACCOUNT IN QUESTION DID BELONG TO HIM. HE FURTHER ADMITTED TO SENDING SNAPCHATS EARLIER IN THE DAY TO [REDACTED] BUT ADVISED HE WAS NOT SERIOUS IN HIS THREATS TO KILL HIMSELF. WHEN I INQUIRED ABOUT THE THREATS TO COMMIT MASS SHOOTING MADE ON THE APP, HE WAS NOT ABLE TO PROVIDE A DEFINITIVE ANSWER TO WHETHER OR NOT HE SENT THIS MESSAGE.

DUE TO THE WRITTEN ELECTRONIC THREATS MADE BY THE DEFENDANT TOWARDS STOOTTS TO COMMIT MASS SHOOTING OR AN ACT OF TERRORISM, HE WAS PLACED UNDER ARREST AND TRANSPORTED TO THE MARION COUNTY JAIL WITHOUT FURTHER INCIDENT.
