IN VIEWING THESE MESSAGES, I OBSERVED ONE SUCH MESSAGE FROM THE DEFENDANT THAT ADVISED "I'LL START MASS MURDERING PEOPLE UNTIL I FIND AND START IN LAKE COUNTY". ANOTHER MESSAGE STATES "YOU'LL SEE ME ON FACEBOOK LIVE" AFTER THREATS ARE MADE BY THE DEFENDANT TO "BLOW HIS BRAINS OUT ON THE FLOOR".

RESPONDING TO THE ADDRESS OF 6 SPRING LOOP CIRCLE, I MADE CONTACT WITH THE DEFENDANT. IN A POST MIRANDA INTERVIEW, HE INFORMED ME THAT THE SNAPCHAT ACCOUNT IN QUESTION DID BELONG TO HIM. HE FURTHER ADMITTED TO SENDING SNAPCHATS EARLIER IN THE DAY TO BUT ADVISED HE WAS NOT SERIOUS IN HIS THREATS TO KILL HIMSELF. WHEN I INQUIRED ABOUT THE THREATS TO COMMIT MASS SHOOTING MADE ON THE APP, HE WAS NOT ABLE TO PROVIDE A DEFINITIVE ANSWER TO WHETHER OR NOT HE SENT THIS MESSAGE.

DUE TO THE WRITTEN ELECTRONIC THREATS MADE BY THE DEFENDANT TOWARDS STOOTS TO COMMIT MASS SHOOTING OR AN ACT OF TERRORISM, HE WAS PLACED UNDER ARREST AND TRANSPORTED TO THE MARION COUNTY JAIL WITHOUT FURTHER INCIDENT.
