
Before me, the undersigned Assistant District Attorney of Harris County, Texas this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **KEYANNA CHERRELL GARDINER**, hereafter styled the Defendant, heretofore on or about **AUGUST 28, 2014**, did then and there unlawfully and with notice that entry was forbidden, intentionally and knowingly enter and remain ON THE PROPERTY of another, namely, **ALLEN EDWARDS, JR.** without the effective consent of **ALLEN EDWARDS, JR.**


PROBABLE CAUSE:

AFFIANT J. CERVANTES IS EMPLOYED BY THE BAYTOWN POLICE DEPARTMENT AS A PEACE OFFICER AND IS CURRENTLY ASSIGNED TO THE CRIMINAL INVESTIGATION DIVISION. AFFIANT BELIEVES AND HAS REASON TO BELIEVE THAT KEYANNA GARDINER, HEREINAFTER STYLED THE DEFENDANT, COMMITTED THE OFFENSE OF CRIMINAL TRESPASS AT 1501 SOUTHWOOD DRIVE, BAYTOWN, HARRIS COUNTY, TEXAS ON OR ABOUT AUGUST 28, 2014. AFFIANT BASES HER BELIEFS ON THE FOLLOWING INFORMATION:
AFFIANT SPOKE WITH OFFICER M. SHAFER, WHO IS ALSO EMPLOYED BY THE BAYTOWN POLICE DEPARTMENT AS A PEACE OFFICER, WHO STATED THAT ON AUGUST 28, 2014, HE WAS DISPATCHED TO 1501 SOUTHWOOD DRIVE, BAYTOWN, HARRIS COUNTY, TEXAS IN REFERENCE TO THREATS; THAT UPON ARRIVAL HE MADE CONTACT WITH ALLEN EDWARDS JR, HEREINAFTER STYLED THE COMPLAINANT; THAT COMPLAINANT ADVISED OFFICER M SHAFER OF THE PROBLEMS HE HAS BEEN HAVING WITH THE DEFENDANT WHO HE KNOWS BY NAME AND SIGHT AS HIS EX-WIFE, WHICH INCLUDED HARASSMENT, DISTURBANCES AND CRIMINAL MISCHIEFS; THAT THE DEFENDANT HAS BEEN GIVEN CRIMINAL TRESPASS WARNINGS FOR HIS RESIDENCE ON TWO OCCASIONS; AND THAT ON THURSDAY AUGUST 28, 2014 AT APPROXIMATELY 11:40 A.M. THE DEFENDANT CAME TO HIS RESIDENCE LOCATED AT 1501 SOUTHWOOD DRIVE, BAYTOWN, HARRIS COUNTY, TEXAS. SHAFER ALSO TOLD AFFIANT THAT THE COMPLAINANT STATED THAT HE HAS SURVEILLANCE CAMERAS ON HIS PROPERTY AS A RESULT OF THE PREVIOUS PROBLEMS WITH THE DEFENDANT AND THE DEFENDANT WAS RECORDED ON THIS SYSTEM BEING AT THE RESIDENCE WHICH VIOLATES THE CRIMINAL TRESPASS WARNING; THAT THE COMPLAINANT PROVIDED SHAFER A COPY OF THE SURVEILLANCE VIDEO FROM AUGUST 28, 2014; THAT SHAFER VIEWED THE FOOTAGE AND DID OBSERVE A WOMAN ON THE COMPLAINANT'S PROPERTY THAT THE COMPLAINANT IDENTIFIED AS THE DEFENDANT.
AFFIANT, WHO ALSO KNOWS THE DEFENDANT BY NAME AND SIGHT FROM A PRIOR INVESTIGATION INVOLVING THE SAME PARTIES, GAVE THE DEFENDANT A CRIMINAL TRESPASS WARNING ON JUNE 27, 2014, AND WARNED HER NOT TO GO ONTO THE PROPERTY AT 1501 SOUTHWOOD DRIVE, BAYTOWN, HARRIS COUNTY, TEXAS.
AFFIANT LATER REVIEWED THE SURVEILLANCE FOOTAGE RECOVERED BY SHAFER AND RECOGNIZED THE WOMAN ON THE VIDEO AS THE DEFENDANT AND OBSERVED HER EXIT A BLACK PASSENGER CAR FROM THE PASSENGER SIDE; WALK UP THE ENTRANCE WALK WAY TO THE FRONT DOOR OF THE RESIDENCE; WALK AWAY A FEW MINUTES LATER; AND ENTER THE SAME BLACK PASSENGER CAR WHICH DROVE OFF.
