## COLLISION DETAILS:

On October 31, 2023, at approximately 11:12 PM, a critical injury vehicle versus vehicle collision occurred at South Rainbow Boulevard and West Hacienda Avenue. Minutes prior to the collision, Officers responded to a call for service regarding a male who was possibly experiencing a mental health crisis near the area of Blue Diamond Road and South Buffalo Drive. The subject in that call encountered the first arriving officer and was able to take a marked 2021 Ford F-150 police vehicle.

Evidence at the scene and a witness statement indicated the suspect was traveling north on South Rainbow Boulevard approaching West Hacienda Avenue in the stolen Ford F-150. The Ford F-150 then crossed the center turn lane and began traveling north in the southbound travel lanes as it entered the intersection on a steady red signal. A 2012 Ford Explorer was traveling east on West Hacienda Avenue on the right of two travel lanes as it entered the intersection on a steady green signal. A collision occurred when the Ford Explorer crossed the path of travel of the Ford F-150. The front of the Ford F-150 struck the passenger side of the Ford Explorer.

The Driver of the Ford-150 was taken into custody immediately following the collision and then transported by ambulance to University Medical Center's Trauma Unit. The driver and passenger of the Ford Explorer were transported by ambulance to University Medical Center's Trauma Unit with critical injuries. The collision remains under investigation by the Las Vegas Metropolitan Police Department's Collision Investigation Section.
