



On 12/06/23 I was dispatched to 2 Seleta Cir in Lexington County in reference to a gunshot wound.

LCCC advised that they received a call saying that a male had been shot in the head and that people were fighting. I arrived on scene and went toward the back of the residence and located a male, later identified as Kevin Newhouse, lying on the ground. Deputy Brazzell and Deputy Aiken were attempting life saving measure. There were three females on scene, one of them \_\_\_\_\_\_\_\_, and I escorted them off of the property. I then had Deputy Apgar put up crime scene tape and start a crime scene log. Deputy Aiken was gathering witnesses and watching the front of the scene. FTO Imel had the deceased body and back of the residence cover.

I then went and spoke with Ryan Lindler Jr, who is the one who shot Kevin Newhouse. Ryan explained that he witness Kevin on his property with their cameras and came to this address with his father, Ryan Lindler(Father) to confront Kevin. Ryan explained they started talking to Kevin but he "didn't say much," but explained that Kevin grabbed a machete and started to swing at them. Ryan explained that his father was hit and so was he. Ryan then explained that he took out his gun and shot Kevin. Ryan stated that people started to come out of the woods so they left. Ryan explained that he also called 911 about this incident.

Ryan did explain that the gun and machete were in his truck. This information was passed on to detectives. Ryan had a 6 round Glock magazine in his pocket. The magazine had 5 Venom 9P VNM rounds and 1 Luger 9mm round. Magazine was tagged into evidence.

I then called Major Crimes and advised them of the situation. I spoke with Watch Command and Region Command about the situation as well. Major Crimes, Coroner, Watch Command all arrived on scene. I was relieved by night shift.

My BWC was activated during this incident.
