DESCRIPTION OF OFFENSE: Murder / Murder

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On 12-06-2023, at approximately 1600 hrs. while in the rear of 2 Seleta Circle., which is in the Lexington area of Lexington County, SC the defendant, Ryan Jordan Lindler Sr. did with malice aforethought tell a co-defendant to shoot the victim, Kevin Lester Newhouse after the defendant disarmed and had taken a machete away from the victim. The defendant also prevented the victim from entering his residence prior to the physical altercation. The defendant admitted post-Miranda, that he and a co-defendant confronted the victim about a trespassing incident. During a physical altercation the defendant instructed the co-defendant to shoot the unarmed victim. These facts are supported by witness statements, defendant and co-defendant statements, evidence on scene, and LCSD incident report 23-023385.

The machete was recovered from the co-defendant's pickup truck after a lawful search warrant. These facts are supported by witness statements, defendant and co-defendant statements, evidence on scene, and LCSD incident report 23-023385.

On 12-06-2023, at approximately 1600 hrs. while in the rear of [REDACTED] Seleta Circle., which is in the Lexington area of Lexington County, SC the defendant, Ryan Jordan Lindler Jr. did with malice aforethought shoot and kill the victim, Kevin Lester Newhouse. The defendant admitted post-Miranda, that he and a co-defendant tracked the victim to the victim's residence and confronted him about a trespassing incident. A physical altercation took place and the defendant fired 3-4 shots from his Glock semi-automatic handgun, which struck and killed the victim. The handgun was recovered after a lawful Search Warrant of the defendant's pickup truck. The facts are supported by witness statements, defendant and co-defendant statements, evidence on scene, and LCSD incident report 23-023385.
