Pamela Reed reported to the , team that A.R. was having seizures.

Pamela posted numerous statements on Facebook about A.R. having cancer. There have been fundraisers, and donations collected to assist the Reed's with ALS "cancer" treatments. Zeps Against Cancer Organization reported they gave the Reed family around \$8,000 to help with the expenses of cancer treatments for AR.

On January 8, 2024, Pamela Reed was interviewed. Pamela first lied but then admitted that A.R. did not have cancer and she posted those statements because she liked the support given as a result. Pamela admitted that she had shaved AR'5 hair, and it was never because of cancer treatment. Pamela also admitted that she obtained seizure medications because of what she reported to the doctors. Pamela acknowledged that A.R. did not likely need the medication and the seizures she reported were more of

"staring sessions." Pamela showed the medications she had in the home that were prescribed to A.R. and some appeared to be full, while others were not. Pamela further admitted that she altered documents from the PROVEDER to say that A.R. had leukemia. She stated she created the document while at her home in Noble County, Ohio, and used a tablet to do so. Pamela stated she had sent the altered document to the school to show that A.R. had cancer. have another daughter, 10-year-old A.R. (same initials), who also lived in the home. Pamela and D. Both children were home during the interview with Pamela and believed that seven-year-old A.R. had cancer and was severely ill. Pamela stated that her husband, P. Reed was not home. As a result of the findings, both children were removed as there were concerns for their safety. I felt there was a substantial risk to the health and safety of both children. Redaded Pamela was arrested for Theft and booked into the Noble County Jail.
