NARRATIVE

*****Also an Agency Assist for an active failure to appear warrant CR2310344 out of Clarke County.**

***** Diego Jose Ibarra is barred from all of Walmart and 4375 Lexington Rd for 2 years.**

On 12-08-2023 at 0956 hours, I responded to Walmart at 4375 Lexington Rd for a shoplifter who was already stopped and in the Loss Prevention Office. The suspect did not speak English and he did not have any Identification with him.

I arrived and found both LPO Emily Bond and LPO Beth Stewart in the office with the suspect male. I was told that the male had put 2 men's t-shirts in a bag on the sales floor, went to the checkout paid for his soft drink then left the store where he was confronted. The T-shirts were valued at \$18.00.

The male did not speak English so Google Translator to translate many of my questions. The male was identified as Deigo Jose Abarra and his birthdate was [REDACTED] 1995. I gave this information to ACC Communications. I was advised that Ibarra had a previous shoplifting and a current warrant for failure to appear for a DUI charge.

LPO Bond checked Walmart files and found that Ibarra had been stopped in November for shoplifting but he was not barred on that day. She completed the barring form and explained it to Ibarra via Google Translate. He was told he was being barred from all of the property for 2 years. He shook his head yes to show he understood and signed the barring form.

LPO Bond told me that they would be prosecuting so I again used Google Translate to explain to Ibarra that he was being charged. I also told him that he had the warrant for failure to appear for the DUI. I had him stand up and remove his backpack. he then put his hands being his back where he was handcuffed (DL, BB).

Ibarra was searched for weapons and then sat in the back of my patrol vehicle. He asked again about the charges and again they were explained. I transported Ibarra to the Clarke County Jail, processed him, and released him to CCSO Jail Staff.

Since Ibarra had no ID and he had an active warrant he was not eligible for the PAD. My involvement was recorded on my Axon body camera.
