On Friday, February 23, 2024; 0513 hours, Westside Nightshift Patrol SGT T Choudhury 2246 contacted me, requesting assistance from Day Shift personnel.

I arrived on scene [REDACTED] and met with SGT. T Choudhury who informed me, suspected evidence relating to the UGA Homicide, was found [REDACTED] [REDACTED] last date, Thursday, February 22, 2024, in the hour pf 22:00. SGT T Choudhury informed UGAPD personnel arrived and retrieved the suspected evidence, and our Command Duty Officer, Captain Nichols was informed. SGT T Choudhury; however, did not want to give up the scene, and therefore was needing assistance from oncoming shift, to which was turned over to me.

With some remaining Nights West "A" Squad personnel, and some Days West "B" Squad personnel, Officers continued to look for evidence or subjects fitting the description obtained from found suspected evidence last date on the property of [REDACTED]

At approximately 08:32 hours OFC T Vaughn 2387 and I were walking through the complex looking at a photograph obtained from supected found evidence on our phones, when a subject, a Latino male, wearing an article, a baseball hat, that look just like the hat observed in the obtained suspected evidence surveillence video, walk into our presence. OFC T Vaughn and I called to the male subject, approached, and asked the subject for ID, to which the Latino male informed Officers he did not speak English. I asked the male subject in Spanish if had an ID, and the male subject informed he did not, but showed Officers his UGA Food services, employee name tag Diego. I asked Diego for his name in Spanish, and Diego informed Diego Ibarra. I aske Diego where he lived and he pointed toward the southwest corner [REDACTED] I asked Diego for his Apartment Number, and Diego advised [REDACTED] I asked Diego, using hand signals to walk Officer to his Apartment to which Diego did.

I informed Central Communications, Officers were out with a subject, and requested and have UGAPD in route to our location.

Diego retrieved and gave Officers a United States of Amercia Permanent Reisdence ID

card to which I observed to be fraudulent, showing a photograph of Diego, a finger print, but what appeared to be two dates of birth [REDACTED] 1995 and [REDACTED] 1995.

UGAPD Officers arrived on scene, and later followed by a Task Force of Law Enforcement Officials, including ICE Agents, investigating the UGA Homicide, Case 2024-02220176, ICE Agents were given the USA Permanent Residence ID Card, and later determined the ID Card to be fraudulent as well.

I later retrieved the USA Permanent Residence ID card back from ICE Special Agent, Ricardo Newman 7608. I procured warrants on Diego Jose Ibarra, reference the above Case 2024-02230074, for Possession of Fraudulent ID, and Diego was later transported to the Athens-Clarke County Jail by Officers on duty.
