A BILL

To prohibit deployment of Federal air marshals to the southern and northern borders of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No FAMS at the Bor-
5 der Act of 2024”.

1 **SEC. 2. PROHIBITION ON DEPLOYMENT.**

2 (a) **IN GENERAL.**—Section 44917 of title 49, United
3 States Code, is amended by adding at the end the fol-
4 lowing:

5 “(d) **PROHIBITION ON DEPLOYMENT.**—

6 “(1) **DEFINITIONS.**—In this subsection:

7 “(A) **ALIEN.**—The term ‘alien’ has the
8 meaning given that term in section 101 of the
9 Immigration and Nationality Act (8 U.S.C.
10 1101).

11 “(B) **APPROPRIATE CONGRESSIONAL COM-**
12 **MITTEES.**—The term ‘appropriate congressional
13 committees’ means—

14 “(i) the Committee on Commerce,
15 Science, and Transportation of the Senate;
16 and

17 “(ii) the Committee on Homeland Se-
18 curity of the House of Representatives.

19 “(C) **ILLEGAL ALIEN.**—The term ‘illegal
20 alien’ means an alien who has not been admit-
21 ted (as that term is defined in section 101 of
22 the Immigration and Nationality Act (8 U.S.C.
23 1101)).

24 “(D) **IMMIGRANT.**—The term ‘immigrant’
25 has the meaning given that term in section 101

1 of the Immigration and Nationality Act (8
2 U.S.C. 1101).

3 “(2) IN GENERAL.—Except as provided in para-
4 graph (3) and notwithstanding any other provision
5 of law, including section 103 of the Immigration and
6 Nationality Act (8 U.S.C. 1103), Federal air mar-
7 shals may not be deployed to the southern or north-
8 ern border of the United States for border security
9 or immigration purposes, including to aid the De-
10 partment of Homeland Security or any other Fed-
11 eral agency with the processing of illegal aliens, or
12 any other immigrants.

13 “(3) EXCEPTIONS.—

14 “(A) EXCEPTION IN CASE OF BORDER CRI-
15 SIS.—Paragraph (2) shall not apply if the Sec-
16 retary of Homeland Security—

17 “(i) determines that a border crisis
18 exists; and

19 “(ii) certifies to the appropriate con-
20 gressional committees in writing that a
21 border crisis exists.

22 “(B) NONDELEGATION.—The Secretary
23 may not delegate the authority to make a deter-
24 mination or certification described in subpara-
25 graph (A).”.

1 (b) TECHNICAL AMENDMENT.—Section 44917(b) of
2 title 49, United States Code, is amended by striking
3 “Under Secretary” each place it appears and inserting
4 “Administrator”.
