ORDER

AND NOW, this 1<sup>st</sup> day of March 2024, after a hearing held yesterday, the Court terminates the injunction issued January 24, 2024, and Orders the following:


- 1) Defendants, including all their employees, agents, successors, assigns or other individuals or entities acting under Defendants' direction or control, are enjoined from marketing and selling raw milk and/or products made with or from raw milk ("Raw Milk Products").
- 2) Defendants may manufacture, process, and/or distribute Raw Milk Products to/for immediate family members on a noncommercial basis.
- 3) Defendants shall permit the Pennsylvania Department of Agriculture entry to any location where Defendants manufacture, process, and/or distribute

Raw Milk Products to inspect, review records, draw samples, conduct tests, and take other actions related to this Order.

Nothing in this Order is to detract from the sincerely held beliefs of individuals who believe in the benefits of Raw Milk Products. However, this Court cannot ignore this Commonwealth's regulations requiring a permit to sell raw milk; to do otherwise is to improperly usurp the authority and responsibility of the Pennsylvania General Assembly. Upon notification of the Defendant's applying for a raw milk permit, and the commencement in good faith of the required testing and documentation requirements pertaining to same, this Court shall immediately reconsider whether to modify or terminate this Order.
