crossing pedestrians--to turn on his headlights. For the reasons that follow, we conclude that, with the record viewed in the light most favorable to the side opposing summary judgment, neither moving side was entitled to summary judgment, as there were genuine issues of fact concerning the reasonableness of Rupp's shout; that the district court erred in granting summary judgment to defendants by resolving fact issues in their favor; and that the court erred in ruling, on the present record, that plaintiff's speech was not

| 7  | I. BACKGROUND  |
|    |  |
| 8  | Rupp is an attorney residing in or near Buffalo. The principal individual            |
| 9  | defendants are Todd C. McAlister and Nicholas Parisi, who at the relevant time, were |
| 10 | officers of the Buffalo Police Department ("BPD"), and Jeffrey Giallella, a BPD      |
| 11 | lieutenant. The case concerns a December 2016 encounter between Rupp and             |
| 12 | McAlister in Buffalo that ended in the issuance of a noise-ordinance-violation       |
| 13 | summons to Rupp.   |

# 1 A. The Events

| 2  | Most, but not all, of the relevant facts are not in dispute, as gleaned                  |

| 7  | At approximately 8:30 p.m. on December 1, 2016, Rupp and his wife, near                  |
| 8  | 291 Seneca Street, after leaving Chef's Restaurant, began to cross the street to get to  |
| 9  | Chef's parking lot. (Undisputed $\P$ 1.) "As the couple crossed to the middle of the     |

| 4  | only inches from the pedestrians." (Affidavit of Linda M. Rupp dated February 28,                |
| 5  | 2019 ("Linda Rupp Aff."), ¶ 4.)  |
| 6  | In their answer to the complaint, defendants denied knowledge or                                 |
| 7  | information as to most allegations, including that 8:30 p.m. on December 1 was "well             |
| 8  | after sunset" and that "the street was dark aside from the street lights and nearby              |
| 9  | illuminated signage" (Complaint and Answer $\P$ 26). And in response to the                      |
| 10 | complaint's ¶ 30, defendants stated that they "admit[ted] that [McAlister] did not               |
| 11 | strike any female patrons" but "den[ied] knowledge or information sufficient to form             |
| 12 | a belief as to the truth or falsity of the remaining allegations in said paragraph"              |
| 13 | (Answer $\P$ 30) <i>i.e.</i> , apparently unable to know or estimate the distance of the vehicle |
| 14 | from the pedestrians when McAlister stopped, or know whether it had "come to an                  |
| 15 | abrupt stop" (or even whether McAlister had "appl[ied] his brakes").                             |
| 16 | Similarly, in response to Rupp's Material Fact ¶ 6, that McAlister had                           |
| 17 | "abruptly applied his brakes and was able to stop only a few feet away from the two              |
| 18 | female pedestrians, nearly hitting and killing them," defendants responded only that             |

| 6  | B. The Unabandoned Claims in the Present Action   |
| 7  | Rupp had commenced the present action in November 2017, asserting                       |
| 8  | 13 numbered causes of action. Following motions to dismiss and for summary              |
| 9  | judgment, the matter was referred to Magistrate Judge Jeremiah J. McCarthy for          |
| 10 | report and recommendation. To the extent pertinent to this appeal, the magistrate       |
| 11 | judge found that there were material issues of fact to be tried as to certain of Rupp's |
| 12 | claims. See Rupp v. City of Buffalo, No. 17-CV-1209S, 2019 WL 12074104, at *8-*9        |
| 13 | (W.D.N.Y. Aug. 7, 2019) ("Report and Recommendation"), familiarity with which is        |
| 14 | assumed. He principally recommended the denial of defendants' motion to dismiss         |
| 15 | the First Amendment retaliation claim, and the denial of both sides' motions for        |
| 16 | summary judgment with regard to the claims of false arrest and malicious                |
| 17 | prosecution based on the existence (as defendants argued) or absence (as Rupp           |

argued) of probable cause for Rupp's arrest for noise-ordinance violation. *See id.* at \*15.

| 3        | Both sides objected to some parts of the magistrate judge's Report and  |
|----------|---|
| 4        | Recommendation. The district court, in a Decision and Order dated March 29, 2021,                                       |
| 5        | determined that about half of the claims asserted by Rupp had either been abandoned                                     |
| 6        | (for failure to object to the magistrate judge's recommendation for dismissal) or were                                  |
| 7        | duplicative of other claims. See Rupp v. City of Buffalo, No. 17-CV-1209S, 2021 WL                                      |
| 8        | 1169182, at *6 (W.D.N.Y. Mar. 29, 2021) (or "D.Ct.Op."). The court concluded that                                       |
| 9        | Rupp's unabandoned causes of action were  |
| 10       | - claims asserted against McAlister, Parisi, and Giallella for First  |
| 11<br>12 | Amendment retaliation ( <b>Claim 1</b> ), and for false arrest in violation of the Fourth Amendment ( <b>Claim 2</b> ); |
| 13       | - claims against all defendants for false arrest in violation of New  |
| 14       | York law ( <b>Claim 4</b> );  |
| 15       | - a claim against McAlister for malicious prosecution in violation  |
| 16       | of New York law ( <b>Claim 5</b> );   |
| 17       | - claims against Parisi and Giallella for failure to intervene to   |
| 18       | prevent McAlister's violations of Rupp's First and Fourth Amendment   |
| 19       | rights ( <b>Claim 11</b> );   |
| 20       | - a claim against the City for the surviving state-law torts on a   |
| 21       | theory of respondeat superior under New York law (Claim 7); and   |

# - a claim against the City for First Amendment violation in the application of its noise ordinance (Claim 9).

*See id.* at \*7-\*13.

## 4 C. The District Court's Decision

| 5  | In its Decision and Order, the district court disagreed with the report of           |
|----|--|
| 6  | the magistrate judge to the extent that he recommended denial of defendants' motion  |
| 7  | to dismiss the above claims. As to the First Amendment retaliation claims, the court |
| 8  | found that Rupp's shout to McAlister was not entitled to First Amendment protection  |
| 9  | and was, in any event, foreclosed by the existence of probable cause for his noise-  |
| 10 | violation arrest. The court stated, <i>inter alia</i> , as follows.                  |
| 11 | "[T]he First Amendment protects a significant amount of                              |
| 12 | verbal criticism and challenge directed at police officers." <i>City of</i>          |
| 13 | Hous. v. Hill, 482 U.S. 451, 461, 107 S. Ct. 2502, 96 L. Ed. 2d 398                  |
| 14 | (1987). "Speech directed at police officers will be protected unless                 |
| 15 | it is likely to produce a clear and present danger of a serious                      |
| 16 | substantive evil that rises far above public inconvenience,                          |
| 17 | annoyance or unrest." Kerman v. City of New York, 261 F.3d 229,                      |
| 18 | 242 (2d Cir. 2001).  |
| 19 | Relying on this body of law, Rupp argues that he engaged                             |
| 20 | in protected criticism of a police officer when he yelled out at                     |
| 21 | McAlister. But this argument fails to recognize the significance of                  |
| 22 | two key admissions. First, Rupp admits that he did not know that                     |
| 23 | he was yelling at a police officer until well after he yelled. He                    |
|    |  |

1 therefore did not direct or intend his speech as criticism of a police officer. Second, Rupp admits that he yelled out because he was 2 "[u]pset with the driver's reaction and provoked by the fear he 3 had induced in my wife and me." (Rupp Aff., ¶ 7.) Rupp 4 therefore did not intend or express his speech as criticism of police 5 6 conduct in the moment. To the contrary, the undisputed record demonstrates that Rupp simply yelled at a passing car, after dark, 7 which yell contained an expletive. 8

9 D.Ct.Op., 2021 WL 1169182, at \*8 (emphasis in original). The court continued:

10 Now after the fact, Rupp *artfully* attempts to characterize his yell as a protected warning about *dangerous* police *conduct--driving* 11 12 a police vehicle at night without headlights illuminated--and argues that he did not have to know that the driver was a police officer for his 13 speech to be protected as criticism of law enforcement under the First 14 Amendment. (Reply Memorandum, Docket No. 26, p. 3.) But 15 Rupp offers no authority for this proposition, and none of the 16 17 cases upon which he relies involve speech directed at an 18 individual who, as it later turned out, just happened to be a police officer. 19

20 *Id.* (emphases added).

21 Rather, and not surprisingly, each of the cases Rupp cites involves 22 speakers criticizing individuals known to be police officers and targeted for speech because they are police officers engaged in 23 police duties. See, e.g., Hill, 482 U.S. at 453-54, 107 S.Ct. 2502 24 25 (speech directed at a uniformed officer engaged in police duties); 26 Hartman [v. Moore], 547 U.S. [250,] 252-53, 126 S. Ct. 1695[, 1699 27 (2006)] (speech directed at federal officials); Lewis v. City of New Orleans, 415 U.S. 130, 94 S. Ct. 970, 39 L. Ed. 2d 214 (1974) (striking 28 down an ordinance criminalizing certain speech directed at police 29 30 officers); Smith v. Campbell, 782 F.3d 93, 96-97 (2d Cir. 2015) 31 (speech directed at known law enforcement officers related to

Officer Shield</i> #207, 180 F.3d 409, 413 (2d Cir. 1999) (speech directed at uniformed state court security officers engaged in their duties); <i>Duran v. City of Douglas, Ariz.</i> , 904 F.2d 1372, 1374-75 (9th Cir. 1990) (speech and conduct directed to a uniformed police officer conducting police duties). |

| 7                     | Given Rupp's admission that he did not know that he was  |
| 8                     | yelling at a police officer, this Court finds that no reasonable juror   |
| 9                     | could conclude that he engaged in speech protected by the First  |
| 10                    | Amendment in the form of law enforcement criticism. Rupp therefore   |
| 11                    | cannot establish the first element of his claim, which itself entitles   |
| 12                    | Defendants to summary judgment.  |
| 13                    | <i>Id</i> . (emphasis added).  |
| 14                    | The court also found that defendants' actions had not "chilled" Rupp's   |
| 15                    | speech because   |
| 16                    | [t]he undisputed record also demonstrates that the   |
| 17                    | individual defendants' actions did not actually chill Rupp's   |
| 18                    | speech. To the extent it could be found that Rupp was  |
| 19                    | complaining about police conduct before McAlister detained him,  |
| 20                    | Rupp concedes that he continued to complain about police   |
| 21                    | conduct throughout the encounter with Defendants McAlister,  |

| 3        | Having noted that the existence of probable cause will normally defeat   |
| 4        | a claim of arrest in retaliation for the exercise of First Amendment rights, see id. at *7,                                  |
| 5        | the court addressed the record as to the existence or absence of probable cause for  |
| 6        | Rupp's arrest. The court noted that the magistrate judge had   |
| 7        | found it undisputed that McAlister "nearly hit two pedestrians   |
| 8        | crossing the street." (Report and Recommendation, p. 11 n. 8.)   |
| 9        | From there, he found that Rupp's yell "plainly constitute[d] a   |
| 10       | justified warning." Id. This Court does not share that view of the   |
| 11       | <i>record</i> . McAlister states that the pedestrians "abruptly walk[ed]   |
| 12       | out into the street," and that he stopped for them to cross safely.  |
| 13       | (McAlister Aff., $\P\P$ 4, 5.) The Rupps, on the other hand, maintain  |
| 14       | that McAlister nearly hit the pedestrians, with Rupp estimating  |
| 15       | that McAlister stopped two feet in front of them, and Linda  |
| 16       | stating that he stopped "only inches" from them. (Rupp Aff., $\P$ 6;   |
| 17       | L. Rupp Aff., $\P$ 4.) Notwithstanding this disagreement, it is underwited that Machineter atomical and that the medactricus |
| 18<br>19 | undisputed that McAlister stopped his vehicle and that the pedestrians crossed safely.                                       |
| 20       | D.Ct.Op., 2021 WL 1169182, at *10 n.8 (emphases added).  |
| 21       | The district court reasoned that there was probable cause, stating as  |
| 22       | follows:   |
| 23       | In assessing whether probable cause existed for McAlister  |
| 24       | to detain and cite Rupp for violating this noise ordinance, this   |
| 25       | Court considers the totality of the following undisputed facts   |

1 known to McAlister. First, it was approximately 8:30 p.m. and dark outside. Second, both McAlister and Rupp were in a public, 2 outdoor space near Chef's Restaurant, which was open and 3 operating. Third, McAlister stopped his vehicle in the vicinity of 4 Chef's Restaurant to permit two pedestrians to safely cross Seneca 5 Street. Fourth, that after McAlister began to proceed again, Rupp 6 yelled, "Turn your lights on, asshole," loudly enough to cause 7 McAlister to turn into the parking lot and further investigate. 8 9 Fifth, that the two pedestrians were also in proximity to hear Rupp's yell. 10

11 Based on these undisputed facts, this Court concludes as a matter of law that McAlister had probable cause to detain and cite Rupp for 12 violating the noise ordinance. Rupp yelled loudly at night in a 13 public place--loudly enough for McAlister to hear him in his running 14 15 *vehicle as he proceeded down the street--in front of a restaurant and* at least three unknown individuals, and his yell contained an 16 expletive. Given both the volume and nature of Rupp's yell in the 17 18 presence of *bystanders*, a reasonable person of normal sensitivities could be annoved and have their quiet, comfort, and repose 19 disturbed. McAlister therefore had probable cause to detain and 20 cite Rupp for violating the noise ordinance. 21

- 22 D.Ct.Op., 2021 WL 1169182, at \*10 (footnote omitted) (emphases added).
- 23 The court found that Rupp's argument that "no reasonable person would
- 24 be annoyed by a yelled" "warning to a police officer engaged in dangerous conduct,"
- 25 was "unpersuasive" for two reasons. *Id.*

First, Rupp's argument hinges on his belief that a loud warning was warranted. But *the salient facts for determining probable cause are those understood by McAlister*, not by Rupp. *See Panetta [v. Crowley]*, 460 F.3d [388,] 395 [(2d Cir. 2006)]. *In that*

| 1<br>2 | regard, at the time Rupp yelled, McAlister did not perceive any apparent danger or emergency. |
|--------|---|
| 3      | D.Ct.Op., 2021 WL 1169182, at *10 (emphases added). The court continued:                      |
| 4      | There is no evidence that McAlister knew while he was driving that                            |
| 5      | his headlights were off, nor did McAlister view the situation with                            |
| 6      | the two pedestrians as dangerous. (McAlister Aff., $\P\P$ 4, 5.) <i>From</i>                  |
| 7      | McAlister's perspective the pedestrians stepped in front of him,                              |
| 8      | which caused him to have to stop to allow them to cross safely. Id.                           |
| 9      | Whether Rupp perceived the situation differently has no bearing                               |
| 10     | on what McAlister knew at the time he heard Rupp yell for purposes                            |

| 18     | Second, as McAlister assessed this <i>fluid situation</i> , he was not                        |
| 19     | required to explore every legitimate reason Rupp may have had                                 |
| 20     | for yelling Rupp essentially argues that McAlister should                                     |
| 21     | have elected not to cite him under the circumstances. But                                     |
| 22     | discretion to charge and probable cause to charge are distinct                                |
| 23     | concepts. Here, probable cause to believe that Rupp violated the                              |
| 24     | noise ordinance arose the moment McAlister heard Rupp loudly                                  |
| 25     | yell a phrase containing an expletive at night in a public place                              |

| 12 | Having determined "that probable cause existed as a matter of law, or at                  |
| 13 | a minimum, that arguable probable cause existed," the court concluded that                |
| 14 | defendants were also entitled to summary judgment dismissing Rupp's false arrest          |
| 15 | claim, see id. at *12, and his malicious prosecution claim, see id. at *13. And on the    |
| 16 | bases of all of the above findings, the court found that the federal claims of failure to |
| 17 | intervene and the New York claim of respondeat superior were dismissable for lack         |
| 18 | of any predicate violations. <i>See id</i> .  |
| 19 | Judgment was entered dismissing the complaint. This appeal followed.                      |

# II. DISCUSSION

| 2  | On appeal, Rupp contends principally that the district court erred in                     |
|----|---|
| 3  | ruling that his speech was not protected by the First Amendment, and in holding that      |
| 4  | there was probable cause for his arrestthe existence of which would have defeated         |
| 5  | his claims of false arrest, malicious prosecution, and First Amendment retaliation.       |
| 6  | Rupp also contends that he was entitled to summary judgment in his favor. For the         |
| 7  | reasons that follow, we conclude that neither side was entitled to summary judgment.      |
|    |   |
| 8  | A. Summary Judgment Principles  |
| 9  | Principles governing consideration of motions for summary judgment                        |
| 10 | and appellate review of the grant of such motionsare well established.                    |
| 11 | A motion for summary judgment may properly be granted-                                    |
| 12 | -and the grant of summary judgment may properly be affirmed                               |
| 13 | only where there is no genuine issue of material fact to be tried,                        |
| 14 | and the facts as to which there is no such issue warrant the entry                        |
| 15 | of judgment for the moving party as a matter of law. See Fed. R.                          |
| 16 | Civ. P. 56[(a)]).   |
| 17 | Kaytor v. Electric Boat Corp., 609 F.3d 537, 545 (2d Cir. 2010) ("Kaytor"). "The function |
| 18 | of the district court in considering the motion for summary judgment is not to resolve    |

| 1                    | disputed questions of fact but only to determine whether, as to any material issue, a  |

| 3                    | In considering whether such a fact issue exists, the court is not to make  |
| 4                    | credibility determinations or weigh the evidence. "'Credibility determinations, the  |
| 5                    | weighing of the evidence, and the drawing of legitimate inferences from the facts are  |
| 6                    | jury functions, not those of a judge." <i>Reeves v. Sanderson Plumbing Products, Inc.</i> , 530  |
| 7                    | U.S. 133, 150 (2000) (reviewing denial of defense motion for judgment as a matter of   |
| 8                    | law following a jury verdict for plaintiff, quoting Anderson v. Liberty Lobby, Inc., 477   |

| 12                   | Further, in reviewing motions for such relief,   |
| 13<br>14<br>15<br>16 | the district court may not properly consider the record in piecemeal fashion ; rather, it must "review all of the evidence in the record" And in reviewing all of the evidence to determine whether judgment as a matter of law is appropriate, "the court |
| 17                   | must draw all reasonable inferences in favor of the nonmoving party,"  |
| 18                   | even though contrary inferences might reasonably be drawn  |
| 19                   | ••••   |
| 20                   | Kaytor, 609 F.3d at 545 (quoting Reeves, 530 U.S. at 150 (other internal quotation marks   |
| 21                   | omitted) (first emphasis ours; second emphasis in Kaytor)). Summary judgment is  |

appropriate when "there can be but one reasonable conclusion as to the verdict."
 *Liberty Lobby*, 477 U.S. at 250.

#### **B.** First Amendment Protection

"The First Amendment guarantees all persons freedom to express their 4 5 views. The scope of permitted expression is broad; insults that contain neither threats of coercion that intimidate nor fighting words that create the possibility of imminent 6 violence, see Chaplinsky v. New Hampshire, 315 U.S. 568, 572 (1942), must be tolerated." 7 X-Men Security, Inc. v. Pataki, 196 F.3d 56, 68-69 (2d Cir. 1999) (internal quotation 8 The First Amendment "generally prevents government from marks omitted). 9 proscribing speech . . . because of disapproval of the ideas expressed." *R.A.V. v. City* 10 of St. Paul, 505 U.S. 377, 382 (1992). 11 "To plead a First Amendment retaliation claim a plaintiff must show: (1) he has a right protected by the First Amendment; (2) 12 the defendant's actions were motivated or substantially caused by his exercise of that 13 14 right; and (3) the defendant's actions caused him some injury." *Dorsett v. County of* Nassau, 732 F.3d 157, 160 (2d Cir. 2013). This appeal primarily concerns the first 15 16 element of a First Amendment retaliation claim--specifically whether Rupp's speech was protected by the First Amendment. 17

| 1  | "[S]peech on matters of public concern is at the heart of First Amendment                       |

| 2  | protection." Dun & Bradstreet, Inc. v. Greenmoss Builders, Inc., 472 U.S. 749, 758-59           |
| 3  | (1985) (plurality opinion) (internal quotation marks omitted). Whether speech                   |
| 4  | "addresses a matter of public concern" is to "be determined by the content, form, and           |
| 5  | context of [the relevant] statement, as revealed by the whole record." Connick v.               |
| 6  | Myers, 461 U.S. 138, 147-48 (1983); see id. at 140 (discussing First Amendment                  |
| 7  | protection for government employeeswho "do[] not," by accepting government                      |
| 8  | employment, "relinquish First Amendment rights" "as a citizen[]" to "comment[] upon             |
| 9  | matters of public concern" (internal quotation marks omitted); Dun & Bradstreet, 472            |
| 10 | U.S. at 761-62 (plurality opinion) (discussing First Amendment protection for credit            |
| 11 | reports sold through subscriptions). Speech that relates to "any matter of political,           |
| 12 | social, or other concern to the community," Jackler, 658 F.3d at 236 (quoting Connick,          |
| 13 | 461 U.S. at 146), which may include conduct "implicat[ing] 'public safety and welfare,"         |
| 14 | Gorman v. Rensselaer County, 910 F.3d 40, 46 (2d Cir. 2018) (quoting Jackler, 658 F.3d          |

| 1  | For these reasons, "[t]he First Amendment protects a significant amount                          |

| 2  | of verbal criticism and challenge directed at police officers," <i>City of Houston, Texas v.</i> |
| 3  | Hill, 482 U.S. 451, 461 (1987)including speech that, had it been between civilians               |
| 4  | might, especially in bygone eras of greater civility, have been viewed as "fighting              |
| 5  | words," see, e.g., Greene v. Barber, 310 F.3d 889, 896 (6th Cir. 2002) (to call a police         |
| 6  | officer "an 'asshole' [i]s not egregious enough to trigger application of the 'fighting          |
| 7  | words' doctrine").   |
| 8  | In the present case, the district court ruled that Rupp's shout at McAlister                     |
| 9  | was not entitled to First Amendment protection primarily because Rupp, at the time               |
| 10 | of his shout, "did not know that he was yelling at a police officer," D.Ct.Op., 2021 WL          |
| 11 | 1169182, at *8. But not knowing that the vehicle's driver was a police officer had no            |
| 12 | bearing on whether Rupp's shout was speech on a matter of public concern. Rupp                   |
| 13 | did not need to know who was driving in the dark without headlights in order to                  |
| 14 | understand that such conduct was dangerous. And he had not shouted at the driver                 |
| 15 | until he saw the vehicle nearly hit the two pedestrians.   |
| 16 | The district court rejected Rupp's contention that he was not required to                        |
| 17 | "know that the driver was a police officer [in order] for his speech to be protected" by         |
| 18 | the First Amendment, because he was "warning" of the "dangerous" fact that the                   |

| 1  | vehicle was being driven "at night without headlights illuminated." Id. at *8. The              |

| 2  | court characterized Rupp's argument as "artful[]," quoting Rupp as having                       |
| 3  | "admit[ted] that he yelled out because he was '[u]pset with the driver's reaction and           |
| 4  | provoked by the fear [the driver] had induced in [Rupp and his] wife," and ruling               |
| 5  | that "the undisputed record demonstrates that Rupp simply yelled at a passing car,              |
| 6  | after dark, which yell contained an expletive." <i>Id</i> . (quoting Rupp Aff. $\P$ 7 (emphasis |
| 7  | ours)).   |
| 8  | We have many difficulties with this rationale, including the court's                            |
| 9  | interpretation of the record, its assessments of the evidence, and its acceptance of            |
| 10 | defendants' assertion that there was in fact no danger.   |
| 11 | First, the district court's characterizing Rupp's contention that he was                        |
| 12 | warning of danger as "artful[]"and so characterizing it because Rupp had stated in              |
| 13 | his affidavit that he was "[u]pset"indicate that the court (a) made a negative                  |
| 14 | assessment of Rupp's credibility, and (b) made that assessment by weighing Rupp's               |
| 15 | warning-of-danger explanation against another fragment of evidence. But credibility             |
| 16 | assessments and the weighing of evidence are the province of the factfinder. When               |
| 17 | the issue is whether a party is entitled to summary judgment, determinations of                 |

credibility, choices between permissible inferences, and the weighing of the evidence
 are beyond the authority of the court.

Second, while the court found that Rupp's shout simply complained 3 about his own personal situation, suggesting that it did not implicate a matter of 4 public concern, the record plainly does not require that inference. While Rupp 5 doubtless had been frightened when he noticed the approach of the lightless vehicle 6 while he was crossing the street, he and his wife had already safely reached the other 7 side before he made any shout. And there is nothing in the record to suggest that the 8 driver of the vehicle reacted in any way to the street-crossing by the Rupps. Thus, 9 whatever Rupp yelled could not have been in response to a "driver's reaction" to 10 Rupp's own experience. 11

12 Third, relying solely on the first sentence of paragraph 7 of Rupp's 13 affidavit, the court did not view the record in the light most favorable to Rupp, or in 14 light of the record as a whole--or even in light of that section of the affidavit as a 15 whole. In paragraph 6, Rupp described seeing the two pedestrians "step[] directly 16 into the path" of the oncoming vehicle, seeing the vehicle "stop approximately two 17 feet from the pedestrians," and seeing the driver "flash[] either his headlights or high-

| 1      | beams at the pedestrians." (Rupp Aff. $\P$ 6.) The next three sentences in the affidavit,       |
|--------|---|
| 2      | including the middle sentence on which the district court solely focused, were:                 |
| 3      | The operator then turned the car lights back off. [] Upset with the                             |
| 4      | driver's reaction and provoked by the fear he had induced in my                                 |
| 5      | wife and me, I called out to the driver "turn your lights on,                                   |
| 6<br>7 | asshole." My words were a warning to the officer that <i>his headlights were still not on</i> . |
| 8      | (Rupp Aff. $\P\P$ 6-7 (emphases added).) With the evidence provided in paragraphs 6             |
| 9      | and 7, a jury could well disagree with the court's conclusion that "Rupp simply yelled          |
| 10     | at a passing car," D.Ct.Op., 2021 WL 1169182, at *8.  |
| 11     | Fourth, as to the substance of Rupp's five-word shout, the court focused                        |
| 12     | on the fact that it "contained an expletive," <i>id</i> . As discussed in Part II.C.1. below, a |
| 13     | jury would be entitled to view a shout as unreasonable noise if all five words were             |
| 14     | "asshole" or other expletives; but in fact Rupp shouted "turn your lights on, asshole."         |
| 15     | We have no doubt that he was upset; but his shout was an exhortation that was                   |
| 16     | forward-looking in the interest of public safety. A rational juror could easily view the        |
| 17     | shout <i>as</i> an attempt to avert a possible accident by (a) a vehicle without lights, (b)    |
| 18     | whose driver appeared not to know he was driving without lights, (c) who had just               |
| 19     | had to stop for two pedestrians in his path attempting to cross the street, and (d) who         |

even after that abrupt stop, resumed driving without headlights--and thus could
 easily view the shout as eminently reasonable.

| 3  | We also note our puzzlement at the court's reliance on the fact that                           |
|----|--|
| 4  | "McAlister" himself did "no[t] view the situation with the two pedestrians as                  |
| 5  | dangerous," D.Ct.Op., 2021 WL 1169182, at *10 (emphases added), especially since the           |
| 6  | court also noted that there was "no evidence that McAlister knew while he was driving          |
| 7  | that his headlights were off," <i>id</i> . (emphasis in original). One of the main purposes of |
| 8  | headlights is to permit the driver to see at a distance what is in his path. As an             |
| 9  | objective matter, it is difficult to credit a safety assessment by an officer who was          |
| 10 | bereft of the benefit of headlights; it is all the more difficult to accept his "view" or      |
| 11 | assessment if in fact he did not know he was driving without headlights. And                   |
| 12 | whether McAlister was negligently or deliberately driving without his headlights on,           |
| 13 | it must surely have been dangerous for the two pedestrians; they unknowingly                   |
| 14 | stepped into the path of a hard-to-see vehicle, "caus[ing the driver] to have to stop to       |
| 15 | allow them to cross safely," <i>id</i> . (emphasis added). Yet the district court appears to   |
| 16 | have viewed McAlister's possible ignorance that he was driving without headlights              |
| 17 | as making it unreasonable for a concerned observer to yell at him to turn them on.             |

| 1  | Finally, the district court was not entitled to adopt the defendants' view             |
|----|--|
| 2  | that the vehicle without its headlights on did not present a danger to, and was not    |
| 3  | involved in a near-accident with, the two pedestrians. We note that in response to     |
| 4  | Rupp's contention that there had been a "near-accident," defendants stated, in         |
| 5  | pertinent part, that they "do dispute that there was a near-accident as Defendant      |
| 6  | McAlister was able to safely stop the vehicle without striking the pedestrians."       |
| 7  | (Defendants' Local Rule 56(a) Response ¶ 8 (emphases added).) As an effort to deny     |
| 8  | that there had been a "near" accident, the explanation that there was no actual        |
| 9  | accident is simply a non sequitur. Yet the simple fact that an accident did not occur  |
| 10 | was the district court's rationale for concluding that there was no near-accident. See |
| 11 | D.Ct.Op., 2021 WL 1169182, at *10 n.8 (rejecting the contention that McAlister had     |
| 12 | "nearly" hit the two pedestrians, because "it is undisputed that McAlister stopped his |
| 13 | vehicle and that the pedestrians crossed safely").                                     |
| 14 | In our view, the record would easily support a finding that there was a                |
| 15 | near-accident, and defendants adduced no evidence to show that there was not. In       |

16 support of their non-sequitur denial of a near-accident, defendants submitted an

17 affidavit from McAlister that is significant for both what it asserts and what it omits.

18 McAlister states, *inter alia*, that in proceeding down Seneca Street he "observed two

female pedestrians abruptly walk out into the street," that he stopped and flashed the 1 lights to signal that it was safe for them to cross, and that after they had "safely 2 crossed," he "began to drive away." (McAlister Aff. ¶¶ 4-5 (emphasis added).) He 3 omits mention of the fact that when he saw the pedestrians he was driving without 4 5 headlights or other illumination--conduct that defendants nonetheless admit (see 6 Undisputed ¶ 4). Nor does he mention that when he began to drive away from that spot, he again was driving without lights, which defendants also acknowledge (see 7 Defendants' brief on appeal at 2 ("After the women safely crossed, the vehicle's lights 8 then went dark again as McAlister proceeded ....")). McAlister's affidavit also does 9 10 not provide any estimate as to how near his vehicle was to the pedestrians when he stopped it, although his indication that the pedestrians appeared in the roadway 11 suddenly ("abruptly") supports an inference--which a jury would be entitled to draw--12 that the pedestrians were relatively close when he first saw them, and hence were 13 14 close when he managed to stop the vehicle. As the district court stated, "[f]rom 15 McAlister's perspective, [when] the pedestrians stepped in front of him," he "ha[d] to stop to allow them to cross safely." D.Ct.Op., 2021 WL 1169182, at \*10 (emphasis 16 added). 17

| 1  | Nothing in McAlister's affidavit refutes the statements in the affidavits                                    |

| 2  | submitted by Rupp and his wife that McAlister stopped his vehicle "two feet" (Rupp                           |
| 3  | Aff. $\P$ 6) or "inches" (Linda Rupp Aff. $\P$ 4) from the crossing pedestrians, and that                    |

| 17 | Amendment rightslike a claim for false arrest or malicious prosecutionmay be                                 |

promote health, *safety and welfare* and the peace, quiet, comfort

## 4 2. *Probable Cause*

In general, probable cause to arrest exists when "the historical facts, 5 6 viewed from the standpoint of an objectively reasonable police officer," Ornelas v. United States, 517 U.S. 690, 696 (1996), provide knowledge or reasonably trustworthy 7 information sufficient to warrant a person of reasonable caution in the belief that an 8 offense has been or is being committed by the person to be arrested, see, e.g., 9 Devenpeck v. Alford, 543 U.S. 146, 152-53 (2004) ("the circumstances" must be "viewed 10 objectively"); Whren v. United States, 517 U.S. 806, 813 (1996) (same). 11 As the district court noted, the existence of "[p]robable cause for an 12

arrest must be determined on the basis of the information reasonably available to the
arresting officer *at the time of the arrest*," D.Ct.Op., 2021 WL 1169182, at \*10 (quoting

15 *Lowth v. Town of Cheektowaga*, 82 F.3d 563, 570 (2d Cir. 1996) (emphasis ours)).

| 7      | Roper testified that he did not decide to arrest Provost                               |
| 8      | until after Provost had gone into the back of the station. <i>The jury</i>             |

## 4. Arguable Probable Cause

16 Defendants also argue, and the district court ruled, that if there was not 17 probable cause for Rupp's arrest, the individual defendants were at least entitled to

| 1  | summary judgment on the basis of qualified immunity on the ground that there was                    |

| 2  | "arguable" probable cause. Again we disagree.   |
| 3  | Qualified immunity shields officials performing discretionary functions                             |
| 4  | "from liability for civil damages insofar as their conduct does not violate clearly                 |
| 5  | established statutory or constitutional rights of which a reasonable person would                   |
| 6  | have known." <i>Harlow v. Fitzgerald</i> , 457 U.S. 800, 818 (1982). With respect to a claim        |
| 7  | of arrest without probable cause, the doctrine shields officers from suit for damages               |
| 8  | if "a reasonable officer could have believed" his action "to be lawful, in light of                 |

| 12 | In addition, qualified immunity is available where officers of reasonable                           |

| 14 | Briggs, 475 U.S. 335, 341 (1986), <i>i.e.</i> , where the existence of probable cause for an arrest |
| 15 | was at least reasonable and arguable, see, e.g., Garcia v. Does, 779 F.3d 84, 92 (2d Cir.           |
| 16 | 2015), "even if mistaken," <i>Hunter</i> , 502 U.S. at 229. But while a mere mistake in the         |
| 17 | performance of an official duty may not deprive the officer of qualified immunity,                  |
| 18 | that doctrine does not shield performance that either (a) was in violation of clearly               |

| 6  | Here, the record indicates that McAlister had been instructed to retrieve                 |
| 7  | a lieutenant's car from one police site and deliver it to another. See D.Ct.Op., 2021 WL  |
| 8  | 1169182, at *2 n.3. We cannot agree that a person of reasonable caution would drive       |
| 9  | on city streets in the dark without headlights either intentionally or negligently. Nor   |
| 10 | can we agree that, as a matter of law, a reasonable officer (unless on an official        |
| 11 | mission of stealth) driving on a city street in the dark without headlights could have    |
| 12 | any objectively reasonable beliefor even an arguably reasonable beliefthat a shout        |
| 13 | to him to "turn your lights on, asshole" constituted an unreasonable infringement on      |
| 14 | his own comfort and repose, or the doubtless-dissipated comfort of the pedestrians        |
| 15 | he had just managed to brake in order to avoid hitting, or the comfort and repose of      |
| 16 | anyone else who could have been (but in this case was not shown to be) in the             |
| 17 | vicinity, so as to constitute a violation of the Buffalo ordinance prohibiting noise that |
| 18 | was unreasonable. Plainly McAlister was annoyed; but we cannot agree that, as a           |

| 5  | D. Other Issues  |
| 6  | For the reasons stated above, we vacate the dismissals of Rupp's claims                        |
| 7  | for false arrest, malicious prosecution, and First Amendment retaliation, <i>i.e.</i> , Claims |
| 8  | 1, 2, 4, and 5, see Part I.B. above. We also reinstate his claims for failure to intervene     |
| 9  | or for respondeat superior (Claims 7 and 11), which were dismissed by the district             |
| 10 | court because it had dismissed the predicate claims, which we are reinstating.                 |
| 11 | We affirm the dismissal of Rupp's claim that his First Amendment rights                        |
| 12 | were violated by the noise ordinance "as-applied" to him. The record contains no               |
| 13 | evidence of any immediate or interim curtailment of Rupp's speech rights; and after            |
| 14 | a full hearing, Rupp was found not guilty of violating the noise ordinance. Thus, the          |
| 15 | ordinance was not actually applied to him. His claims of false arrest, malicious               |
| 16 | prosecution, and First Amendment retaliation are being reinstated.                             |

We decline Rupp's request for entry of summary judgment in his favor. 1 In reviewing the district court's grant of summary judgment against Rupp, we were 2 required to draw all reasonable inferences or make all credibility determinations in 3 his favor. A jury at trial of course is under no such obligation. And in considering 4 Rupp's motion for summary judgment in his favor, we are required to draw all such 5 inferences and make such credibility determinations against him. As indicated above, 6 there are questions for the jury as to the dangerousness of the circumstances Rupp 7 observed--for example, whether and to what extent McAlister came close to hitting 8 the pedestrians. 9

#### CONCLUSION

We have considered all of defendants' contentions in support of summary judgment in their favor and have found them to be without merit. The judgment is affirmed to the extent that it dismissed Rupp's Claim 9; it is vacated to the extent that it dismissed Rupp's Claims 1, 2, 4, 5, 7, and 11, and the matter is remanded for trial of those claims.
