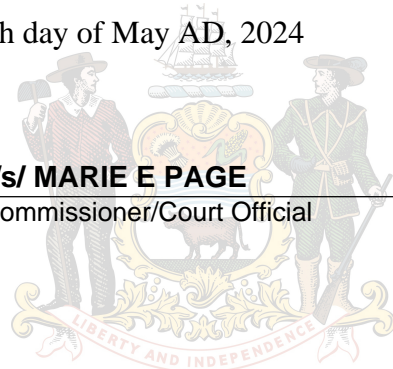

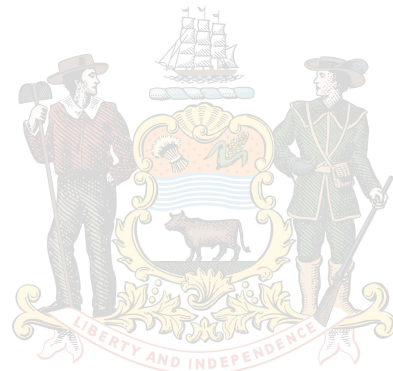

- 1.) Your Affiant is a duly sworn Police Officer with the University of Delaware Police Department and has been since September of 2022. Your Affiant is currently assigned to the Patrol Division.
- 2.) Your Affiant was on duty on Wednesday, May 8th 2024 at approximately 1634 hours. Your Affiant received a complaint which stated a female individual was currently damaging Holocaust Memorial flags near UD Memorial Hall. While destroying the flags, the female individual proceeded to spit on the flags.
- 3.) The display, which was approved by the University, is sponsored by the Hillel Student Life RSO in an effort to recognize Holocaust Remembrance Week. The display was identified as such by signs on the Green. The display consists of color-coded unmarked flags, each representing a group of people who lost their lives in the Holocaust.
- 4.) Witnesses at the location advised assisting Officers that the female individual stated "fuck the Jews" and "Jewish people are nasty, free Palestine", among other vulgar statements.
- 5.) These statements were heard by several witnesses on scene from multiple yards away.
- 6.) The female Individual was viewed by UDPD Dispatch on surveillance camera as the suspect involved with the destruction of the Holocaust memorial flags. Your Affiant responded to the scene and made contact with the suspect when she was walking away from the flag display. Your affiant confirmed her identity from her Pennsylvania Drivers License as Kandeel, Jenna M (DOB 01/25/2001 W/F/N).
- 7.) Kandeel advised your affiant that she was frustrated and triggered by the Holocaust memorial flag display and had intentionally damaged the flags out of frustration.
- 8.) Kandeel damaged approximately 10 Holocaust Memorial flags which costs approximately \$2 USD each.
- 9.) Kandeel commits the crime with the purpose of interfering with the victims free exercise of speech protected by the first amendment of the United States Constitution
- 10.) Your affiant prays an arrest warrant be issued for Jenna M Kandeel for the above listed charges.

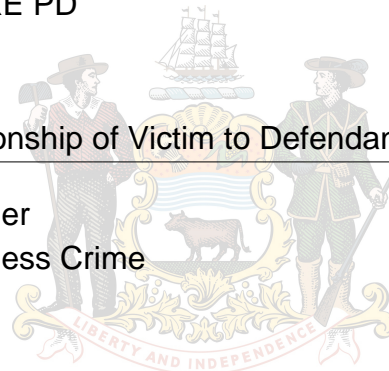
