Dear Dr. O'Connor,

I am writing today to request that you urge President Biden, in the strongest possible terms, to take a cognitive and neurological exam and to share the results with the American people. The deep public concern with President Biden's mental acuity is well known. Yesterday, in response to questions about the state of his mental fitness, President Biden said: "If my doctors tell me I should have another neurological exam, I'll do it." It has been reported that you have "never recommended [President] Biden take a cognitive test." You have an obligation to request that he take such an exam and share the results. Our national security, the welfare of the American people, and our country's standing in the world demands it.

My alarm about President Biden's capacity to lead our country is shared by 80% of the American public,<sup>3</sup> as well as by political leaders on both sides of the aisle. Influential members of the Democratic Party, including Governor Gretchen Whitmer<sup>4</sup> and Representative Adam Schiff<sup>5</sup> have also called on the President to take a cognitive test. Prominent physicians—including CNN Chief Medical Correspondent and neurosurgeon Dr. Sanjay Gupta—have made similar calls.<sup>6</sup> To date, at least seventeen Democratic members of Congress have urged President Biden to step down, and twelve more have expressed doubts about his viability as a candidate.<sup>7</sup>

These concerns are entirely justified in light of President Biden's recent public appearances, including his disastrous debate performance which has surely emboldened our enemies abroad as much as it has alarmed Americans at home. Concern is also justified in light of Special Counsel
