A BILL

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Stopping Transgender
- 5 Operation Payments and Wacky Expenses for Illegal Resi-
- 6 dents and Detainees Act of 2024" or the "STOP WEIRD
- 7 Act of 2024".

1	SEC. 2. PROHIBITING FEDERAL FUNDS FROM BEING USED
2	TO PROVIDE CERTAIN GENDER TRANSITION
3	PROCEDURES.
4	(a) In General.—Notwithstanding any other provi-
5	sion of law, no Federal funds may be used or otherwise
6	made available to provide or refer for a specified gender
7	transition procedure to an individual in the custody of the
8	Department of Homeland Security or the Department of
9	Health and Human Services or to reimburse any entity
10	for providing such a procedure to such an individual.
11	(b) Specified Gender Transition Procedure
12	Defined.—
13	(1) In general.—For purposes of this para-
14	graph, except as provided in paragraph (2), the term
15	"specified gender transition procedure" means, with
16	respect to an individual, any of the following when
17	performed for the purpose of intentionally changing
18	the body of such individual to no longer correspond
19	to their sex:
20	(A) Performing any surgery, including—
21	(i) castration;
22	(ii) orchiectomy;
23	(iii) scrotoplasty;
24	(iv) vasectomy;
25	(v) hysterectomy;
26	(vi) oophorectomy;

1	(vii) ovariectomy;
2	(viii) metoidioplasty;
3	(ix) penectomy;
4	(x) phalloplasty;
5	(xi) vaginoplasty;
6	(xii) vaginectomy;
7	(xiii) vulvoplasty;
8	(xiv) reduction thyrochondroplasty;
9	(xv) chondrolaryngoplasty;
10	(xvi) mastectomy; and
11	(xvii) any plastic, cosmetic, or aes-
12	thetic surgery that feminizes or
13	masculinizes the facial or other body fea-
14	tures of an individual.
15	(B) Any placement of chest implants to
16	create feminine breasts.
17	(C) Any placement of fat or artificial im-
18	plants in the gluteal region.
19	(D) Administering, supplying, prescribing,
20	dispensing, distributing, or otherwise conveying
21	to an individual medications, including—
22	(i) gonadotropin-releasing hormone
23	(GnRH) analogues or other puberty-block-
24	ing drugs to stop or delay normal puberty;

1	(ii) testosterone, estrogen, or other
2	androgens to an individual at doses that
3	are supraphysiologic than would normally
4	be produced endogenously in a healthy in-
5	dividual of the same age and sex.
6	(2) Sex.—For purposes of paragraph (1), the
7	term "sex" means the indication of male or female
8	sex by reproductive potential or capacity, sex chro-
9	mosomes, naturally occurring sex hormones, gonads,
10	or internal or external genitalia present at birth.
