During the morning hours, I telephoned Gabriel Vasquez. Mr. Vasquez admitted that he made the call to Carlos Solis that was construed to be a threatening-type call. He apologized and claimed at the time, he was very upset due to the condition of his friend Christopher Berry as listed in LCPD case #200504721. Mr. Vasquez assured me that he wished no ill-will on Mr. Solis and will not call or harass Mr. Solis in any way.

## U68 - BOWEN, ANDREW; CASE Narrative

ON MARCH 8, 2005 I RESPONDED TO THE NMSU COUNSELING CENTER IN REFERENCE TO A TELEPHONE HARASSMENT COMPLAINT. ON ARRIVAL I MADE CONTACT WITH CARLOS SOLIS. MR. SOLIS STATED THAT HIS ROOMMATE, CHRIS BERRY, WAS HOSPITALIZED AT MEMORIAL MEDICAL CENTER FOR AN ALCOHOL POISONING INCIDENT, LAS CRUCES POLICE DEPARTMENT CASE: 200504721. MR. SOLIS STATED THAT WHILE HE WAS IN DR. KAREN SCHAEFER'S OFFICE WITH HIS FRIEND ANDREW GALLEGOS, HE RECEIVED A PHONE CALL FROM A MALE SUBJECT. MR. SOLIS STATED THAT THE SUBJECT CALLED HIM SEVERAL BAD WORDS IN SPANISH, AND STATED IN SPANISH THAT HE WAS GOING TO KILL HIM AND BURY HIM. MR. SOLIS STATED THAT THE MALE SUBJECT SOUNDED LIKE HIS ROOMMATE'S SISTER'S BOYFRIEND WHO HE KNEW ONLY AS GABE. MR. SOLIS STATED THAT THE SUBJECT CALLED FROM TELEPHONE NUMBER, 522-4461.

DR. SCHAEFER STATED THAT SHE HEARD THE MALE SUBJECT YELLING ON THE PHONE, BUT COULD NOT HEAR WHAT HE WAS SAYING. MR. GALLEGOS STATED THAT HE HEARD THE MALE SUBJECT STATE THAT HE WAS GOING TO BURY HIM.
