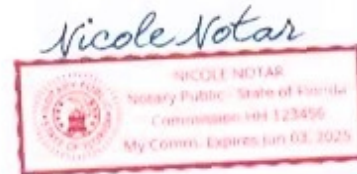

This letter serves as explanation of the employment of William Dennis Milstead. He is one of the States agents through the FDLE Official Off Grid Unit Officers meaning "Undercover Agent" that provides highly sensitive information regarding illegal activities investigated by The Florida Department of Law Enforcement. Due to the nature of the work he preforms his personal security would be at risk if leaked or falls into the wrong hands. For this reason information on his background and credit files are very limited and/or sealed and doesn't reflect his true ability to receive credit or pay his debts due to his involvement in FDLE Off Grid program. Please see the new dated background check attached that was ordered and preformed through this agency in recent days by "Certn A partner of the FDLE" it reflects a up to date background information list of criminal charges if he may of have in his file. The attached background dated 10/23/2024 is clear of any charges or convictions of any type other then minor traffic offensives, Although his credit score is under the recommended level that uses the .03 score platform used by the leading three credit bureaus, due to the fact our agents do not usually use their personal identity for personal security reasons do to the nature of their occupation. The FDLE keeps a close eye on its agents and I can certify that William Dennis Milstead is a very reputable individual and would be a great complement and a outstanding citizen to any community that he may reside in. As Asst Capt J.C. Addams and on behalf of the FDLE we can certify that there has been no complaints of his behavior or his ability to honor his commitments outside of his employment or file that came through my office. We also perform a yearly comprehensive State and Federal background / financial check on all of our agents, in the last twelve years his reports have always came back cleared for normal standards of the FDLE, since hes been under the supervision of the Special Agent / Off Grid Command Unit. William Dennis Milstead records show his employment started on October 4th 2006 with the FDLE, he entered the new formed Off Grid Unit in 2011 under my watch as the Asst Capt. The records shows William Dennis Milstead is three years shy of reaching his 20th year retirement, and eligible for his full state pension. His current yearly income is set to reach \$84,990 for the year 2024 at that time his contract will expire and be eligible to negotiate a new contract for the remainder of the three years.

We ask that you make a exception to limit the background / credit check on William Dennis Milstead due to the security needed to protect our agent safety and rely solely on this letter of recommendation from the FDLE and State of Florida. Credit and Background checks are easily obtain in the criminal world and could have negative consequences for the names listed or associated in these checks. We ask that any legal documents be made in the name of William Dennis Milstead along with his Social Security number for identification purposes. Any files, records, contracts of personal business information shall be forward by William Dennis Milstead to the Office of The Florida Department Law Enforcement to anyone of the state office locations within 5 days to be recorded and sealed into his personal file. In the event of any legal court proceedings being brought upon or filed in the name of William Dennis Milstead this office of the FDLE would provide complete access to any related files upon written notice within ten days of receiving such notice at the address listed above.

We appreciate your understanding and cooperation in the matter.
