Dear Senator Paul,

As law enforcement professionals dedicated to protecting the people of Broward County, we are deeply concerned about the current state of national security under the Biden Administration.

Over the past few years, we have witnessed firsthand the negative impact of failed policies, including open borders, the failure to enforce immigration laws, and the expansion of sanctuary cities. In southern Florida, we have seen an increase in migrant landings, which present a serious security threat.
