Detective Yousef Demes, Shield # 01575 of the Midtown North Precinct Detective Squad, states as follows:

*The defendant is charged with:*

- 1 PL 125.25(1) Murder in the Second Degree  
(defendant # 1 : 1 count)
- 2 PL 265.03(1)(b) Criminal Possession of a Weapon in the Second Degree  
(defendant # 1 : 1 count)
- 3 PL 265.03(3) Criminal Possession of a Weapon in the Second Degree  
(defendant # 1 : 1 count)
- 4 PL 170.25 Criminal Possession of a Forged Instrument in the Second Degree  
(defendant # 1 : 1 count)
- 5 PL 265.02(2) Criminal Possession of a Weapon in the Third Degree  
(defendant # 1 : 1 count)

On or about December 04, 2024 at about 06:44 AM, outside 1335 Avenue of the Americas; in the County and State of New York, the defendant, with intent to cause the death of another person, caused the death of such person; the defendant possessed a loaded firearm with intent to use it unlawfully against another; the defendant possessed a loaded firearm outside of his home and place of business; the defendant uttered and possessed a forged instrument of a kind specified in section 170.10 of the Penal Law and particularized below with knowledge that the instrument was forged and with intent to defraud, deceive and injure another; the defendant possessed firearm silencer ;

*The factual basis for these charges are as follows:*

I have reviewed surveillance video depicting the exterior of the Hilton at the above location, specifically a camera angle depicting 54th Street between Seventh Avenue and Avenue of the Americas. In the surveillance footage, at approximately 6:44 a.m., a man

wearing a distinctive clothing outfit (“the shooter”) approached Brian Thompson from behind, and then the shooter held what I recognized to be a firearm with a silencer attached at the end and fired it several times at Brian Thompson, causing him to collapse on the ground.

I am informed by Detective Oscar Diaz, shield #4656 of Manhattan South Homicide Squad, that he was present for the autopsy of Brian Thompson and that the cause of Mr. Thompson’s death was determined to be a gunshot wound to the torso.

The defendant is the person shooting and killing Brian Thompson in the above-described surveillance footage, based upon evidence collected during the investigation, including, but not limited to:

(i) surveillance footage that I have reviewed from the HI New York City Hostel at 891 Amsterdam Avenue which depicts the same man, wearing the same clothing, leaving the hostel on December 4, 2024, at about 5:34 a.m;

(ii) surveillance footage that I have reviewed from that same hostel that depicts the same man, checking in to the hostel on November 24, 2024, at about 11:20 p.m and showing a driver's license upon check-in;

(iii) I have reviewed business records from the hostel that showed that the man provided a New Jersey Driver’s License with the name of Mark Rosario on it;

(iv) I am informed by Detective Diaz that he is informed by Patrolman Tyler Frye, Badge #351 of the Altoona Police Department, that on December 9, 2024, at 09:58 a.m, defendant was taken into custody at the McDonald’s in Altoona, Pennsylvania, that defendant presented a forged New Jersey Driver’s License with the name of Mark Rosario as his identification, which based on the number on it was the same identification defendant presented at the hostel, and that in defendant’s belongings, Patrolman Christy Wasser, Badge #250 found a semi-automatic pistol with what appears to be a 3D printed loaded receiver with a metal slide and silencer, and written admissions about the crime.
