PETITION

COMES NOW, the City of Clarksdale (the "Clarksdale"), through its duly elected Board of Mayor and Commissioners (the "Board"), and files this Petition against Delta Press Publishing Company, Inc. d/b/a The Clarksdale Press Register, Emmerich Newspapers, Inc., Clarksdale Press Register (collectively "CPR"), and Floyd Ingram, the editor and publisher of the Clarksdale Press Register newspaper (the "newspaper), and in support thereof would show unto the Court, as follows:

1. Clarksdale is a municipal corporation organized and existing under the laws of the State of Mississippi and domiciled in Coahoma County, Mississippi.
2. CPR is a Mississippi corporation whose principal office is located at 246 Briarwood Drive, Suite 101, Jackson, MS 39206 whose registered agent is John Wyatt Emmerich located at the principal office of CPR or PO Box 16709, Jackson, MS 39236. Mr. Ingram is an adult resident citizen whose business address is at 128 East Second Avenue, Clarksdale, Coahoma County, Mississippi, an employee of CPR who is the editor and publisher of the Clarksdale Press Register newspaper owned by CPR in Clarksdale.
3. This Court has jurisdiction over the parties and subject matter pursuant to MISS. CODE

ANN. § 9-5-81 (Rev. 2002) and pursuant to Article 6 § 159 of the Mississippi Constitution of 1890.

4. Venue is proper with this Court as the subject matter complained of is online, in circulation throughout the state, and the principal harm complained of occurs within the boundaries of Hinds County.

5. On Tuesday, February 4, 2025 at noon, the Board held a duly noticed special-called meeting to discuss and pass a Resolution supporting local and private tax legislation before the deadline to submit proposed local and private bills to the Mississippi State Legislature.

6. The City Clerk, Laketha Covington, created the notice for the meeting and forgot to e-mail a copy of the notice to Mr. Ingram as she customarily does. (A copy of the City Clerk's Affidavit is attached hereto as Exhibit "A".)

7. The special-called meeting of the Board on February 4, 2025 was properly noticed by law, the doors to the meeting were open, and the meeting was streamed live online to the public through Mayor Chuck Espy's public Facebook page.

8. On Tuesday, February 4, 2025, between 2:13 p.m. and 2:17 p.m., Mr. Ingram came to the City Clerk's office and picked up the special meeting's Notice, Agenda, the Resolution, and the proposed local and private legislation from the Clerk at no cost and without need of making a public record request. During that time the City Clerk apologized or admitted that it was her fault that Mr. Ingram did not get the usual courtesy e-mail notifying him of the special-called meeting. Mr. Ingram also did not further inquire as to why he did not receive a notice before the meeting. Mr. Ingram further gave no indications or assertions to the City Clerk he believed any intended deception was afoot or notice to him was purposefully restricted. (A copy of the Notice, Agenda, the Resolution, and the proposed legislation is attached hereto collectively as Exhibit "B".)

9. On Thursday, February 6, 2025 and at 3:00 a.m. on Saturday, February 8, 2025, Mr.

Ingram respectively published in the newspaper and posted as free content to online properties owned by CPR an article with the title "EDITORIAL: SECRECY, DECEPTION ERODE PUBLIC TRUST." In the article Mr. Ingram stated Clarksdale failed "to go to the public with details" about the idea of the proposed legislation. Within the context of his title, Mr. Ingram also strongly stated or implied the reason he did not receive notice to the February 4, 2025 meeting was because the Board and its members received "kick-back," "just want a few nights in Jackson to lobby for this idea - at public expense," give "away candy at Halloween, toy giveaways at Christmas and hosting events where politicians can hand out goody bags to voters," and made the community "suspicious." His statements could be reasonably understood as declaring or implying that the "deceptive" reason he was not given notice of the meeting is provable through someone in the community willing to reveal promises made by Board members in exchange for votes or in the process of time. (A copy of the print and online articles (the "libelous editorial") is attached hereto as Exhibit "C".)

10. The efforts of the Mayor of Clarksdale to lobby for and push the proposed local and private legislation by meeting with legislators in Jackson, MS have been chilled and hindered due to the libelous assertions and statements by Mr. Ingram which are currently in the circulation newspaper and published to the online properties of CPR.

11. Also published in the February 6, 2025 edition of the newspaper, and merely an hour before the libelous editorial was published online, Mr. Ingram published a free article online reporting on the February 4, 2025 meeting of the Board without the libelous statements. (A copy of the prior article is attached hereto as Exhibit "D".)

12. Clarksdale and the Board verily believe that immediate and irreparable injury, loss or damage will result to Clarksdale, the Board and its members, and the public if the libelous editorial is allowed to be accessed, and an injunction would be without harm to the respondents and consistent with public interest.


WHEREFORE PREMISES CONSIDERED, Clarksdale prays as follows:

1. That this Court issue a temporary restraining order or preliminary injunction preventing CPR, Mr. Ingram, and their assigns, agents, and employees from continuing to make the article available to the public or paying clients on their online properties, personal pages, and/or print publications.
2. That after a hearing on this matter, this Court declare the libelous editorial as libelous and enjoin CPR, Mr. Ingram, and their assigns, agents, and employees from republishing the libelous editorial, recall any newspapers with the libelous article possible , and warn against future libelous statements.
3. That this Court grant any other such relief, up to and including monetary damages, attorney's fees, and the cost of litigation, it deems appropriate based on the Premises.



2. On Tuesday, February 4, 2025, I posted Notice of Special Meeting at approximately 8:00 a.m. on the door to City Hall at 121 Sunflower Avenue, Clarksdale, Mississippi for a meeting of the Board of Mayor and Commissioners of Clarksdale to be held at noon the same day.
3. As City Clerk for the City of Clarksdale, I customarily e-mail the media any Notice of Special Meeting around the same time I post it on the door of City Hal, however, I inadvertently failed to do so on Tuesday, February 4, 2025.
4. After the special meeting between 2:13 p.m. and 2:17 p.m. on Tuesday, February 4, 2025, Mr. Floyd Ingram, of the Clarksdale Press Register, came to my office and inquired about



the subject matter of the February 4, 2025 special meeting.

5. I observed that Mr. Ingram had something to write with and a notepad, but I told him that I would print all the documents for him and proceeded to do so without asking him to fill out a Record Request Form and without asking him to pay for the cost of printing.
6. I apologized for neglecting to send him the Notice of Special Meeting as I usually would have done and stated how busy I have been due to the upcoming elections.
7. I gave him a copy of the February 4, 2025 Notice of Special Meeting, the agenda of that meeting, the Resolution that was passed during that meeting, and the local and private legislation that was the subject of the Resolution.
8. Mr. Ingram expressed gratitude to me and I observed that he was smiling as he left.

RESOLUTION OF THE BOARD OF MAYOR AND COMMISSIONERS OF THE CITY OF CLARKSDALE, MISSISSIPPI DECLARING ITS SUPPORT OF LOCAL AND PRIVATE LEGISLATION ALLOWING THE CITY TO LEVY SALES TAX UPON THE GROSS PROCEEDS OF SALES AT CERTAIN BUSINESSES IN THE CITY FOR THE PURPOSE OF PROVIDING FUNDS TO SUPPORT AND PROMOTE PUBLIC SAFETY, CRIME PREVENTION, AND CONTINUING ECONOMIC GROWTH IN THE CITY; TO REQUIRE THAT AN ELECTION BE HELD ON THE QUESTION OF THE IMPOSITION OF SUCH TAX; AND FOR RELATED PURPOSES.

WHEREAS, the Board of Mayor and Commissioners (the "**Governing Body**"), acting for and on behalf of the City of Clarksdale, Mississippi (the "**City**"), hereby finds, determines, adjudicates and declares as follows:

1. Governing Body has determined the necessity to approve a referendum to go before the qualified electors of the City to impose a tax at a rate not to exceed two percent (2%) of the gross proceeds of retailers whose main purpose of business is to sell alcoholic beverage, hemp, marijuana, or tobacco to consumers.

2. Qualified electors will be allowed to decide whether to vote "FOR THE TAX" and, on a separate line, "AGAINST THE TAX" and the voters shall vote by placing a cross (X) or check (✓) opposite their choice on the proposition.

3. When the results of the election shall have been canvassed and certified, the City may levy the tax if sixty percent (60%) of the qualified electors who vote in the election vote in favor of the tax.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY, ACTING FOR AND ON BEHALF OF THE CITY, AS FOLLOWS:

SECTION 1. The Governing Body hereby requests that the Mississippi Legislature enact local and private legislation authorizing the City to call for a referendum to go before the qualified electors of the city voting in the election to decide whether to vote "FOR THE TAX" and/or on a separate line, vote "AGAINST THE TAX".


SECTION 2. This resolution shall become effective immediately and all resolutions and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, repealed.

LOCAL AND PRIVATE LEGISLATION

BILL NO. ____

AN ACT TO AUTHORIZE THE BOARD OF MAYOR AND COMMISSIONERS OF THE CITY OF CLARKSDALE, MISSISSIPPI TO LEVY SALES TAX UPON THE GROSS PROCEEDS OF SALES AT CERTAIN BUSINESSES IN THE CITY FOR THE PURPOSE OF PROVIDING FUNDS TO SUPPORT AND PROMOTE PUBLIC SAFETY, CRIME PREVENTION, AND CONTINUING ECONOMIC GROWTH IN THE CITY; TO REQUIRE THAT AN ELECTION BE HELD ON THE QUESTION OF THE IMPOSITION OF SUCH TAX; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISALTURE OF THE STATE OF MISSISSIPPI:

SECTION 1. As used in this act, the following terms shall have the meanings ascribed to them in this section unless otherwise clearly indicated by the context in which they are used:

- a. "Alcoholic beverage" means any alcoholic liquid, including wines of more than five percent (5%) of alcohol by weight, capable of being consumed as a beverage by a human being, but shall not include light wine, light spirit product and beer, as defined in Section 67-3-3, Mississippi Code of 1972, but shall include native wines and native spirits. The words "alcoholic beverage" shall not include ethyl alcohol manufactured or distilled solely for fuel purposes or beeper of an alcoholic content of more than eight percent (8%) by weight if the beer is legally manufactured in this state for sale in another state.
- b. "Board" means the Board of Mayor and Commissioners of the City of Clarksdale, Mississippi.
- c. "City" means the City of Clarksdale, Mississippi.
- d. "Hemp" means the plant *Cannabis sativa* L. and any part of that plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, salts and salts of isomers, whether growing or not, with a delta-9-tetrahydrocannabinol

(THC) concentration of not more than three-tenths percent (0.3%) on a dry weight basis that is grown or processed.

- e. "Hemp product" means a finished product that is intended for human consumption, contains any part of the hemp plant, including naturally occurring cannabinoids, compounds, concentrates, extracts, isolates, or resins, and contains less than three-tenths percent (0.3%) of THC.
- f. "Marijuana" means all parts of the plant of the genus *cannabis*, the flower, the seeds thereof, the resin extracted from any part of the plant and every compound, manufacture, salt, derivative, mixture or preparation of the plant, its seeds or its resin, including whole plant extracts. Such term shall not mean cannabis-derived drug products approved by the federal Food and Drug Administration under Section 505 of the Federal Food, Drug, and Cosmetic Act.
- g. "Person" means any individual, company, corporation, partnership, association, joint venture, estate, trust, or any other group, or combination acting as a unit, and the plural as well as the singular, unless the intention to give a more limited meaning is disclosed by the context.
- h. "Retailer" includes every person whose principal business is that of selling merchandise at retail, who shall sell, or offer for sale any alcoholic beverage, hemp, marijuana, or tobacco to the consumer.
- i. "Sale" means an exchange for money or goods, giving away, or distributing any alcohol, hemp, marijuana, or tobacco as defined in this chapter.
- j. "Tobacco" means any cigarettes, cigars, cheroots, stogies, smoking tobacco (including granulated, plug cut, crimp cut, ready rubbed, and other kinds and forms

of tobacco, or substitutes thereof, prepared in such manner as to be suitable for smoking in a pipe or cigarette) and including plug and twist chewing tobacco and snuff, when such "tobacco" is manufactured and prepared for sale or personal consumption. All words used herein shall be given the meaning as defined in the regulations of the Treasury Department of the United States of America. The term "tobacco" also includes heated tobacco products such as products that contain tobacco that produces an inhalable aerosol by (i) heating the tobacco without combustion of the tobacco or (ii) heat generated from a combustion source that only or primarily heats rather than burns the tobacco.

SECTION 2. (1) For the purpose of providing funds to promote public safety and continuing to promote economic growth in the city, the Board, in its discretion, may levy, assess and collect from every person, firm and corporation operating a retail establishment licensed to sale tobacco, hemp, marijuana, or alcohol, in the city, a tax which shall be in addition to all other taxes and assessments imposed by the city, as provided in this act.

(2) The tax shall be imposed upon every person, firm or corporation operating as a Retailer in the City, at a rate not to exceed two percent (2%) of the gross proceeds of the sales of such Retailer.

(3) Persons liable for the tax imposed pursuant to this act shall add the amount of tax to the gross proceeds from sales and shall collect, insofar as practicable, the respective amount of the tax due by him from the person receiving the products at the time of payment for the products.

(4) The tax shall be collected by and paid to the Department of Revenue in the same manner that state sales taxes are computed, collected and paid; and the full enforcement provisions and all

other provisions of Chapter 65, Title 27, Mississippi Code of 1972, shall apply as necessary to the implementation and administration of this act.

(5) Except for any amount retained by the Department of Revenue under Section 27-3-58, Mississippi Code of 1972, the proceeds of the tax shall be paid to the city on or before the fifteenth day of the month following the month in which they were collected.

(6) The proceeds of the tax shall be deposited into the general fund of the city and may be expended for any purpose authorized by law for expenditures of city general fund money, including the purpose of carrying out the programs and activities of the commission under the provisions of this act; however, accounting for receipts and expenditures of the proceeds of the tax shall be made separately as provided.

SECTION 3. Before any tax authorized under this act may be imposed, the Board shall adopt a resolution declaring its intention to levy the tax, setting forth the amount of the tax to be imposed, the date upon which the tax shall become effective and calling for an election to be held on the question. The date of the election shall be fixed in the resolution. Notice of such intention shall be published once each week for at least three (3) consecutive weeks in a newspaper published or having a general circulation in the City, with the first publication of the notice to be made not less than twenty-one (21) days before the date fixed in the resolution for the election and the last publication to be made not more than seven (7) days before the election. At the election, all qualified electors of the City may vote, and the ballots used in the election shall have printed thereon a brief statement of the amount and purposes of the proposed tax levy and the words "FOR THE TAX" and, on a separate line, "AGAINST THE TAX" and the voters shall vote by placing a cross (X) or check (✓) opposite their choice on the proposition. When the results of the election shall have been canvassed and certified, the City may levy the tax if sixty percent (60%) of the

qualified electors who vote in the election vote in favor of the tax. At least thirty (30) days before the effective date of the tax provided in this section, the Board shall furnish to the Department of Revenue a certified copy of the resolution evidencing the tax.

SECTION 4. Before the expenditure of the proceeds of the tax authorized by this act, a budget reflecting the anticipated receipts and expenditures shall be approved by the Board. The first budget of receipts and expenditures shall cover the period beginning with the effective date of the tax and ending with the end of the City's fiscal year, and thereafter, the budget shall be on the same fiscal basis as the budget of the City.

SECTION 5. Accounting for the receipts and expenditures of the funds derived from the proceeds of the tax authorized by this act shall be made separately from the accounting of receipts and expenditures of the general fund and any other funds of the City. The records reflecting the receipts and expenditures of these funds shall be audited annually by an independent certified public accountant and the audit shall be included in the General Purpose Statement of the City. The audit shall be made and completed as soon as practicable after the close of the City's fiscal year, and copies of the report of the audit shall be filed with the clerk of the Board. The expense of this audit may be paid from the funds derived pursuant to Section 2 of this act.

SECTION 6. This act shall be liberally construed for the purposes prescribed herein, the power granted by this act shall be deemed to be full and complete authority for the imposition and collection of the tax and the expenditure of the proceeds thereof and shall be construed as additional, cumulative and supplemental to any power granted to the City by any general or local and private act of the Legislature.

SECTION 7. This act shall take effect and be in force from and after its passage.

Our View

Secrecy, deception erode public trust

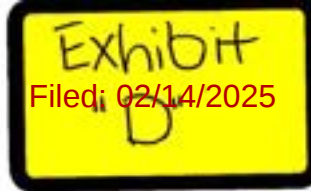

CLARKSDALE SENDS 2-PERCENT 'SIN' TAX LEVY TO JACKSON FOR APPROVAL

The Clarksdale Board of Mayor and Commissioners met in a quickly called meeting this week and approved a resolution seeking to levy taxes on all purchases of alcohol, hemp, marijuana and tobacco in the city.

The idea has been discussed repeatedly by the board and the concept covered by your *Clarksdale Press Register* at least twice, but it wasn't until the Tuesday, Feb. 4 meeting that details of the plan to levy a 2-percent tax were made public.

Tuesday's meeting was held at noon and posted on the door of city hall. The notice said the special called meeting followed state law and the media would be notified. The *Clarksdale Press Register* was not notified of that meeting.

The meeting saw commissioners, on a motion by Ward 1 Commissioner Bo Plunk, a second by Ward 2 Commissioner Jimmy Harris and unanimously supported by Ward 3 Commissioner Willie Turner and Ward 4 Commissioner Ed Seals, approve the resolution that now heads to Jackson for review by the Mississippi Legislature.

If the resolution becomes law, a referendum would be held in the city to approve the levy and would have to pass by 60-

percent of the votes cast.

The resolution asks that a 2-percent tax be levied on top of an 11-percent tourism tax for alcohol served or purchased anywhere in Clarksdale. The new levy will add 2-percent to the purchase of tobacco, hemp or marijuana in the city limits.

The initial idea was for the levy to go strictly to the Clarksdale Police Department to hire officers, but language in the resolution states “funds (will) support public safety, crime prevention, and continuing economic growth in the city.”

Espy said in Tuesday’s meeting the deadline for submitting such legislation is next week and he would go to Jackson and help work the measure through the Mississippi House and Senate.

City Board attorney Melvin Miller said the language in the measure has been vetted by Butler & Snow and should pass any constitutional challenge.

The language for hemp and marijuana were added to tax any cannabinoid extracts, powders or salts and the sale of marijuana from a medical marijuana dispensary.

While cannabinoid products have been sold in Clarksdale for years, the city does not have a medical marijuana dispensary at this time. The city had requests to allow at least two

medical marijuana dispensaries on South State Street/Old Highway 61 more than a year ago, but the businesses have been held up by state regulations.

In July the city voted to allow police and sheriff's deputies to work side-by-side to bolster a need for law enforcement personnel in both departments. The community had just notched it's 13th homicide and would end 2024 with 21 officially reported homicides.

Clarksdale PD currently has two investigators assigned to the Criminal Investigation Division and has 23 sworn officers on its roster. The Coahoma County Sheriff's Department has about two dozen officers.

The Sheriff's Department had the number of sworn officers plummet after 2023 county elections made Mario Magsby Sheriff and saw him hire his own officers. In 2021 the Clarksdale Police Department saw its workforce dwindle after the city hosted a rally as part of Black Lives Matter events across the country denouncing police brutality and telling authorities not to use force against the populace.

In June 2021 the city passed a number of measures seeking to reduce how officers respond with force in Clarksdale. The city's Human Resource officer Tara Slack has had virtually no luck in recruiting or attracting officers to the Clarksdale Police Department.

The Clarksdale Police Department is paying fulltime veteran officer up to \$44,122 a year. Part-time officers can make \$18

an hour.

The annual compensation for Mayor went from \$86,421 to \$122,421.92 and Commissioner went from \$26,650 to \$46,650 on the city first meeting in June 2021.

The Clarksdale Police Department was once budgeted for budgeted for more than 40 police officers.

Since the resolution by the city must first be approved by the legislature, no date has been set for a referendum. The resolution does ask that the tax go into effect immediately upon approval by Clarksdale voters.

The tax would be collected, monitored and enforced by the Mississippi Department of Revenue with the city getting checks from the state based on confirmed collections.
