did, on February 11th, 2025, commit the following criminal offense in the Town of Mooresville, Morgan County, Indiana, in violation of Indiana law, to-wit;

INTIMIDATION.....LEVEL 5 FELONY

This probable cause is based upon the following facts and circumstances based upon my personal knowledge:

On Tuesday February 11th 2025 at approximately 19:00, I was contacted by Morgan County Sheriff's Department Detective Sergeant Joshua Sparrow about a potential threat tip.

I was told that the FBI's Sandy Hook Tip Line had contacted Sergeant Sparrow about a potential threat to the Mooresville High School. This tip included the following information:

Tipster stated that their friend is planning a shooting in Indiana on the 14th of February.

Tipster stated that has access to an AR15

and has just ordered a bulletproof vest. Tipster stated that this offender admires Nicolas Cruz. Tipster stated that the offender stated that he will kill his best friend [REDACTED] first.

Snapchat: jgull199
Discord: crazynickolaz

The person was named as "Jamie", an 18 year old 12th grader who is trans gender. Tip ID: 3007C761

The FBI did an emergency preservation request on the Snapchat profile of jgull199. The profile had a phone number listed as [REDACTED]. The FBI did an exigent ping status with AT&T regarding this phone number and it came back to within 1553 meters of the following coordinates:

This is at Locust Lane and Trinity Way in Mooresville, Indiana.

The following messages between a "Jamie" and a "TCC Mama" were provided with the tip to the FBI from a chat application called Discord:

01/12/2025 18:29

Jamie: Yeah.

I'll be honest. I'm close to shooting mine up. I have an AR-15.

TCC Mama:

Dman OMD that's so cool!!

But wait, do you have a solid plan??

Jamie:

Parkland part two. Of course. I've been planning this for a YEAR.

TCC Mama: You don't plan on killing yourself right??

Jamie: No.

TCC Mama: Okay good Your secret is safe with me bro. Kids are awful And if you do carry it out good luck.

On February 7th 2025, Jamie has a conversation with someone called "Sasha" on Discord:

Jamie sends a link with a photo of ten Magpul AR15 magazines to Sasha and also says "I'm also buying a bulletproof vest". Jamie then sends a link and a photo to a bulletproof vest and says "Like this".

TCC Mama: "Youre gonna look great vro"

Jamie: And like Ar's fire 60 ammunition at a time.

Another conversation occurred with someone named "ERIC!"

Jamie: GUYS BEST NEWS ME AND [REDACTED] ARE GOINNG TO HAVE A SLEEPOVER??
[REDACTED] MY CRUSH. ([REDACTED] was named earlier as a potential victim)

February 7th 2025 16:25

Jamie: I'm taking [REDACTED] with me.

TCC Mama: [REDACTED]

Jamie: My boy best friend.

TCC Mama: I dont mean to sound really dumb but what do you mean youre doing it?

Jamie: The shooting.

TCC Mama: Ah okay and you're still doing the 14th?

Jamie: Yeah

TCC Mama: So is he going to be joining you in the shooting or do you plan on killing him too?

Jamie: I'm shooting him.

TCC Mama: And yourself?

Jamie: No.

February 10th 2025 21:10

Jamie: 4 More days.

TCC Mama: Yeah

Jamie: I have THIS staring at me

(Jamie sent a photo collage of what appears to be Dylan Roof, a known mass shooter)

Jamie: HE'S ALWAYS THERE.

Jamie also sent images of AR15 Rifles.

The FBI sent Discord an emergency disclosure request and received the following information:

The user name for Jamie was "Crazy Nikolaz".

They received an IP address to this Discord account as 172.56.248.144. This IP Address was ran by the FBI and it came back to Comcast. The FBI filed an EDR with Comcast and they informed them that the IP came back to the target phone number [REDACTED] listed at [REDACTED], Mooresville Indiana.

On February 11th 2025 at approximately 15:00, a student identified as Trinity Shockley asked to speak with a school counselor at the Mooresville High School. She spoke with counselor Laura Mikesell at this time. Trinity's date of birth is 10/26/2006 and she identifies as transgender. Trinity wanted to speak with Miss Mikesell about some ongoing issues and ended up disclosing to her that she was sexually attracted to Nikolaz Cruz, the Parkland School Shooter. Trinity spoke about how she wanted to have multiple children with Nikolaz and that she has already named the children. Trinity told Miss Mikesell that she has written to Nikolaz several times while he has been in prison. Trinity also showed Miss Mikesell a heart locket necklace with Nickolaz Cruz' photo inside.

After speaking with school administrators, it was discovered that Trinity's best friend is [REDACTED]

Trinity has expressed an obsession with a school shooter, the GPS coordinates for an emergency cell phone ping places her address within 1500 meters of the ping, and her best friend is named [REDACTED]. Her address is [REDACTED] and her listed phone number is [REDACTED]. She has sent photos of rifles, magazines, tactical vests, and photos on her wall depicting a known mass shooter and has said that she is going to execute a school shooting on Friday,

February 14th.

Trinity Shockley resides at [REDACTED] with her father, Timothy Shockley. [REDACTED] is an apartment complex at the corner of North Indiana Street and County Line Road. The apartments are in an [REDACTED] formation and face to the North and to the East. They have red, black, and tan bricks with brown shingles. The apartments are segmented into four per building and are multi level. Trinity's apartment is the first building on the Southside and the first apartment on the top level to the right.

On Wednesday February 12th, 2025 I executed a search warrant from Superior Court Three for the right to search the residence at [REDACTED]. I was assisted by the Morgan County SWAT Team at this time. The Morgan County SWAT Team utilized a surround and call out method and successfully extracted Timothy Shockley, his girlfriend Erika, his son, and Trinity Shockley. Trinity was transported to the Mooresville Police Department by Officer Ballard at this time where she was placed in a secure interview room.

I then executed the search warrant along with Mooresville Consolidated School Corporation Police Chief Brian Chambers and Mooresville Police Department Sergeant Brian Anderson. I observed in Trinity's bedroom some photos on the wall depicting Dylan Roof that matched the collage on Discord. I also knew that this was Trinity's room because it contained all of her belongings and her school backpack. There was a collage on the wall of Dylan Roof, Nickolas Cruze, and Andrew Blaze. All three of these men were known for mass killings. I took these photographs down and collected them as evidence at this time.

There was a poster for a movie called "Zero Day". This movie is about two boys who conduct a school shooting. I removed this poster and collected it as evidence. There was also a poster of who I believe to be Dylan Roof. This poster was collected as well.

On a bookshelf there was a framed photo of who I believed to be Dylan Roof. This frame and photo were collected. Above the light switch was a photo of Nickolas Cruze. This photo was collected.

I located an open laptop on a chair in front of Trinity's bed. The laptop was placed in airplane mode for collection. While placing the laptop in airplane mode it was observed to have a wallpaper of Nickolas Cruze at trial. Another laptop was located in the closet. It was collected. Finally, a Mooresville Schools issued Chromebook was found in Trinity's backpack. This Chromebook was placed in airplane mode and collected.

I also collected an iPhone that was located on the bookshelf and an iPhone that was on the top shelf of the closet.

On Trinity's backpack I observed three safety pin style buttons. Each button depicted one of the three murderers listed above, Dylan Roof, Nickolas Cruze, and Andrew Blaze. These buttons were collected as evidence.

A photo album depicting known mass shooters, including the above three, was collected from a bookshelf near the bed.

In Timothy Shockley's room I found a few AR-15 magazines and a box of (50) .40 caliber rounds. These were collected along with a soft armor vest that was located in the front room closet.

Inside Trinity's backpack was located three notebooks. Each notebook depicted swastikas, the words "kill", "bang", "I hate you all DIE DIE DIE" among other obscenities.

The following are excerpts from Trinity's notebooks:

12/16/2024

My name is Dex I am eighteen years old. Born on October 26th 2006. I currently live with my father, my mother passed away. I am aslo a transgender male. I have a lot of homicidal thoughts. In all honesty, I want to be just like Elliot Rodger. He is my main influencer along with Nikolas Cruz. These thoughts never seem to stop, you may believe that I am some edgelord, but in reality I am just a loser. I am grateful for my chance to live but in reality, I am scared of living. Is it the government you ask? No. It is this sad reality of living with piece of shits waste of life. I hope whoever reads this takes acknowledgment and maybe use it for your massacre. :)

I will be back to write again, xoxo Dex.

12/17/2024

Why is it so depressing here? Why must I be so easy to target? I dont really focus on them as much but still bothers me how entitled people can be. I dont hate everyone here but majority of them are all a wast of life. Back in twenty twenty two I was relentlessly a victim of bullying. They would ask me stupid questions send me rape threats, threaten to hurt me. I hate all of them so much but at the same, I like some.

Part two of taoday, Tuesday 17 2024. It is 1:54 PM So far today has been weird. SOMone had accused me of becmoing a school shooter. Ha! No, I almost was. I am committing what Elliot Rodger has done. A mass Shooting. A stabbing. Time will come. Sig Sauer, AR-15, automatic semi pistol is what Elliot Rodger used.

Hail Elliot Rodger!

Supreme Gentleman!

January 9th 2025

I am death, destroyer of worlds.

Everyone at my school hates the environment.

I do too, why must it be so stressful & boring?

I want to hurt others.

All of these minorities are useless.

I bleieve others dont desreve to live.

Everyone lives to die.

I am a loser.

Ethan Crumbley, Dylan Roof, Nikolas Cruz.

Nikita Lytkin.

My favorites

Fuck you all

We'll all be laughing

when you die!

I hate you all DIE DIE DIE!!

I miss Ethan. We were the same, born 2006, same eyes. Boom!

January 13th 2025

These thoughts wont stop. I want to hurt others. All of the time!

I want to hurt others. I wish people around me knew about my bad thoughts. I love violence. I love Ethan Crumbley and Nikolas Cruze. Becoming the worst

version of myself hurts me but this needs to be done. You all need to be burnt out, killed, wiped away from humanity. Right now, I want to pull out a AR-15.

Jamie Jan 22

I cannot stop thinking about Nikolas. It's impossible why must he be so far away? Why must of he done it? I love you Nikolas, you remind me of Lana Del Rey. There are days that I'll cry about you. My forever boy. You're a lovely soul from a broken home. I will always love you, no matter what, my darling.

Monday February 3, 2025

Recently, I have been watching and reading about Alyssa Bustamantae. She killed her neighbor, Elizabeth Olten, whom was nine. She strangled, slit her throat, then stabbed her twice. Why? She wanted to know the feeling of what it felt to kill. I undestand it, too. I want to stab someone too.

I (heart) ALYSSA BUSHAMANTAE.

February 3

Everyday

I want to hurt.

Everyday.

I hate living.

Everyday.

I hate myself,

make it stop!

Am I okay?

Am I alive?

An I here?

Replaceable!

I want to cut,

I deserve pain,

Nothing else.

February 5

Why can't Nikolas be mine? I need him in my life. I mentally cannot go a day without him. It is very difficult not to look at his face. He's so lovely and I can always understand him. He has taught me a bunch of things about guns. Zero in rifle is a term that he had taught me. An AR-15 is a semi automatic rifle.

ETHAN CRUMBLEY IS MEANT TO BE FREED DUE TO HIS IGNORANT PARENTS

February 14 2018

17 people lost their lives to a school shooting. Nikolas Cruz, 19. A former high school drop out dropped fine.

According to Snapchat and Discord, Trinity sometimes refers to herself as "Jamie" as depicted in these journal entries.

Ethan Crumbley and Elliot Rodger are also known murderers.

Detective Lindsay Hayden spoke with Trinity Shockley at the Mooresville Police Department. The following is the report written by Detective Hayden:

On February 12, 2025, I made contact with Trinity Jade Shockley at the Mooresville Police Department interview room. I provided Trinity with a copy of the Mooresville Police Department Advice of Rights and informed her of her Miranda Rights. Trinity advised that she understood and wrote her initials on

the line for Yes. I then read to her the Wavier of Rights portion of the form. Trinity signed the form to answer questions.

Trinity informed me that she believed she was talking to me because of her dad's girlfriend. Trinity believes that she has a warrant for her arrest. Trinity advised that her phone number is [REDACTED]. Trinity stated that school is okay and that she does not have many friends. She keeps a close circle of friends. Trinity wants to be in the FBI and is planning to attend Ivy Tech for Criminology after she graduates in three months. She plans to move in with a friend named Katie Brown from Huntington, Indiana. They used to attend school together. Trinity just started a job at Subway.

Trinity advised that she went to school on 2/11/25. She had a breakdown while at school because her mother had recently passed away from a drug overdose. She skipped two classes at the end of the day. Trinity has a metal health class for 5 period. She wanted to talk to the Teacher after class and the teacher said she would get later to talk. The teacher was not available during 6 period, so Trinity went to the guidance office instead. Trinity talked to her counselor, Laura Maisel about her breakdown and her mother. Trinity also told Laura that she was scared about her future. Trinity told Laura about her investigations into mass murders. She wanted to understand them more, so she watched them a lot. Trinity talked about her dad and missing him. Her dad is not very affectionate, but she did not cry about it.

Trinity is interested in mass murders and the mind set of them. She will study them in the interview room and watch their movements when no one is in the room. Trinity stated that they were not nervous, but she is nervous during her interview. She said that while watching the interview with Nicholas Cruz, he was emotionless when talking about his victims. Nicholas Cruz was nervous but did not care at the same time. When listening to Cruz, it would make her feel something in her hearing about what he did. She hated him for what he did and at the same time she understood what he did. Cruz wanted to ruin Valentine's Day and ruin the families because he did not have his own. She can relate to that because of the loss of her mom and people talking about their moms.

Trinity stated that she uses TikTok, Messenger, Twitter, Spotify, Instagram, Red Note, and Discord. Her username on TikTok is crazynicholaz. She talks to online friends on Discord about True Crime and Nichloas Cruz. Trinity stated that she does not idolize but does find him very attractive. Trinity stated that it is not a crime to find someone attractive, but she does not like what he did. She argued with her ex on Discord. She stated that she does not like Valentine's Day. She does not understand the meaning of the holiday. She does not know what her Discord account is. Trinity would talk about hurting people and she would lie about it because of the rage that she feels. Trinity says she does not mean it at all. Trinity would say that she was going to bring a knife to school, but she would not do that.

Trinity stated that she was joking and said that she wanted to shoot the school up. She advised that she would never do that and does not have access to a gun. She stated that she wanted to recreate with Cruz did, but she would never do anything like that. It was said out of rage. She is trying to get help with it. Wanted to be in home school because of how bad the thoughts got but her dad would not let her.

Trinity talked to username Tccmama on Discord about killing herself but that she would not that. Trinity stated that she did not have an AR 15 and was

joking when she said that to Tccmama. Trinity does not know her real name. She does not have a firearm, but her dad has one in his car. He takes the gun away from her. Trinity stated that she sent the messages about a day ago. Trinity did have a plan, and it was going to be similar to other school shootings. She was going to go into the school and wait. Trinity was going to come outside at lunchtime and do it. She advised that she was going to wait for lunch because it was the most people coming out. She was going to do this on Valentine's Day. She had planned to use an AR but would have trouble holding one. Trinity did not recall if she had a list of people she wanted to shoot. She stated that she would take [REDACTED] with her because he was her crush, and it made sense that he would die. She wanted them to die together.

Trinity stated that she was not the only one that was going to do this, and Rachel was going to help her execute the plan. Rachel is from Texas, and she was going to come to Indiana. Trinity has Rachel's address on her phone. She was supposed to execute the plan last year in the fall. They talked on Instagram, and she found her on TikTok. Rachel blocked her on social media, and she has not talked to her in a couple of days. She cannot remember if anyone else was going to do it with her. Trinity had written down her plans on her phone on the Notes. Trinity stated that she had a notebook in her backpack with things written in it.

Trinity's motivation for making the plan is Cruz. She wanted to prove that she is his number one fan. Trinity has an emotional attachment to Cruz. Her message behind the plan is that she does not like people who think they are better than everyone else and people should value their everyday life. You never know and you could die at any minute. Trinity could see herself in court after executing her plan, but she did not like it. When she saw all the police officers, it hit her that she did not want this. She does not want to be escorted to a cop car after doing that. Trinity did not want to go to court and listen to all the stuff.

When asked about a firearm. She stated that she was going to save up money but she thought about on 2/10/25, she changed her mind. She now wants to be a gun activist to help people get out of that mind set. She is slowing trying to get herself out of that mindset of wanting to do that. Trinity wishes that she would never think about that kind of stuff but ever since the bullying happened to her it was hard on her. She hates herself for thinking that way. She would feel too much guilt about it.

Trinity advised that she was bullied about the accident that she had. People would tease her, and she has anger issues. Trinity used to cut herself in the past because of anger issues. She is bipolar like her mother. It made her feel like if she was in a room with them, she would hit them. She could do that, and she would be in trouble. Trinity received threats from people for two years. She was in a very bad position. Trinity found out later that the male who struck her with his vehicle, committed suicide. She felt like she killed him, but she knows she did not. She blamed herself for him killing himself.

She stated that in her room she has shrines of Nicholas Cruz, Dylan Roof, Andrew Blaze and a poster of Zero Day. Zero Day is about a school shooting. Trinity knew that Dylan Roof killed 9 church goers, and it was racially motivated. Andrew Blaze was the one who did the supermarket shootings. He killed 3 people then himself. She watched the Cruz trial, and it lasted for 5 years. She likes the victims' families' statements. Trinity likes the judge in the case because she did not cry. Trinity watched another interview with Cruz,

where he stated that he was diagnosed with autism. Cruz stated that he did not understand fear, and because of that he shoots three girls over a dirty look. Trinity stated that he does not understand emotions and did not even cry when his mother passed away. Trinity stated that she related a little bit with Cruz. They have the same mental problems. She is not diagnosed with a lot of it, but she has traits of it. She advised that she planned her shooting around what Cruz. Trinity stated that she liked Cruz's plan. Trinity described what Cruz did at his shooting in detail. Trinity stated the names of the victims and how many people him killed.

Her friends at school for [REDACTED]. Trinity has friends in Huntington, [REDACTED]. She has another friend online, Rage or Rachel. Trinity stated that she has a sister who is not real sister, [REDACTED] from Canada. She stated that she was going to call the police on her because she was mad about it and was worried about her. Brannigan was trying to get help, but she begged her not too. [REDACTED] used to have the same thoughts but she does not anymore.

Trinity had looked up body armor because that is what Cruz had, and she wanted one as well. She was going to get it from a shop but does not remember the shop. It was a bullet proof vest. Trinity was looking at bullet proof vests about a week ago.

After talking to people online or talking to anyone things, she feels a sense of power to feel that way. She also stated that it is more of an interest thing because she dad was in the military. Trinity wanted one like him too.

END OF DETECTIVE HAYDEN'S REPORT

At the conclusion of the interview Miss Shockley was placed in hand restraints and transported to the Morgan County Jail by Officer Ballard in his issued squad car. She was remanded to the on duty jail staff without incident.

Detective Sergeant Josh Sparrow and ISP Trooper Detective Timothy Cummins went to 645 White Ash Trail to speak with 16 year old [REDACTED]. [REDACTED] was identified as a good friend of Trinity's and a possible target. The following is a paraphrase of their interaction with [REDACTED]. The interview took place at approximately 01:30 hours on February 12th, 2025 with his parents Michael and Bridget Kilgore present. Below is a summary of that interview:

[REDACTED] was informed that he was not in trouble and was asked whether he had any conflicts at school or if anyone might be upset with him. He stated that he could not think of anyone he had issues with. When specifically asked if he and Trinity (Jamie) had discussed any problems between them, he responded "no" and added that, to his knowledge, she was not depressed.

Note: Trinity also goes by the name of/or identifies as "Jamie"

[REDACTED] and his parents were then informed about the specific threat made by Trinity (Jamie), in which she expressed an intent to carry out a mass shooting at Mooresville High School, with [REDACTED] being one of the targets.

[REDACTED] stated that he had never been to Trinity's (Jamie) house and was unaware of her interest in past active shooters. He also confirmed that she had never

spoken to him about acquiring firearms, vests, or magazines. Their last text conversation took place around 21:00 hours on February 11th, 2025, and was about clothing.

██████ mentioned that he and Trinity (Jamie) had only recently started communicating and spending time together around mid-January and that they share a fifth-period health class. When asked if Trinity (Jamie) was upset with or wanted to harm anyone at school, he responded, "kind of" and elaborated that she disliked many people and generally hated everyone.

██████ eventually admitted that Trinity (Jamie) had made some comments in a text exchange regarding school shootings. Someone had told her that she would carry out a shooting, and ██████ told her she would never do that. She responded, "Yeah, I'm not that psycho," but added that if she ever did, she wouldn't target him. This conversation took place the previous week at school.

When asked if Trinity (Jamie) had ever requested his involvement in a school shooting, ██████ stated "no." He also reiterated that she had never sent him any images or references related to mass shootings or their perpetrators. Their primary mode of communication was texting, though they had occasionally interacted through TikTok and Instagram.

██████ expressed shock that Trinity (Jamie) had made a threat against him, stating that although she had previously mentioned the idea of a school shooting, he believed she was joking. He recalled her claiming to have an "AK" or "some type of gun" at her house but said she assured him she had no intention of using it.

██████ confirmed that Trinity (Jamie) had never asked him to store firearms, ammunition, or body armor at his house. With his parents' consent, his room was searched, and no firearms, ammunition, or body armor were found.

On Wednesday February 12th, 2025 I spoke with Vice Principal Zack Love and Counselor Laura Mikesell at the Mooresville High School. Both parties confirmed what was reported the night prior and no significant deviations from their account was noted. I also spoke with the head of mental for the Mooresville Consolidated School District, Emily Roscoe.

Miss Roscoe told me that Trinity has sought mental health resources from the school all the way back to when she was a freshman. She had expressed suicidal ideation in the past but nothing was significant enough to cause intervention. Each time Trinity would try to receive mental health assistance, her father, Timothy Shockley, would deny her the access to the resources. It was Miss Roscoe's understanding that Mr. Shockley did not believe in mental health treatment and did not take his daughter's conditions seriously. On November 12th, 2024, two weeks after her 18th birthday, Trinity signed herself up for mental health assistance.

For the foregoing reasons, I have probable cause to believe that the Defendant named herein committed the offense stated hereinabove.

(X) No arrest warrant need be issued. The Defendant has been placed in the custody of the Morgan County Sheriff. The Defendant

was placed in custody on February 12th, 2025.
