INITIAL NARRATIVE

Date: 04/02/2025 17:04

Officer: CORTEZ, EDUARDO

On 04/02/2025, at 1001 hours, I, Staley School Resource Officer E. Cortez, heard over the radio dispatch call out a stabbing call at David Kuykendall Stadium (6927-A Stadium Ln, Frisco, Collin County, TX). FPD call notes indicated that an athlete was stabbed. The suspect was reported as being a black male, wearing a grey hoodie and blue sweatpants.

I immediately left my office and ran across the Staley Middle School Parking (6927 Stadium Ln, Frisco, TX) lot towards a south west entrance into the stadium. As I entered the stadium, two high school age students informed me that the victim was on the north end of stadium by the bleachers under a Memorial High School tent (I did not identify these students). Next, I proceeded towards the north end of the stadium (visitors side) on foot. As I got closer to the north end, I could see the Memorial High School tent with multiple individuals under the tent. Once I arrived onto the north side bleachers, an adult male, who was on the track, pointed out the suspect (I was not able to identify that witness). The individual that was pointed out to me was a black male, wearing a grey hooded sweater and dark colored Nike pants. The suspect at this point was on the

track on the north end. There was a chain link fence that separated me from the suspect. I gave the suspect instructions to keep his hands up in the air. During this time, the suspect said verbally out loud, "I was protecting myself". It should be noted that I had not questioned him about the incident when he made that comment. I asked him if he had any weapons, and he said no. I patted him down for weapons while we were walking along the fence, and I did not locate any on his person. I instructed the male to continue walking along the fence, which he complied, towards an area where there was an opening in the fence that led off the track. While walking him off the track, the suspect also said "he put his hands on me". I then detained the suspect in handcuffs (hand cuffed behind his back) and had him sit down on the ground. Officer A. Ricci had arrived on scene at that time. I conducted another pat down of his person and then searched his person after he gave me consent, no weapons were located. While the suspect sat on the ground, I advised that I had the alleged suspect. The suspect then responds and says, "I'm not alleged, I did it".

Next, Officer Ricci and I walked the suspect to patrol vehicle #2412 (this is Officer A. Ricci's patrol vehicle), which was on the north east gate of Kuyrkendall stadium. As we were walking to the squad car, the suspect was emotional and said "He put his hands on me, I told him not too". I did not question the suspect about the incident while he was escorted to the patrol vehicle. I searched his person once again and I had him sit in the back seat area (driver side) of patrol vehicle #2412. While the suspect was in the back seat, I noticed fresh blood on his left middle finger. I verbally acknowledged that I saw the blood out loud so that it would be captured on my Body Worn Camera. It should also be noted that the suspect asked me "is he going to be ok" while he was in the back seat.

I then identified the suspect. He provided his name and date of birth verbally as Karmelo Anthony (b/m) with a date of birth of [REDACTED] which I ran through FPD Dispatch. Officer J. Hancock arrived on scene and remained with me and the suspect at this point. Karmelo was then checked via eschool (database for Fisd students) to also confirm his identity. The identifying information he provided matched the individual I had in custody (Karmelo Anthony). Next, I was advised by Sgt. Holland to transport the subject to the Frisco PD Jail. Officer Hancock and I transported him to the FPD Jail. Again, I did not question Karmelo about the incident.

Upon arriving at the Frisco Jail, Karmelo was escorted in the intake area. FPD Jail Staff changed him out into jail attire. I remained with the Jail staff the entire time that he was changed over. The clothes that Karmelo was wearing was placed in an FPD paper evidence bag. The clothes remained in my possession from this point on. Upon Karmelo being placed into a jail cell, I continued to keep possession of his clothes. I returned to my patrol #2412, along with Officer Hancock, which was in the FPD Salley Port and placed Karmelo's clothes in the back trunk area. I drove patrol vehicle #2412 out of the Salley port and parked the squad car in the FPD patrol parking area. Karmelo's clothes remained in the trunk area of vehicle #2412.

FPD Crime Scene Technician K. Dillard then took possession of Karmelo's clothes.

I added my body worn camera to the case. I have no further information to report.

Officer: RICCI, ALLYSON

On 04-02-2025, 1001 hours, I (Officer Ricci #3806) was wearing a full Frisco Police uniform, and I was operating a fully marked Frisco Police vehicle #2412. At about that time, I was dispatched to the report of a stabbing at David Kuykendall Stadium (8825 7th St, Frisco, Collin County, Tx). Frisco Police Dispatch advised an athlete had been stabbed. The suspect was described as a black male wearing a gray hooded sweatshirt and blue sweatpants. I responded Code 3 from the area of Eldorado Pkwy and Frisco St. I arrive on scene at approximately 1005 hours.

When I arrived on scene, I approached the track/ field area and saw Officer Cortez kneeling next to a black male wearing a gray hooded sweatshirt and blue sweatpants. The male, later identified as Karmelo Anthony (B/M [REDACTED]), was in handcuffs and was seated on the sidewalk by the entrance to the track. As I approached Officer Cortez, Officer Cortez stated Anthony was the alleged suspect. Anthony then made a spontaneous statement and stated, "I am not alleged, I did it." Officer Cortez conducted a PAT search of Anthony's person to ensure Anthony did not have any weapons and found nothing of evidentiary value. Officer Cortez and I then walked Anthony to my pre searched patrol vehicle and Anthony was seated in the rear driver side compartment of my patrol vehicle. While walking to my patrol vehicle, Anthony made another spontaneous statement and asked if what happened could be considered self-defense. I replied by telling Anthony I did not know what happened. It should be noted the in-car camera in my patrol vehicle was activated prior to Anthony being placed in my patrol vehicle.

While Officer Cortez assisted Anthony into my patrol vehicle, I noticed Anthony had blood on his left middle finger. I grabbed my department issued digital camera and took a photograph of Anthony's hands. I later uploaded the photograph to the crime scene folder under this case number.

Officer Cortez remained with my patrol vehicle and Anthony while I provided assistance with scene security. Nothing further from this Officer.

Officer: OATIS, WILL

On Wednesday, April 2, 2025, at around 1001 hours, Frisco Police Department officers were dispatched to Frisco Independent School District (FISD) David Kuykendall Stadium 6927 Stadium Lane # A, Frisco, Collin County, Texas in reference to a stabbing victim call.

Frisco Police Department emergency communications was receiving an emergency call regarding an athlete that was stabbed, the originally unknown assailant was a Black Male wearing a grey hoodie and blue sweatpants and also had a goatee and short hair. The subject was possibly wearing Centennial High School (Centennial) attire as it was believed he was a student there for the sporting event. This had all taken place on the visitor's side of the stadium (North side) and the victim was under the Memorial High School (Memorial) tent in the bleachers. At around this same time, School Resource Officer (SRO) Cortez arrived on-scene and began assisting the victim, trainers, and the other parties. Officer Cortez also advised on the radio that he also had the suspect.

Sergeant Oatis was working the 50's sector as the Sergeant, he was in full Frisco Police Department uniform with distinct patches and badge and a police duty belt. He was also in a marked Frisco Police Department patrol vehicle #2315. He was relatively close to the call and placed himself on it at around 1002 hours and responded to the call with his patrol vehicle's overhead emergency lights and sirens activated. He arrived to the call at around 1006 hours. Sergeant Oatis arrived to the stadium and began walking up to the location. At around this time, Officer Cortez and Officer Ricci were walking a Black Male subject (the suspect) away from the stadium. The suspect was crying hysterically. Please see the other involved officers' narratives for their involvement.

Sergeant Oatis walked up to the visitor bleachers and observed the victim being treated by Frisco Fire Department (FFD) personnel and also the athletic trainers. The weather began to turn and it began to heavily downpour rain, at this time, some of the FISD staff moved the Memorial tent to cover the victim and the FFD personnel. Sergeant Oatis began using his city-issued phone to snap crime scene photos to preserve as much of the scene as possible due to the weather and the large gathering of people that were involved in the incident. Other officers began to set up a crime scene with tape moving non-essential personnel out of the immediate area. The officers on-scene were informed that the knife that was used was tossed and was still believed to be somewhere close. Eventually, one of the witnesses said they remember seeing it on the bleachers still. Officer Shalz was able to locate the knife. It was located between rows 9 and 10 near seat 30 (closest to the aisle) partially open. The rain began to come down again heavily and it was determined that instead of moving the knife the officers would cover it with a large blue tarp.

Sergeant Oatis assisted in preserving the immediate crime scene as much as possible while the other personnel tended to the victim and eventually transported him. At around this time, Officer Wetzel had the crime scene log and began logging the individuals on the call to the best of his abilities. Lieutenant's Crawford and Pemberton relieved Sergeant Oatis of the scene. Sergeant Oatis went back to the police department to download his body-cam and the photos he took with the city-issued phone. Sergeant Oatis' city-issued phone had a total of 33 photos that were used to document the incident scene. During the download the initial photos formatting was incompatible with the crime scene folder. He re-downloaded the photos that he took and they were able to be saved properly for preservation of evidence.

At this time there is nothing further to add to this report.

On Wednesday, April 2nd, 2025, I (Officer T. Wetzel #3698), was assigned to work patrol in the City of Frisco. At approximately 1002 hours, I responded to the report of a stabbing at David Kuykendall Stadium located at, 8825 7th Street. The original call notes stated an athlete had been stabbed in the chest and that the suspect that stabbed the victim goes to Centennial High School. Athletic trainers were on site and were providing care to the victim and advised he was not conscious and not breathing. The notes also indicated that the suspect was a black male with a goatee and short hair wearing Centennial gear. I arrived on scene at approximately 1006 hours.

When I arrived on scene, I grabbed a roll of crime scene tape from my trunk and proceeded to the visitor's bleachers where dispatch advised the victim was. While I was walking towards the visitor's bleachers, I was approached by a witness who identified himself as, J [REDACTED] began telling me what happened, and I asked him where the stabbing occurred. [REDACTED] advised it happened under the Memorial High School pop up tent in the visitor's bleachers. I immediately informed Sgt. Oatis where the witness stated the stabbing occurred and gave him the crime scene tape to start securing the crime scene. I then had [REDACTED] move to the walkway under the visitor's bleachers out of the rain to further speak with me. The following is a summary of my contact with [REDACTED] [REDACTED] advised he was sitting under the Memorial High School pop up tent with his team and was near

the victim, Austin and the suspect, who was later identified as, Karmelo Anthony (b/m DOB: [REDACTED] Anthony was from Centennial High School and was sitting under the Memorial High School tent. Austin had told Anthony that he needed to move out from under their team's tent and Anthony grabbed his bag, opened it and reached inside and proceeded to tell Austin, "Touch me and see what happens." No one really thought Anthony really had any weapons in his bag and Austin proceeded to touch Anthony and then Anthony told Austin to punch him and see what happens. A short time later, Austin grabbed Anthony to tell him to move and Anthony pulled out what [REDACTED] recalled as a black knife and stabbed Austin once in the chest and then ran away. Austin began grabbing his chest and telling everyone to get help. [REDACTED] advised he did not know Anthony's name but stated another Memorial Track member, E [REDACTED] P [REDACTED] was friends with Anthony and he could identify Anthony. [REDACTED] described Anthony as a black male, skinny, with possibly a goatee, short puffy hair and wearing Centennial High School clothing. This concluded my contact with [REDACTED]

I then was instructed to start a crime scene log. I retrieved a crime scene log from my patrol vehicle and began starting the crime scene log. I was later relieved by Ofc. Shalz who took over the crime scene log and I cleared the scene.

Officer: HANCOCK, JERRY

Today, 4/2/2025, while working as the SRO at Independence High School, 10555 Independence Parkway, Collin County, a weapons call was dispatched over the air that detailed a stabbing occurred at Kuykendall Stadium in Frisco, Texas.

After hearing more dispatched call information, I drove to the scene. While enroute, I heard Officer Cortez say he as the suspect in custody. When I got on scene I looked for Officer Cortez and went straight to him to hold security with the suspect that he had cuffed and secure in the police squad. Multiple witnesses were providing statement to officers where the stabbing occurred at the Memorial HS track tent.

Only a short time later, Officer Cortez and myself escorted the suspect, Karmelo Sincere Anthony, to the Frisco adult holding facility. Anthony was transitioned off to the jail staff without incident. All jail paperwork was completed and CID took the investigation from there.

Officer: FISCHER, ALVIN

On Wednesday, April 2, 2025, at about 1005 hours, I Officer A. Fischer #3696 was dispatched to 6927 Stadium Ln #A, Frisco, Collin County, TX 75034, in regards to a stabbing. The notes stated an athlete had been stabbed in the chest, was unconscious, and not breathing.

When I arrived, the crime scene was already marked off and a suspect was in custody. I began asking people if they were witnesses to anything. I made contact with Hunter M [REDACTED] and then E [REDACTED] P [REDACTED] (B/M [REDACTED] they were both breathing heavily and crying due to the nature of events. They were with coaches on the field and it was pouring down rain. We made the decision to relocate to a locker room just to the east to get out of the rain. Once in there, things calmed a little bit however they were still hysterical and could not really talk. In there, I learned Hunter was the brother of the victim.

I attempted to ask them both what had happened. I could not really get anything out of Hunter, but [REDACTED] stated he wanted to speak. I asked him what happened, and he stated they were all sitting on the bleachers under a Memorial HS tent. When another male, who he did not know, walked over and sat under the tent. [REDACTED] then said Austin (the victim) told this male that since he did not go to Memorial he had to leave the tent. Austin and the male went back and forth and then Austin stood up and pushed the male to get him out of the tent. [REDACTED] had said during this time of arguing, the male was reaching around in his bag he had. It was at this time the male took out a knife and stabbed Austin and then left the scene. This was all [REDACTED] remembered when he talked to me.

After this, I then stood by with three athlete witnesses until CID arrived and interviewed them. I was then relieved by an SRO and went back to patrol.

Nothing further.

Officer: CRAWFORD, MIKE

On 04/02/25 at approximately 1000 hours, I, Lt. M. Crawford #3095, was dispatched to the Kuykendall Stadium at 6927-A Stadium Ln, , in Frisco, Collin County TX in reference to a stabbing call.

I arrived on scene and observed medical personnel and several bystanders standing next to a subject, later identified as the victim, Austin M [REDACTED]. The medical personnel were actively engaged in life saving measures with Mr. M [REDACTED]. I observed that a crime scene was created around the area and began collecting the names and contact information of the bystanders within the scene. I then met with Officer Wetzal and directed him to begin a crime scene log. As he was getting the needed paperwork, I took over his responsibilities of monitoring a witness (J [REDACTED]) to the event. Ultimately, the witness was taken to another area out of the rain and Officer Shalz took over the crime scene log and I forwarded information about the bystanders to him.

From that point forward, I worked with coordinating response from SRO, CID, CSI and PIO. I took no other action at the scene. My body worn camera did not activate when I initially arrived on scene, but I did activate it when I discovered it wasn't recording, while waiting with the witness. Nothing further.

Officer: SHALZ, JACOB

On Wednesday 4/2/2025 I, Ofc. Shalz was working as the SRO at the Student Opportunity Center. At approximately 1001 hours I was dispatched to a stabbing that occurred at David Kuykendall Stadium, located at 6927 Stadium Ln, Frisco, Collin County, Texas. It should be noted that my location is approximately 200 yards from the stadium.

Upon my arrival I tried to get an updated location of the suspect, I could not see Ofc. Cortez when I arrived. Ofc. Cortez informed over the radio that he had the suspect in custody. At this time I turned my attention to the victim. Multiple Fisd trainers were already performing CPR. I could see blood on and around the victim. At this time medics arrived and began life saving measures. I coordinated with other officers on scene to secure the location. By this time the students and Fisd staff had cleared the area. I used crime scene tape and began to tape off the area. It began to rain harder at this time Sgt. Otis and myself moved a Memorial HS tent over the medics and victim to attempt to preserve an evidence that we could. A Memorial coach approached me and informed me that he was with a student who claimed to see the entire altercation. I told the coach to stick with the student and that we would need to get him to the police station to give a statement. The student quickly informed me that he knew where the suspect threw the knife and pointed me to its location. I located the knife with Sgt. Otis and could see blood on the knife. I quickly used my city issued phone to take pictures before the rain could wash the blood away. Sgt. Otis located a blue tarp and we decided that we should cover the knife without touching it in an attempt to preserve any evidence. It was windy and raining hard. Once we positioned the tarp over the knife, I reached down and grabbed a backpack left in the stands to weigh the tarp down and threw it up by where Sgt. Otis was positioning the tarp. It was later discovered that the backpack I threw up onto the tarp was the suspects backpack. It was the only Centennial HS backpack located within all of the Memorial HS backpacks in that area of the stands.

After securing the scene with crime scene tape, and attempting to preserve as much evidence as possible I assisted other officers with locating other possible witnesses. Ofc. Wetzel was maintaining scene security while I was assisting the other officers, after the medics transported the victim I relieved him of that post so he could go back to patrol. I maintained scene security until the call was cleared. Photos will be uploaded to the crime scene folder and my body cam will be downloaded at the end of the shift.

On 4-2-2025 at approximately 1004 hours I Lt. K. Pemberton #3411 responded to 6927-A Stadium Ln Frisco (Collin County) Texas in response to a reported stabbing. This location is a school stadium.

Call notes advised a male had been stabbed and was unconscious. Upon arrival several officers and medical personnel were attending to the victim who was laying on the ground of the stadium bleachers. I coordinated the Frisco Pd response and trying to establish a crime scene. The knife reported to have been used in the assault was located by another officer in the bleachers. Shortly after my arrival, a large downpour of rain began. I directed several officers to use a tarp found at the scene to cover the location of the knife. I remained on scene until the victim was transported and the crime scene was established.

On 4/2/25 I responded to Texas Health Plano to assist with this case. I was tasked with meeting the ambulance at the hospital. I arrived prior to the ambulance and waited for them to arrive. They arrived at 1046 hours with the victim, Austin M. [REDACTED] who was brought into the trauma bay for treatment. At 1053 hours, Dr. Chao pronounced Austin deceased. Once he was pronounced, staff stopped treatment and disconnected cords and tubes from the machines without removing anything from the body its self. While on scene I took possession of clothing worn by Austin and maintained possession of the items until CSI Dillard took them from me.

While on scene Officer Landin requested assistance in lifting the sheets off the body to take photos. I then placed the sheets back when complete. I then stood by in the room for security while Officer Landin, Officer Hernandez and CSI Dillard took additional photos. At one point they rolled the body and removed shorts from Austin which were bagged and stayed in my custody until CSI took them. At 1324 hours, family was allowed into the scene to view the body. I was informed by staff and Officers that they would be allowed to touch the head and feet of Austin which they did.

At 1337 hours, Nurses from the hospital bagged Austin in a "body bag".

At 1515 hours, the transport service for the Medical examiner arrived and took possession of the body. Tag

#1016978 was placed on the bag and secured.
 I took notes during this time which were scanned to the report and booked as evidence. I turned in the crime scene log to be scanned to the report.
 At the conclusion of the call I took my camera off of covert mode and went to turn it off, At that point I learned the camera had failed to activate. Due to it being on covert mode I did not see the indicator lightson the top of the camera.

On 04/02/2025 I Officer Higgins was working as the desk officer at 7200 Stonebrook Parkway, Frisco, Collin County, Texas. On Tuesday, April 2, 2025, at approximately 1001 hours, I, Reporting Officer T. Craig #3517 (School Resource Officer Liberty High School) was at Heritage High School and heard via radio that a FISD student had been stabbed at the address of 6927 Stadium Lane (Kuykendall Stadium).

I immediately responded to the scene.

Upon arrival, I first made contact with Officer Cortez who was standing next to a marked police vehicle.

Officer Cortez advised he had detained the suspect and he was in the patrol vehicle.

I then responded to the victim's scene that was in the north bleachers. As I walked up, I noticed Frisco Fire Department personnel was attempting to provide life saving measures to a subject later identified as Memorial High School Austin M [REDACTED]

As other officers worked the scene, I was asked respond to the stadiums medical/locker room area and keep the following Memorial High School students / witness separated until Detectives could speak with them

While with them, I was told to take their cellphones from them and later turned them over to Sgt. Bissonnette.
