Attached paper will reference actual grievance complaints that accounts for the actual incident, date, time, staff involved, staff whom saw the plaintiff's body after the assault and refusal of medical attention outside of MSP.

That the courts start holding staff employees accountable for their misconduct actions and violations against policy and procedure towards incarcerated people.
