We doubt that we can describe his "illness" really satisfactorily. Had we seen his handwriting before he assassinated Senator Kennedy, we would have described him as However, under no circumstances would we have predicted that he was "capable" of doing what he did. We do not see him as the kind of person who can . We do see him be and systematically . On the basis of the way we see his as illness, what he did can only be explained by a tragic combination of . The odds against him being successful were tremendous. Obviously, we cannot see him as part of a conspiracy. He could be a tool of a conspiracy in the sense that the attempted assassin of Secretary of State Seward and the assigned assassin of Vice President Andrew Johnson (George Atzerodt) were tools of the Booth conspiracy. It is very unlikely however that he could have effectively acted under precise instructions.

or their girlfriend. Occasionally they will lash out against an employer or colleagues (a case in point is the recent Pennsylvania case of the "quiet" man who killed his car pool and them himself). Sometimes they will pick public figures and make abortive attempts to get at them. Essentially, we see Sirhan as being much more like the impulsive assassins of Garfield and McKinley than the calculating assassins of Lincoln and President Kennedy.
