A BILL

To amend the Federal Funding Accountability and Transparency Act of 2006 to provide Members of Congress with access on a real-time basis to updated information about Federal awards and with access to information on payments made to individual recipients of Federal assistance and Federal employees, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Make DOGE Perma-
3 nent Act”.

4 **SEC. 2. PROVIDING MEMBERS OF CONGRESS WITH EX-**
5 **PANDED ACCESS TO INFORMATION ON FED-**
6 **ERAL AWARDS.**

7 (a) EXPANDED ACCESS TO INFORMATION FOR MEM-
8 BERS OF CONGRESS.—Section 2(b) of the Federal Fund-
9 ing Accountability and Transparency Act of 2006 (31
10 U.S.C. 6101 note) is amended by adding at the end the
11 following:

12 “(5) EXPANDED ACCESS TO INFORMATION FOR
13 MEMBERS OF CONGRESS.—

14 “(A) REAL-TIME ACCESS TO UPDATED IN-
15 FORMATION.—The Director shall establish on
16 the website a separate hyperlink which will be
17 accessible solely to Members of Congress
18 through which Members of Congress may ob-
19 tain real-time access to updated versions of the
20 information contained on the website.

21 “(B) INCLUSION OF INFORMATION ON PAY-
22 MENTS MADE TO INDIVIDUAL RECIPIENTS AND
23 FEDERAL EMPLOYEES.—Notwithstanding sub-
24 section (a)(2)(C), for purposes providing infor-
25 mation to Members of Congress through the
26 separate hyperlink established under subpara-

1 graph (A), the term ‘entity’ shall include an in-
2 dividual recipient of Federal assistance and a
3 Federal employee.

4 “(C) DEFINITION.—In this subsection, the
5 term ‘Member of Congress’ means a Senator or
6 a Representative in, or Delegate or Resident
7 Commissioner to, the Congress.”.

8 (b) CONFORMING AMENDMENT RELATING TO TIM-
9 ING OF UPDATES.—Section 2(c)(4) of such Act is amend-
10 ed by striking the period at the end and inserting the fol-
11 lowing: “, except that the website will be updated in real
12 time for the use by Members of Congress of the hyperlink
13 established under subsection (b)(5).”.

14 (c) EFFECTIVE DATE.—The Director of the Office of
15 Management and Budget shall establish the hyperlink re-
16 quired under section 2(b)(5) of the Federal Funding Ac-
17 countability and Transparency Act of 2006 (31 U.S.C.
18 6101 note), as added by subsection (a), not later than 6
19 months after the date of the enactment of this Act.
