On June 30, 2025, I was requested to respond to the Disney Dream Cruise Ship, which was docked at Terminal 4, Port Everglades, located at 1800 SE 20 St., Fort Lauderdale, Broward County, Florida. The response was in reference to a reported incident involving a child who fell overboard from the vessel on June 29, 2025, at approximately 1130 hours, while the ship was sailing in international waters between the Bahamas and Port Everglades.

Upon arrival, I made contact with the ship's security officer, identified as Howard. He advised that the incident occurred on Deck 4, aft, port side. According to Howard, the child had been walking with her parents when they stopped to take a photograph. During this time, the child climbed onto the railing and sat down, subsequently losing her balance and falling backward into the ocean. The child's parents immediately panicked and began calling for help. Approximately one minute later, the father jumped overboard in an attempt to rescue his daughter.

The ship's crew initiated a "Man Overboard" (MOB) protocol and launched a rescue boat. Multiple staff members deployed life rings from the bridge and surrounding areas to provide flotation for both the father and the child. After approximately 15 minutes, the ship completed a turn, and the rescue boat was able to retrieve both individuals safely from the water. At the time of the incident, the vessel was traveling northwest from Lookout Cay in the Bahamas to Port Everglades at a speed of approximately 10 knots.

Security Officer Howard provided a thumb drive containing video footage of the incident. The video was submitted to BSO Evidence via the secure evidence lockers at the District SOC. I surveyed the scene on Deck 4, aft port side, and took photographs of the area where the child had fallen. The railing at the scene was measured and found to be approximately 47 inches in height. All scene photographs were uploaded to Evidence.com.

Timeline of the Incident (June 29, 2025)

- " 1129 hrs: The family walks to the aft port side of Deck 4. The mother gestures toward the porthole railing.
- " 1129 hrs: The child climbs onto the railing, sits down, loses her balance, and falls backward into the ocean approximately 49 feet below.
- " 1130 hrs: The father jumps overboard from the same deck in an effort to save his daughter. The MOB alarm is activated.
- " 1131 hrs: MOB alert is broadcast over the ship's communication system. The U.S. Coast Guard is notified.

After gathering this information, I requested to speak with the family. I was informed they had been transported to Broward Health Medical Center for follow-up evaluation by the ship's medical staff.

I interviewed the ship's attending physician, Dr. Chante', who reported that the child presented with Medical Records

She was kept under observation in the ship's medical center for nine hours with instructions to follow up with a local hospital upon arrival at port. The father was diagnosed with Medical Records

Medical Records

He remained in the ship's medical center until the vessel docked and was subsequently transported to Broward Health Medical Center by Broward Sheriff's Office Fire Rescue.

I then proceeded to the hospital to continue the investigation. The father was listed as a trauma patient. I interviewed him in his hospital room. He reported that the family had been walking on Deck 4 when his wife stopped to take a photo of their daughter sitting on the railing. He stated that he was approximately 10 feet ahead and did not witness the fall. He heard his wife scream and, upon turning around, observed his daughter in the water. He initially ran to get help but, after approximately 45 seconds, decided to jump into the ocean to attempt a rescue. He noted difficulty locating his daughter in the water and admitted losing visual contact temporarily. He was eventually able to reach her and tread water with her until they were rescued. He expressed surprise and relief at their survival.

Hospital staff confirmed the father was admitted with a Medical Records. The daughter had no noted injuries and was released from the hospital. I also interviewed the child, who appeared healthy and age-appropriate, though shy and reluctant to speak. She was able to state her name, age, and grade level. I observed her eating breakfast and interacting normally for a five-year-old.

I interviewed the mother, who confirmed the details reported by the father. She stated that she initially did not believe her daughter had fallen into the ocean, as she assumed a glass barrier was present. Once she realized her daughter was in the water, she screamed for help and tried to maintain visual contact with both the child and her husband as the ship turned.

I made a mandatory report to the Florida Abuse Hotline (1-866-532-2873). The report was taken by Operator Jan, ID #197, who advised that an investigator would respond to the hospital.

Sergeant V. Perez was advised of the investigation and notified command. I was informed that a detective from the Special Victims Unit (SVU) would respond. I met with Detective C. Favatta (CCN 17020) at the vessel and accompanied him during his follow-up investigation.

My Body-Worn Camera (BWC) was activated during this incident. All video, audio, and related transcripts captured are considered part of this report and will be retained accordingly.

On June 30, 2025, Deputy Argenti responded to the Disney Dream Cruise Ship, which was docked at Terminal 4, Port Everglades, located at 1800 SE 20th Street, Fort Lauderdale, Broward County, Florida, regarding a child who fell overboard from the vessel on June 29, 2025, at approximately 11:30am, while the ship was sailing in international waters between the Bahamas and Port Everglades. As a result of the fall, the child's father, Abuse Victim had jumped into the water to rescue his child. The child was identified as Abuse Victim, a 5 year of age female.

NARRATIVE:

On June 30, 2025, at 2:00pm, I was called out to investigate this case by Broward Sheriff's Office (BSO) Special Victims Unit (SVU) Supervisor Yanessa Ayra. She instructed me to respond to Port Everglades and meet with Deputy Argenti, who was the primary Deputy assigned to the case. She provided me with the aforementioned synopsis of events and directed me to conduct an investigation into an allegation of child neglect.

On the same date, I met with Deputy Argenti at Port Everglades, Terminal 4 dockside. Deputy Argenti again affirmed the aforementioned information and provided me with security camera footage on a flash drive, which was given to him by the ship's security staff. The security camera footage captured the incident in its entirety, excluding the at sea rescue. The flash drive footage was uploaded into evidence.com and the flash drive sealed and placed into evidence. The following timeline of incident events was notated from Deputy Argenti from July 29, 2025:

- 11:29am: Abuse Abuse , and Abuse walk to the aft port side of Deck 4. Abuse gestures toward the porthole railing to take a picture.
- 11:29am: Abuse climbs onto the railing, sits down, loses her balance, and falls backward into the ocean approximately 49 feet below, into the water.
- 11:30am: Abuse jumps overboard from the same deck to rescue Abuse. The man overboard (MOB) alarm is activated.
- 11:31am: MOB alert is broadcast over the ship's communication system. The U.S. Coast Guard is notified.
- 11:32am: Crew members arrive at the scene. Life rings are deployed. The ship begins turning and maneuvering to initiate rescue/ recovery procedures.
- 11:37am: A mayday call is issued by the ships radio.
- 11:40am: The rescue tender is launched from deck 4.

who saw the actual incident take place.

On the same date of my investigation, I responded to "aft deck 4" and viewed the scene where the incident occurred. Present was Deputy Argenti and ship security staff. I observed the incident located to have several large open "porthole" type windows. The portholes were open air, and blatantly not protected by any clear material. There was a railing/banister in front of the porthole, which measures approximately 44 inches tall. The distance from the porthole to the water is approximately 49.3ft, and 4 decks from the bottom of the ship. Ship security staff notated to me that when the incident occurred, the ship was moving at approximately 10 knots, and located within international waters, off the Bahamas. When Abuse fell, her small body figure did not trigger the man overboard (MOB) sensors. The MOB sensors were triggered when Abuse jumped from the ship. One of the ships Captains on the bridge of the vessel was able to keep a visual of Abuse in the water, and ultimately able to guide the rescue tender to his location. The ship had already disembarked all passengers from the cruise, and there were no witnessed notated to me at the time of the investigation,

There was no security camera footage provided from the ship of Abuse and Abuse in the water, and no footage of the rescue. As a result, I compiled videos from the social media platform "Tik Tok", where several passengers had video recorded the rescue. The videos were downloaded from the application and uploaded into evidence.com for retention. The videos were found from user accounts "cmd.91", "lifeofchandler", "selenavip1", and "timarie904".

On the same date, while still on the ship, I spoke with Doctor Chante Charles, who was the lead Doctor during the incident. Doctor Charles was also a crew member onboard the rescue tender and aided in the rescue operation.

According to Doctor Charles, Abuse presented with Medical Records was kept under observation in the ship's medical center for nine hours with instructions to follow up with a local hospital upon arrival at port. Abuse was diagnosed with Medical Records . He remained in the ship's medical center until the vessel docked and was subsequently transported to Broward Health Medical Center by Broward Sheriff's Office Fire Rescue upon docking.

On the same date, at 3:58pm, I responded to Broward Health Medical Center and met with Abuse, who was undergoing treatment for injuries he sustained from the incident. I obtained an audio/ video recorded sworn statement from Abuse regarding the incident. The statement was recoded on my body worn camera (BWC). Abuse provided me with his identifying information. He then raised his right hand and was sworn in, further understanding what purjery is and the penalty for lying under oath. Abuse dentified his wife as Abuse Victim, and his daughter as Abuse Abuse. He described that they boarded the Disney Cruise on June 26, 2025, and the ship was slatted to return on June30, 2025. This was the families first cruise. Abuse described the incident occurred on June 29, 2025, at about 11:00am. The family was exploring new parts of the ship on the running trail of deck 4. The family was walking together, but Abuse walked ahead of Abuse and Abuse Shortly after, Abuse audibly heard a scream from Abuse. Abuse described the scream as desperate and knew by the type of

Present in the room, was a representative from Disney, who stepped into the hallway. Also present was Abuse, who was sleeping in a bed, Abuse Victim, who was being put down for a Abuse provided me with her identifying information. She then raised her right hand and was sworn in, further understanding what purjery is and the penalty for lying under oath. Abuse verified the dates of the cruise starting June 26, 2025, and ending on June 20, 2025. Abuse stated that the incident occurred on June 29, 2025, at about 11:29am, while the family was walking and exploring the ship. Abuse described she was walking with Abuse and Abuse and they were on deck 3 or 4. Abuse stated that while walking, she saw porthole windows, and she had offered for her daughter to take a picture in the porthole. Abuse described that Abuse approached the porthole and stood in front of it, then climbed and positioned herself-siting on the railing. Abuse was facing Abuse when Abuse then lost her balance and fell backwards. Abuse described that she had assumed the porthole had a window or Plexi-glass, and she thought that Abuse would be caught by the glass, but instead, she kept falling, ultimately off the ship and into the water. Abuse then screamed for Abuse to come and help and was panicking. Abuse stated that ultimately, Abuse jumped off the deck and into the water. Abuse described that she went and got help and stated that the incident occurred very quickly.

Abuse elaborated that while on the cruise of previous days, Abuse had taken numerous pictures in several other portholes/ windows on the ship. She provided me with a picture of Abuse laying in a porthole with a window on it. The picture was uploaded into evidence.com. In addition to those pictures, Abuse had taken pictures of Abuse, leading up to the fall, and a picture of the fall. Abuse provided me with her cellphone, where I viewed the pictures. The pictures were also live pictures, and when streamed together, depict a few second video of the child getting up on the railing, and falling backwards into the water. With Abuse Victim permission, the videos were emailed to me and uploaded into evidence.com. After reviewing the live picture on her phone, I observed meta data from the picture providing a GPS location of the moment she fell off the ship. The coordinates are 25.00000 degrees north, 77.4 degrees west. This was uploaded into evidence.com.

Therefore, in light of the facts of this case along with the relevant case law, I am declining one count of Child Neglect Without Great Bodily Harm."
