Brief Synopsis of the Complaint:

I am writing to formally lodge a complaint against the King County Department of Adult and Juvenile Detention (DAJD) for ongoing violations of RCW 43.101.095, particularly subsection (v). This statute clearly mandates that all Washington State peace officers and corrections officers must have their immigration status verified and must be either U.S. citizens, lawful permanent residents, or recipients of Deferred Action for Childhood Arrivals (DACA). However, it has come to my attention that, over the past several years, the King County DAJD has knowingly hired individuals as corrections officers who do not meet these legal requirements. Specifically, individuals have been hired while holding only temporary work visas, and in some cases, with expired work authorization altogether. These hires are in direct violation of the statutory requirements set forth by state law. This practice not only undermines the integrity of Washington's criminal justice system but also presents significant legal and security concerns. I urge the Commission to promptly investigate these violations and take appropriate action to ensure compliance with RCW 43.101.095 by the King County DAJD. Thank you for your attention to this matter.


