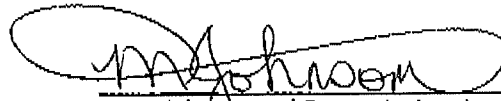

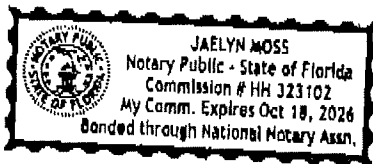

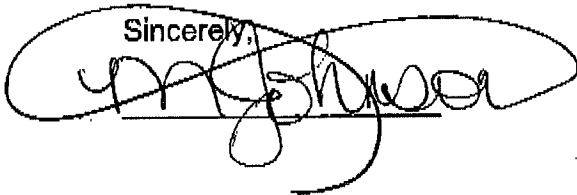
I, Michelle Johnson, demand that you return the aforementioned property immediately.

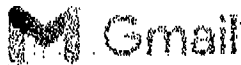
